New statistics on Scottish firms' use of the furlough scheme, also published today, show that of all firms surveyed over two thirds were still furloughing their workforce to some extent. The new data also estimated 15.0% of the workforce were still on furlough.

Economy Secretary Fiona Hyslop has once again called on the Chancellor to implement an extension and provide reassurance.

Ms Hyslop said:

“The UK Government must think again about withdrawing blanket support and they must urgently re-consider the premature ending of this support and to implement some form of extension which would continue to provide support for the sectors that have been most heavily affected.

“Extending the Job Retention Scheme for eight months would save 61,000 jobs in Scotland and help secure a stronger economic recovery from COVID-19. Unlike the Scottish Government, the UK Government has the borrowing powers necessary to fund the extension of Job Retention Scheme and they must act now to protect jobs and livelihoods.

“New furlough statistics for Scotland published today show wide variation between different sectors of the economy. Even though in some sectors a significant number of people have gone back to work, the outlook is much bleaker in other sectors. For example in accommodation and food services an estimated 34.4% of staff were still on furlough, and in the arts, entertainment and recreation sector, 57.5% of staff were still on furlough.

“Of course, the furlough scheme cannot continue indefinitely, but an extension would help keep people in jobs while sectors of the economy currently unable to fully open recover and will lead to sustained economic benefits at a relatively small cost.”
