Hi All

Please find attached a copy of **NDC Customer Alert Notice CAN 395** which is being issued by National Procurement following reports of quality issues with **TYPE 11R DFJB VER2 EARLOOP** Face Masks.

Please distribute to all NHS Scotland Boards to ensure they receive this information.

Description of the issue:

The National Distribution Centre (NDC) has received reports where some Masks were found to have a small metal shard near the nose band. Initial examination has found that the metal nose strip had not been encased in the binding at the top of the mask correctly and the whole metal strip could be easily slid out of the mask.

This has been reported to the supplier and a full investigation is underway. Pending a response, National Procurement has decided that the following lot numbers should be held in quarantine as a precautionary measure until further notice.
