LETTER TO MATT WARMAN MP OF 3 DECEMBER 2020

Thank you for your letter of 13 August and the subsequent joint announcement on 23 October allowing voucher beneficiaries to benefit from both our Scottish Broadband Voucher Scheme and your Gigabit Broadband Voucher Scheme simultaneously.

In that letter you said you would further consider some other matters I raised in my correspondence of 14 July and I now seek a meeting to discuss those points, in light of the recent Spending Review and the publication of the National Infrastructure Strategy.

Now that annual spend for each of the next four years has been secured for the UK Gigabit programme, I see it as mutually beneficial to agree a way forward for how, when, and how much of that funding is deployed in Scotland.

I strongly believe that a significant proportion of this funding should be focused on delivering gigabit connections to the hardest to reach areas in Scotland – those outside the scope of the R100 contracts and commercial investment or in enabling the cost of upgrading the minority that will receive FTTC to get FTTP instead. I am also keen to see that funding delivered as early as possible to assist and underpin economic recovery once the immediate emergency created by COVID-19 has subsided.

We have seen excellent collaboration between our teams in recent times – notably to join up, and maximise the impact of, respective broadband voucher schemes. I want to build on this and jointly develop our approach to procurement for Scotland, that determines the most effective use of these resources and delivers maximum impact in our hardest to reach communities.

This would utilise the expertise that has been built up in recent years through the successful roll-out of the DSSB superfast programme and the development of our Reaching 100% (R100), which is now rolling out across Scotland. Whilst the majority of the planned R100 build is in fact full fibre, I now ask that you confirm the UK Government's in principle commitment to providing the necessary funding which would see much of the planned fibre to the cabinet build in the Central area 'flip' to fibre to the premises.

As you will no doubt be aware, we hope to sign the contract covering the North of Scotland (and Islands) in the coming weeks. Work has already begun to pin down the precise footprint of that build, based on the latest commercial data, and I would now like to use the headroom available to us under that contract to secure a portion of the funds now committed to the Gigabit roll-out. Such a commitment would enable you to secure accelerated roll-out in some of the hardest to reach areas of the UK.

I welcome restatement of your commitment to the Shared Rural Network in both the Spending Review and the National Infrastructure Strategy and am pleased that regular engagement is taking place between our respective officials and the delivery team at DMSL. I understand from my officials that although the initial radio plan is now complete, further work on the Scottish rollout plans is still being undertaken and that pending completion, no data can be shared. I ask that you commit to sharing maps and data pertaining to expected Scottish coverage with the Scottish Government as soon as this

is finalised. This is crucial for our early understanding of the scale and location of the coverage gap likely to remain on completion of SRN and our consideration of what further activity in the future may be required.

I also welcome confirmation that a further £50 million will be made available through 5G Testbeds and Trials programme. I understand that your officials are already having dialogue with the CEO of the Scotland 5G Centre and urge that you continue work with us to ensure that an appropriate Scottish share of this funding can be targeted effectively in Scotland to align with delivery of our own national 5G strategy.

Earlier this year, the Scottish Government established the Advisory Group on Economic Recovery (AGER) to provide expert advice on what actions should be taken to aid economic recovery. Their report recognised the key role that digital connectivity has played throughout the pandemic and called upon the UK and Scottish Governments to mobilise investment in Scotland's digital infrastructure.

The funding confirmed by the Chancellor to extend broadband and mobile networks offers a timely opportunity to drive that economic recovery, while ensuring alignment with existing initiatives in Scotland. A joint procurement strategy, that will determine how we best deploy Scotland's share of the Gigabit programme funding in the most effective and efficient way possible, to complement the resources we have committed to R100, is the logical next step in this process and will underpin our shared economic recovery efforts.
