Thanks for this. Mr Russell agrees that we should do this. He thinks we should aim to get a decision this coming week and announce it. He has asked for a draft note from him to the FM explaining that the CA asked to continue with a slight change of remit, and to do so on line and that he has agreed subject to the cost being no more than the budget originally allocated. The note should outline that this route will save money. It should also make clear that the CA would like to get on with the arrangements for this now and that we anticipate the first on line meeting in early September with a report by the end of the year.

Can I leave this with the team to prepare a draft note to send to FM this week please?

REASONS FOR NOT PROVIDING INFORMATION

An exemption under section 38(1)(b) of FOISA (personal information) applies to some of the information requested because it is personal data of a third party (i.e. names/contact details of individuals), and disclosing it would contravene the data protection principles in Schedule 1 to the Data Protection Act 1998. This exemption is not subject to the 'public interest test', so we are not required to consider if the public interest in disclosing the information outweighs the public interest in applying the exemption.
