The length of the village from the eastern loops exiting invites too much acceleration as there is no calming measure sufficient to slow vehicles just before Barcaizlie road junction which is a very narrow opening and used by residents who choose to walk or cycle there. I have found myself completely stopped on the A75 waiting to turn in as there can be farm vehicles or even sometime a car sitting to exit which can prevent you accessing the lane. This is a frightening experience when accelerating vehicles are coming from behind (especially scores of HGVs) at high speed. The whole idea of calming here is akin to putting your finger in the dyke when a tsunami is approaching. If the authorities believe in Reverse Discrimination then please prove it and do more to eradicate this roguish behaviour which happens around the clock. Yes, the measures have not been nearly ambitious enough. Too much illegal speed is conceded before the system triggers. Professional drivers exploit this to drive over 30 but under the trigger speed. The exiting channels are very susceptible to compensating speeding which begins well before the lights as soon as the sensors are crossed and such drivers can often be doing 40-50mph at the exits. Very common; every few minutes in fact. Very disappointing as is the fact some incoming drivers have ignored the countdown markers and enter the village at 50mph plus. 60mph has been seen. There has to be hard engineered gateway features as in Crocketford and more SIDs near the exits coming in and going out to show just how fast these rouge drivers are going at those points. These will be flashing red all day long. The whole impatient driver mentality toward the Springholm village limit is poor and resentful that's why the place must be finally bypassed Drivers simply cannot be slowed to safe speeds.
