Thanks for this resource and your time earlier. I have discussed this with my manager and we are pleased to make a preliminary offer to Affa Sair to join the NACCP.

Please note that the offer is preliminary as that there is Ministerial oversight of all chronic pain policy decisions, and I will update you as soon as I can once we have had the Minister's response (likely next week).

Until then, we would ask for your discretion in discussing this with other members of the Patient Reference Group or more widely at this stage. We will provide an update to the wider Committee and Reference Group in due course.
