One further thought. You'll know that the Care Inspectorate were also asked to provide info on their notifications. They cited a number of exemptions. The 2nd is perhaps more relevant to the CI and their relationship with the provider but the first is relevant

Section 33(1)(b) – Commercial interests and the economy

Release of this information at care provider level outlining infections and deaths may substantially prejudice services commercially in that it would be perceived as a negative reflection of their care service provision and care standards. The rate of Covid-19 infections and number of deaths may not necessarily be related to a service's quality of care, hygiene standards, use of PPE etc. so to release information, even at provider level, could have significant impact on the ability of the provider and consequently their services to function commercially in already challenging economic circumstances caused by the

pandemic. Releasing information at this level would also likely impact on their ability to engage new staff and/or attract new residents which would have a direct impact on their being able to operate commercially and maintain sufficient standards of care for their existing residents ultimately undermining the Care Service Sector.

Section 36(2) Confidentiality

The role of the Care Inspectorate as the regulator for care in Scotland requires it to assist and support all Scottish care services in upholding the Scottish Health and Social Care Standards. It is vital that care services feel free in terms of their relationship with the Care Inspectorate to turn to us when they need our support and guidance, and also in the instances where they themselves have any concerns. This section incorporates the Scots law of confidence into FOISA. Therefore, information collected or provided to the Care Inspectorate by a care service can be considered as confidential in that the care service is providing that information in the understanding that it is provided in the context of our role as regulator, and within the confines of our professional relationship with the care service.

Following my previous emails on the topic, I wanted to let you know that, following advice, we've decided that we have to release data on COVID deaths in individual care homes.

On Wednesday when we release the latest COVID stats, we will publish an ad-hoc table showing all deaths which mention COVID by individual care home. A single figure will be given for each home covering deaths registered between 16th March 2020 and 31st January 2021.

We have no plans to update this table on a regular basis, but may have to revisit this if there is significant demand.

We can't provide this information grouped by care home provider but there may be requests for this, which we would refer on to the SG or Care Inspectorate.

Can you ensure that the relevant people within SG and Care Inspectorate are aware of this in case it results in queries towards you?

Here's the table we will be publishing.

Can everyone please note that this table contains pre-release statistics which will not be released until 12 noon tomorrow, so they should not be shared outwith the copy list without prior agreement.

The table contains a record for every care home which had a COVID death between March 2020 and January 2021.

Care homes without any COVID deaths are not included. It is important to note that we only know about care homes which had deaths so can't provide an accurate figure for the number or proportion of care homes with no COVID deaths.

From our records, there were around 880 care homes which had a death (of any cause) from 2020 to date. But this may not be an accurate number of all care homes. It's possible that some care homes have had no deaths at all during this period.

You should also take note of the 'info' tab in the spreadsheet which explains how we allocate institutions to the care home category as this may explain why there may be differences with other data sources.

Thank you for your time earlier. The release of these data has been discussed today at our regular meetings with HSCP Chief Officers and at the Care Homes GOLD group; we thought it necessary to inform them these data would be published given the obvious handling implications for partners. There's clearly considerable anxiety in ensuring the data is released in a sensitive manner given the likely distress it will cause care home staff, residents and their families. Is it possible to set up a meeting for Thursday and Friday this week with a number of key sector partners to discuss options to ensure awareness this information is being released and how we might minimise any distress through its publication?

Thanks [redacted]. Yes agree that it's not appropriate to have ICO involved tomorrow; if stakeholders have wider concerns then they should raise with ICO.

Useful explanation on single / small number of deaths. I don't think it's so much that the home may not believe that the death is Covid-related (the NRS and Care Inspectorate death figures are pretty close and the latter are reported by the home), more the concern is that the families will know it's their relative. I appreciate that the ICO has ruled this concern is insufficient to prevent release.

We are clear about the ICO advice and it is for NRS to act on this – so I would rather not have a discussion with ICO in the room [Redacted] as this seems to imply that COs think this will change the ICO advice and stop the release of the data. We are clear about the advice we have been given. If however COs want to explore the broader context for their own awareness, then ok.

Regarding single deaths, there is no specific exemption under FOISA for information about deceased people. There are some areas such as medical records or information about other living people which would be considered, but essentially reporting that an individual died of COVID wouldn't be covered.

The broader protections to living people through GDPR don't apply to deceased individuals as their data doesn't constitute personal data.

NRS currently produces tables of mortality data with single counts – so there is a precedence for releasing data at this level.

Of course for these single and small counts it is quite likely that individual care homes may believe that the death wasn't COVID – ie lack of a positive test or lack of a test. However, NRS methodology is clear that we report on registered deaths where COVID is mentioned. This is the basis of our stats throughout the pandemic.

As noted above there isn't an issue of disclosure (about the individual), and implications for families, staff, organisations have been considered by ICO to not be sufficient to stop the release of data. Therefore small counts aren't a consideration from this perspective.

I would assume that the interest will be at the other end of the spectrum !

NRS have informed me that the decision to publish this information was made following a Freedom of Information Request from a journalist. NRS initially refused this request but following an appeal to the Scottish Information Commissioner's Office (ICO), NRS obtained advice from both the ICO [Redacted] Rather than release this data on an individual basis to a journalist, it was deemed appropriate to pro-actively publish this data on the NRS website.

NRS appreciate the public impact of making this data available. As such, they will not publish the data this week but will do so on 10th February to allow SG Officials the opportunity to engage with relevant stakeholders such as Chief Officers of the Health and Social Care Partnership and the Care Commission to minimise the distress caused to families and care home staff by this information as best as possible.
