Hi <redacted>,

Ahead of the meeting this morning, Ms Gougeon wanted to give initial feedback.

She is happy to take advice from <redacted>, but she doesn't think we need the annexes and thinks the note should be succinct and to the point.

The note should also outline the general opposition to the policy from pretty much all political parties, including SNP MSP's representing islands. Cab Sec asks if we can give the percentages of who was for/against in the consultation, but outline that those in favour tended not to live here.

Ms Gougeon would also emphasise that it wasn't just the feedback from MSP's that was strong - officials faced strong opposition in their engagement events.

Cab Sec has commented that the politics of this also needs to be outlined. We will be criticised because this will be seen as a U-turn on a manifesto commitment. However, the steps we're taking next will mitigate this because we are actually listening and taking action on the feedback we have received.

**Top Lines**

**Withdrawing a policy is not a decision that any Government takes lightly, nor without good reason.**

- Over the past 10 months, we have been engaging very closely with communities and stakeholders to investigate what sort of impact the Bond policy may have - both positive and negative.
- This has allowed us to gather input on how we can best help to address depopulation at an island level.

**We have listened carefully to islanders, and are changing our approach to the issues of depopulation in response to what they have told us.**

- The feedback we have received has been very clear. Whilst a renewed focus from the Scottish Government on the population challenges being faced across our islands is to be welcomed, a more strategic focus on the drivers of depopulation would be far more beneficial.
- Furthermore, resources that would have supported the Islands Bond this year will better deliver change through supporting this more strategic approach.

**We have been in listening mode, and on the basis of what we've heard from partners and communities, we are withdrawing the Islands Bond so that we can focus on the delivery of more localised solutions.**

- We remain fully committed to addressing our population challenges, and will deliver this through a collaborative plan aimed at responding to the key drivers of depopulation.
- This cross-sectoral approach responds directly to feedback received from islanders through our engagement on the Bond.

**The challenging fiscal environment means we need a realistic public spending framework for the years ahead.**

- These are very challenging times, with the cost of living crises, the impact of the pandemic and the fallout from Brexit being felt acutely across all of Scotland. This means we have had to make some difficult funding decisions.
- The Capital Spending Review sets the broad parameters for Scottish Budgets to 2025-26 as best can be done at this time.
- Whilst the CSR sets out high-level multi-year spending parameters, it does not provide the Scottish Government with the authority to spend public funds. Annual

budgets will continue to be set through the annual parliamentary budget Bill process and the annual budget will be based on the latest fiscal information.

- The investment that was planned for the Islands Bond for this financial year will now support our Practical Policy Tests, which in turn will inform our future funding requirements so that we can tackle the depopulation challenges across our islands.

#### **Background**

In our [A Fairer, Greener Scotland Programme for Government 2021/22](#), we announced a commitment to develop an Islands Bond fund, providing up to £50,000 each for up to 100 households by 2026, by providing financial support for island residents to remain in their community, or to encourage people to move there.

[Islands bond: consultation](#) 19 stakeholder engagement sessions and 12 on-island in-person events took place last year.

The learnings and suggestions gathered through the Islands Bond consultation will be utilised in shaping a range of Practical Policy Tests to inform the 'Addressing Depopulation Action Plan'. This work will be driven forward over the next 12 months, in close collaboration with island communities, by delivering interventions that respond to unique island needs.

Scottish Government support for islands, and progress made towards delivery of the National Islands Plan, is recorded in our annual report, presented to parliament each year. The first of these was the [National Islands Plan: annual report 2020](#), published 23 March 2021. The most recent report was the [National Islands Plan: annual report 2021](#), published 23 March 2022.
