6. Note of meeting with Mermaids & SG Officials – Tuesday 8 June 2021

1. Welcome and Introductions

2. [redacted] gave an overview of Mermaids and ongoing work to support trans, non-binary and gender diverse young people up until their 20th birthday as well as wider family members where necessary. Discussed helpline service, a core part of Mermaids' work which acts as an info point for anyone wanting to discuss gender identity (e.g. parents, young people, teachers). [redacted] discussed policy work with parliamentary focus and in house campaign department. Mermaids operates a UK wide training programme and has recruited both a Sports Inclusion Officer and Trans PoC Policy Officer.

3. [redacted] noted Mermaids are currently developing a network of trans inclusive lawyers across the UK. [redacted] raised SG engagement with the Scottish law centres and it was agreed that officials would share relevant contacts details with [redacted]. **[Action: LGBTI Policy to share contact details for Child Clan Law and Scottish Child Law Centre.]**

4. [redacted] briefly outlined main issues impacting service users and wider trans community such as sports inclusion and healthcare. Many trans young people are waiting between 2-3 years for appointments at gender identity clinics and misinformation regarding gender identity services/ prescription of puberty blockers was noted as a significant challenge. [redacted] noted perceived differences between Scotland and England and legal landscape post *Bell v. Tavistock* and asked officials if they see potential for similar litigation in Scotland. Officials were not aware of any specific cases in Scotland.. [redacted] noted stakeholders consistently raise these healthcare concerns and highlighted the work of the Working Group for Non-Binary Equality (WGNBE) which will focus on healthcare inequalities (including primary care, fertility preservation, mental health, gender identity services) amongst other topics. **[Action: LGBTI Policy to share link to WGNBE web page]**.

5. On Mermaids' engagement with service users in Scotland via their helpline, [redacted] noted that users more often tend to live in rural locations and have had little to no education around gender identity and trans issues. On education in schools in Scotland, [redacted] highlighted that TIE are key stakeholders and front runners on Scottish policy. **[Action: LGBTI Policy to gather updates from education on trans school guidance publication date and implementation group]**.

6. [redacted] noted Mermaids are keen to input on policy if and where possible and asked officials about key stakeholders in Scotland. **[Action: LGBTI Policy to share contact details for key stakeholders including LGBT Youth and TIE].**

7. On GRA reform, [redacted] asked Family Law colleagues for an update on next steps. Noting SNP manifesto commitment to reforming the GRA, [redacted] outlined that next steps would be to first ask ministers how they would like to proceed and second, internally recruit staff. [redacted] noted that we can expect a wide range of issues to be raised such as the census, data, sport and single sex spaces for women . On the possibility of stakeholder roundtables with stakeholders representing a range of views, [redacted] was open to the idea dependent on the views of invited groups (i.e. Would not be open to roundtable with group holding openly transphobic views)..

8. [redacted] asked for thoughts on efficacy of trans healthcare pilots in England. [redacted] noted that while they are welcome, ultimately they will not solve long term issue with primary care system.
