Dear [Redacted],

It's been some time since we were last in touch and I was grateful that you and your colleagues were able to give me some information in relation to Professor Sam El-jamel, and confirm that he held temporary registration with IMC between 1991-1995. However we have again been contacted by Mr Kelly, who was a patient of El-jamel and has since suffered from the results of surgery performed on him. I gather that Mr Kelly has been in touch with IMC in relation to the fact that El-jamel also worked as a House Officer at Richmond Hospital, Dublin, from 1985-1986, and during that time did not hold registration with IMC.

Would you be able to confirm that El-jamel was not registered with IMC between 1985-86, and that in fact he should have been required to do so? Or were there any alternative arrangements in place by employers that would have negated the requirement to do so? If he was in fact not registered, what would be the effect of that on the time he spent as a house officer? Appreciate these are all questions set against the backdrop of some years ago but it may be of crucial importance.

Further to your email below with your queries regarding Dr Eljamel and the granting of CCST's, I've spoken with my colleagues in our Registration Department and they have advised the following -

In June 2019 we were made aware that Dr Eljamel was being investigated by Police Scotland, who were seeking assurance that his primary medical qualification (PMQ) was genuine. In July 2019, we were able to confirm to them that Dr Eljamel's PMQ from Libya was genuine. We were not asked to look into his specialist credentials at that stage.

Dr Eljamel obtained full registration on 20 February 1990 and specialist registration in neurosurgery on 12 January 1996. At that time, doctors could apply to have their specialist training recognised on the medical register by submitting a Certificate of Accreditation to the GMC. Certificates of Accreditation were issued by the Royal Colleges to confirm completion of specialist training. We have access to Dr Eljamel's archive file, which shows that the Joint Committee on Higher Surgical Training confirmed on 1 November 1993 that Dr Eljamel had satisfactorily completed his higher surgical training. This wasn't sufficient on its own to award him specialist registration but on 20 October 1994 we received a letter from the Irish Surgical Postgraduate Training Committee which confirmed that he had completed his training in neurosurgery. It appears to have been this letter that led to him being entered onto the specialist register.

In terms of whether Dr Eljamel's specialist qualification was obtained fraudulently, we can contact the organisation which is currently responsible for surgical training in the UK, the Joint Committee on Surgical Training (JCST), to see if they can assist in confirming that he completed training in neurosurgery in 1993. However, given that you have advised that you will follow up with colleagues at the Irish Medical Council in relation to Dr Eljamel's registration/training - it would be helpful to know if you have had a response from them before we start those enquiries at our end – this is just in case the IMC have already been able to confirm with the Irish Surgical Postgraduate Training Committee that Dr Eljamel's training is all genuine.

I hope that this is helpful in the first instance but please let me know if you have any questions.

[Redacted] – just some further detail which might be helpful in illuminating where this might involve the GMC.

The patient says he has received information from organisations in Ireland that suggest that Prof Eljamel has never been registered with the Medical Council of Ireland and that he has concerns that Prof Eljamel may have relied upon submission of information relating to the completion of FRCS in Ireland as the basis for his CCST being awarded in 1993.

Would you be able to provide any background documents or briefing that outline the ways in which historically (I think through PMETB) that Fellowship qualifications informed granting of relevant CCSTs – including any processes that would be in place to ascertain the validity of any Fellowship).

Hopefully this makes sense but please do call me if you'd like to discuss? In the meantime I'll follow up with colleagues in Ireland.
