I write with reference to the Auditor General's comments at a parliamentary audit committee meeting on 12th May, as reported in the Herald (13th May 2022), under the terms of the Freedom of Information (Scotland) Act 2002, and request the following information:

- Given the increasing scrutiny of the governance failings at South Lanarkshire College under its Chair, Andy Kerr, what action is the Scottish Government taking to restore effective operation at this public body? Please provide documentation to evidence this.

- Given the suggestion at the committee hearing that Police Scotland should be involved, what action has the Scottish Government taken to ensure that appropriate action is being taken by the College Board in relation to the significant governance failings at this college? Please provide documentation to evidence any action taken. The College has not yet contacted Police Scotland (Herald 13th May), which feels like an inappropriate response for a public body.

- Given the Vote of No Confidence in the SLC Chair and SLC Board by EIS/FELA and Unison members in Dec 2021, what actions has the Scottish Government to address the concerns of both unions and staff at the College?

- Given the synergies between this situation and that of Clyde College, why has the Scottish Government not yet intervened in the manner which it did with that institution? What are the differences in the two situations? Please provide documentation to evidence this.

I am writing to request an internal review of Scottish Government's handling of my FOI request 'Governance Issues in Lanarkshire Region - Directorate of Advanced Learning and Science'.

Thank you for your response of 10 June to my FOI request of 11 May about the actions being taken by the Scottish Government in relation to the governance failings at South Lanarkshire College.

In your response you state:

Question 1 - It is not the role of the Scottish Government to consider additional intervention as it the responsibility of the Scottish Funding Council (SFC) to investigate any potential issues around governance in Scotland's colleges.

You also asked for "copies of all documentation which has supported the decision-making". The Scottish Government does not have the information you have asked for as it is the responsibility of the SFC to investigate potential governance issues. Therefore SG does not hold copies of any documentation that has supported a decision making process.

You state the above despite providing a link to the parliamentary statement made by a previous minister for further education, Angela Constance, as she removed the board of Clyde College in 2015, and described in detail the significant actions taken by Scottish Government ministers and officials to rectify the situation at Clyde College – which was less public, less costly to the public purse, less impactful on the staff, students and college community at SLC.

This makes no sense therefore I would welcome a review of your response to this query and a more coherent response to a matter of significant public interest.

I have been following events in the press concerning the situation at South Lanarkshire College for some time now and enclose the latest article in today's Herald. This latest article states that appeals had been sent to both the First Minister and the Education Secretary asking them to intervene in the hope that a meaningful update on the investigation by the Scottish Funding Council can be obtained as a matter of urgency. Frankly, the circumstances surrounding the SLC are very worrying and we are entitled to answers. In my opinion the Scottish Funding Council should be under investigation itself for the way this has all been handled. An interim review by the SFC was completed mid 2021 and little progress has been seen since.

This is really not acceptable. Ms Somerville was contacted by what's called the "college leadership" in November of last year just before the college principal was suspended. Nothing appears to have happened since. SLC attracts a significant amount of funding and it is very disturbing that all these allegations remain unaddressed. We need action to be taken by Ms Somerville, now. I would be obliged if you would raise this matter with her at the earliest opportunity. These allegations are serious and it is deeply worrying that no one at Scottish Government level appears to be concerned either by the complaints raised or the failure of the Scottish Funding Council to deal with them in a transparent manner. Two people remain suspended and that really isn't acceptable either.

South Lanarkshire College began life in the humble surroundings of Cambuslang School of Building, behind the old library. It then moved to premises previously occupied by Trinity High in Hamilton Road. Another campus was opened in East Kilbride. Then, the whole thing was decamped to East Kilbride and Cambuslang lost the college for good. Millions have been spent on the college. It is sad indeed to now hear so many rumours about fraudulent practices which, frankly, damage the reputation of the college. It doesn't help if we see no progress in th investigation after such a long time.
