Good Afternoon [redacted] and Jenny

I have been contacted by a constituent in connection with the proposed NMU- non motorised user route from Aviemore to Carrbridge (hereafter "NMU"), and following the report recently published by Atkins Mouchel recording the outcome of the public consultation.

I am pleased to note that the majority of the responses to the proposed route were favourable.

However there is one issue which I raise on behalf of my constituent, but which was also raised by consultees as is evidence from the helpful analysis by Atkins Mouchel. That is that to "tie" the delivery of the route to the A9 procurement process for the Dalraddy to Slochd route means that the timing of delivery of the pathway is entirely uncertain, because, at present at least, there is no indication of when this section of the dualling of the A9 will be completed.

I would respectfully request if you can advise me and my constituents of when you expect that this section of the A9 shall be dualled, and that work completed?

If you are not at present able to offer any response to that question I am asking if consideration can be given of separating this work from the dualling contract, and the NMU be constructed as soon as is possible.

This indeed is a suggestion which many have supported as far as I can see, from the said report.

If that cannot be done, then there seems no immediate prospect of walkers, cyclists, horse riders and others having an access way from Carr-bridge to Aviemore. Should that prove to be the case, there is another issue which I wish to record, which again has been raised with me by this constituent but also by others too.

That is that when the A9 is closed, as sadly it frequently it has been of late as you will be well aware, following various fatalities, then the whole traffic is re-routed through Carrbridge. This does create a hazard for people in Carr-bridge and is the cause of concern in itself. This factor is another reason why to de-couple or delink the NMU from the Dualling would I think have substantial support, and would presumably be in line with the avowed Scottish Government policy to promote and encourage active travel.

If this cannot be done, then it seems to me that there will be considerable disappointment locally by those who very much wish to pursue active travel options in safer circumstances. My constituent believes that Transport Scotland are committed to delivery of this, and so it would surely be absurd if the implementation of it were delayed by several years or more, as the Scottish Government have not yet given any clear indication as to when the dualling will take place.
