This is similar to SQA marking, where we do not capture why a particular grade was awarded.

## Draft Response:

Thank you for your enquiry of 10 September to Shirley-Anne Somerville MSP, Cabinet Secretary for Education and Skills, about the National Qualifications in 2021-22. As an official with policy responsibility for the National Qualifications I have been asked to respond.

You may be assured that the Cabinet Secretary understands that studying toward qualifications can be stressful at the best of times and appreciates the disappointment that learners face when they do not get the grades that they had expected.

While there was a return to exams this year, Ministers recognise it was not a return to normal. In recognition of the disruption that learners have faced over the last two years, and the different approaches to assessment, SQA took a more generous approach to grading than in a normal exam year. SQA experts – experienced teachers and lecturers – took an expert judgement based on a wide range of evidence as they do every year.

In addition, acknowledging the disruption this year, the appeals approach goes further than in recent pre-pandemic years. Where a learner received a lower grade than the estimate submitted by their school, they could request an appeal.

The collective view of the National Qualifications Strategic Group, including representatives from parents and learners, was that this approach to reviewing centre evidence was fairer to learners than the post results service of marking reviews. The service was provided in the context of disruption as a result of the global pandemic. Also, it was the first examination diet for three years, meaning learners may not perform as well as expected, given it would be their first experience of sitting national examinations.

You have noted that you are unable to appeal your grade for Higher Mathematics. It is important to note that the operational delivery of the appeals process is a matter for SQA, and Scottish Ministers are unable to intervene in individual cases. However, I have checked the general position with the SQA and I have set this out below.

SQA provided centres with guidance for determining estimates for 2022, and this can be accessed at: National Courses: guidance on gathering evidence and producing estimates (sqa.org.uk). You should have been informed of your estimates when they were submitted in June, with the opportunity to discuss and resolve any concerns at that point.

In relation to Prelim exams, it is important to note that although they are commonly used, they are not a formal part of the process for awarding SQA qualifications. SQA does not set, mark, grade or quality assure Prelims and, accordingly, they vary in standard and in breadth of course coverage between different centres. As such, while they may have been used by your teachers to determine your estimate alongside other assessment evidence gathered during the year, the marks and grades awarded for Prelims by centres have no formal standing in the SQA awarding process.

Staff in schools and colleges are best placed to provide individualised advice and information. I would encourage you to discuss any questions regarding appeals or any other concerns about any aspect of your learning, support, or assessment with teaching or support staff at your school, or with the head teacher.

I hope you find this reply helpful and wish you every success in the future.

After receiving my SQA results I was happy with them apart from Higher Maths as it had displayed that I achieved a C grade when I was hoping for a B grade despite calculating the marks. Both question papers of the Higher Maths for Paper 1 and Paper 2 was posted online after the exam and I had checked like everyone else the marks needed to achieve the grade I want and it came to a grade R

I am very sure that I should have achieved a grade B I have calculated all the marks and remember every answer and working I had put. I believe it could be the marker's error of harsh marking or a fault within the system as I am certain it is. This is demonstrated attainment from the SQA papers which is higher than my appeal grade resulting myself unable to appeal.

Could there be anyway if you can ensure that due to the disruption to education we can appeal like in a normal year not based off evidence as we have already demonstrated attainment in the exam papers, it used to be that we can appeal not based on evidence. I am only 11 marks away from a B I think it is worth the SQA checking as despite the grade boundaries being lowered I am very certain I have hit that 70/120. I know markers are checked throughout and quality assurance is there but it is still hard to believe and it seems suspicious despite calculating and checking that I have achieve a grade B. We should not be disadvantages due to harsh marking as each marker is different with their generosity.

During our Prelim examination time, I had an event which was unavoidable and I told my department head of mathematics but she was unable to change the prelim date and that represents unfairness and unequality as I wasn't given the same opportunity as everyone else to revise and I could of gained a higher mark and also other people got to delay their prelim exam to revise more whilst I was not allowed.

Thank you for your email of 20 September 2022 to the First Minister, regarding your experience with the National Qualifications this year. As an official with policy responsibility for the National Qualifications, I have been asked to respond and I apologise for the delay in coming back to you.

Firstly, I am sorry to hear about your ongoing health issues throughout the course of your fifth year at school and the disruption that you experienced during your [Redacted s38(1)(b)] exam. I understand that you will be very disappointed that you did not receive the result that you had hoped for in your [Redacted s38(1)(b)] exam.

Acknowledging the disruption this year, the appeals approach went further than in recent pre-pandemic years. Where a learner received a lower grade than the estimate submitted by their school, they could request an appeal.

The collective view of the National Qualifications Strategic Group, including representatives from parents and learners, was that this approach to reviewing centre evidence was fairer to learners than the post results service of marking reviews. The service was provided in the context of disruption as a result of the global pandemic. Also, it was the first examination diet for three years, meaning learners may not perform as well as expected, given it would be their first experience of sitting national examinations.

It is important to note that the operational delivery of the appeals process is a matter for SQA, and Scottish Ministers are unable to intervene in individual cases. However, I have checked the general position with the SQA and I have set this out below.

Learners should have been made aware of their estimates prior to them being submitted in June, with the opportunity to resolve any concerns at that time. As you have noted, you achieved a greater result than estimated by your school therefore, you would be unable to appeal. While incredibly sensitive to individual situations, SQA processes do not consider context and personal circumstances as part of the awarding process. Did you raise your concerns regarding the invigilators with SQA directly an advise about the problem with regarding this in your exam?

SQA provided centres with guidance for determining <u>estimates</u> for 2022. SQA also published <u>roles and responsibilities</u> for Appeals 2022 on their website. These documents outline the evidence gathering approach with regards to estimates as well as what is expected of SQA, centres and learners during the Appeals 2022 process.

In relation to Prelim exams, it is important to note that although they are commonly used, they are not a formal part of the process for awarding SQA qualifications. SQA does not set, mark, grade or quality assure Prelims. As such, while they may have been used by your teachers to determine your estimate alongside other assessment evidence gathered during the year, the marks and grades awarded for Prelims by centres have no formal standing in the SQA awarding process.

You mention that as well as facing physical health issues, your mental health has been impacted which has also affected your responsibilities as a young carer. If you feel you require any additional support for your mental health, I would recommend contacting your local GP to discuss your concerns in the first instance. I have had a very bad experience with the SQA following the return to externally assessed exams this year -[Redacted s.30(b)(ii)]

The SQA claims that their policy this year is comprehensive, but it is in fact highly illogical with multiple flaws. [Redacted s.30(b)(ii)] This year the physics papers have been weighted so that paper 1 contributes more to your overall grade than normal, this was in an attempt to make it fairer due to teaching disruptions caused by Covid-19, in my case it has not been fair at all. [Redacted s.30(b)(ii)](i cannot find any statistics on sqa appeal results, but in England a candidate tends to gain around 5/6 marks on a paper after a remark). The SQA has acknowledged and apologised for the issues caused by the invigilator and how these have impacted my academic attainment, however, this does nothing to help my progression to further education.

As a young person who was working hard and looking forward to moving onto further education, this has had a detrimental impact on both my physical and mental health, and in turn, [Redacted s.30(b)(ii)].

Thank you for your email of 7 October 2022 to Nicola Sturgeon MSP, First Minister, regarding the SQA assessment process and appeal service. As an official with policy responsibility for the National Qualifications, I have been asked to respond.

# [Redacted s38(1)(b)]

I understand that [Redacted s38(1)(b)]will be very disappointed that her [Redacted s38(1)(b)]result did not reflect the grade that she had hoped for or had been estimated. Additionally, I appreciate the stress and uncertainty that can occur while awaiting any appeals outcomes - particularly when this has potential implications for onward progression.

When [Redacted s38(1)(b)] portfolios are assessed during the examination diet, quality assurance measures are put in place to ensure all work is assessed fairly and to the national standards. For [Redacted s38(1)(b)], this includes a 'double-blind' marking process. This means that all portfolios are independently assessed by two different examiners. If there is any discrepancy between the two examiners final judgements, a senior examiner will assess the work for a third time to ensure the candidate receives the correct mark. SQA examiners are experienced [Redacted s38(1)(b)] teachers who receive full training before assessing any candidate work, and they are monitored and supported by the senior examining team throughout the marking process. I have provided a link to the SQA Estimates Guidance

Fairness was at the centre of decisions around the National Qualifications this year. Acknowledging the ongoing disruption, the 2022 appeals approach went further than in recent pre-pandemic years. Where a learner received a lower grade than the estimate submitted by their school, they could request an appeal.

These measures were discussed and fully supported by the National Qualifications Strategic Group representing a broad range of stakeholders, such as local authorities, teaching professional associations, college representatives, Universities Scotland, parental and learner representatives, Scotlish Government and Education Scotland.

It is important to note that the operational delivery of the appeals process is a matter for SQA, and Scottish Ministers are unable to intervene in individual cases. However, I have checked the general position with the SQA and I have set this out below.

In relation to Prelim exams, it is important to note that although they are commonly used, they are not a formal part of the process for awarding SQA qualifications. SQA does not set, mark, grade or quality assure Prelim exams. As such the marks and grades awarded for Prelims by centres have no formal standing in the SQA awarding process. Because Prelims are not quality assured by SQA they vary in standard, as well as in breadth of the course coverage, between different centres. This means it is not possible, when they are used in the appeal process as evidence of attainment, for SQA to accept the marks and grades applied by centres without additional checks.

As well as conducting a clerical check on the examination script, for each appeal SQA appointees (experienced subject teachers) will have reviewed alternative assessment evidence that learners have completed through the year. If, following this review of evidence, the appointee assessed that a higher grade had been achieved, then this will have been awarded. As per the fifth provision in the

attached SQA pages relating to Appeals, '(if) a clerical check confirms there is no change required to the grade on your certificate and your alternative assessment evidence does not demonstrate a higher grade', then 'the grade will remain the same'. SQA Appeals 2022 - what you need to know

SQA provided centres with guidance for determining estimates for 2022. SQA also published roles and responsibilities for Appeals 2022 on their website. These documents outline the evidence gathering approach with regards to estimates as well as what was expected of SQA, centres and learners during the Appeals 2022 process.

The National Qualifications Group have been clear that demonstrated attainment is a key principle in ensuring credibility and fairness of the qualifications. As such, while incredibly sensitive to individual situations, SQA processes cannot consider context and personal circumstances as part of the awarding process

The evidence provided by [Redacted s38(1)(b)] school in support of her appeal would have been reviewed by SQA appointees (an experienced art teacher). They would have assessed this against the national standard and would not have been made aware of the estimated grade or the awarded grade.

With the considerable demands on the wider system to deliver the evidence-based Appeals 2022 service, SQA have advised that there is no opportunity to provide individual feedback regarding appeal outcomes. In addition, as the outcomes are academic judgement made by subject experts there is no further appeal route.

I hope you will find this reply helpful and I would like to wish [Redacted s38(1)(b)] every success in her future studies.

Dear Nicola, I hope you are well. I write as a concerned member of the public, parent and government employee over a number of years regarding the assessment process being carried out with the SQA.

[Redacted s.38(1)(b)] How this happened no one will ever know, not really. She has worked on her portfolio of Art for some time, over 2 years, [Redacted s.38(1)(b)] in her subject, and sent her best work along with all the other [Redacted s.38(1)(b)] children with predicted high grades from school. I ask myself how can a young adult work [Redacted s.38(1)(b)] in [Redacted s38(1)(b)] to produce excellent work and [Redacted s.38(1)(b)]??

Her teachers for all students, and parents concerns have appealed but having spoken to an open and forward speaking person at the SQA only 10 minutes ago, I am told the SQA assessors will not be even reviewing the comments to support the individuals work, this includes a large number of children from one school, but having now spoken on the parents forum online this seems to be a pattern throughout a number of schools in the [Redacted s.38(1)(b)]area. No doubted, this appears to be a theme or trend, due to lack of resources, time constraints or for what ever reason, these results coming out of the SQA third week in October etc. I hear from our head master that the SQA markers are teachers from the schools taking out of their normal job, I only hope they use [Redacted s38(1)(b)] Teachers to Assess [Redacted s38(1)(b)] Work.

The SQA have had issues over the years, with an IT system not able to calculate properly, putting the future of our children at risk not gaining the valuable qualifications they need, no matter what the schools do. Covid impacted their studies, making it more of a challenge for them, even with help, these young impressionable individuals went through a traumatic time, not dissimilar to many other people. [Redacted s.38(1)(b)]

We are taught to be fair, just, fairness to all, the behaviours of the SQA are unjust, unfair and tragic, I want an investigation into there practices, marking and operations. They as the SQA caller stated, we have been told what to say, "not to go into detail, ignore head teachers questions, pleas, same for the parents. Their word is final, there will be no follow-up."

My daughter was to qualify with the grades to get into [Redacted s.38(1)(b)]this year, she had a [Redacted s.38(1)(b)]from her school. Thank you for your email of 27 September regarding your daughter's complaint about the SQA appeal process. As an official with policy responsibility for the National Qualifications, I have been asked to respond.

I understand that studying toward qualifications can be stressful at the best of times, and appreciate the disappointment that learners face when they do not get the grades that they had expected.

While there was a return to exams in 2022, it was not a return to normal. In recognition of the disruption that learners have faced over the last two years, and the different approaches to assessment, SQA took a more generous approach to grading than in a normal exam year. SQA experts (also known as appointees) – experienced teachers and lecturers – took an expert judgement based on a wide range of evidence as they do every year.

Fairness was at the centre of decisions around the National Qualifications this year. Acknowledging the ongoing disruption, the 2022 appeals approach went further than in recent pre-pandemic years. Where a learner received a lower grade than the estimate submitted by their school, they could request an appeal.

These measures were discussed and fully supported by the National Qualifications Strategic Group representing a broad range of stakeholders, such as local authorities, teaching professional associations, college representatives, Universities Scotland, parental and learner representatives, Scottish Government and Education Scotland.

SQA provided centres with guidance for determining <u>estimates</u> for 2022. SQA also published <u>roles and responsibilities</u> for Appeals 2022 on their website. These documents outline the evidence gathering approach with regards to estimates as well as what is expected of SQA, centres and learners during the Appeals 2022 process.

It is important to note that operational delivery of the appeals process is a matter for SQA, and Scottish Ministers are unable to intervene in individual cases. However, I have checked the general position with the SQA and I have set this out below.

I also note that you have written to SQA separately regarding this matter and have received a response. I hope you will find their reply informative.

As the SQA stated in their response to you, in relation to Prelim exams it is important to note that, although they are commonly used, they are not a formal part of the process for awarding SQA qualifications. SQA does not set, mark, grade or quality assure Prelim exams. As such, while they may have been used by your daughter's teachers to determine her estimate alongside other assessment evidence gathered during the year, the marks and grades awarded for Prelims by centres have no formal standing in the SQA awarding process.

As well as conducting a clerical check on the examination script, for each appeal SQA appointees (experienced subject teachers) will have reviewed alternative assessment evidence that learners have completed through the year. If, following this review of evidence, the appointee assessed that a higher grade had been achieved, then this will have been awarded.

The evidence provided by your daughter's centre in support of her appeal would have been reviewed by an SQA appointee who would have applied their professional judgement to the standard and coverage of evidence against the national standard.

As per the fourth provision on page 8 of the following SQA pages relating to appeals, "(if) a clerical check confirms there is no change required to the grade on your certificate and your alternative assessment evidence does not demonstrate a higher grade", then "your grade will remain the same". SQA Appeals 2022 - what you need to know

With the considerable demands on the wider system to deliver the evidence-based Appeals 2022 service, SQA has advised that there is no opportunity to provide individual feedback regarding appeal outcomes. In addition, as the outcomes are academic judgement made by subject experts there is no further appeal route.

I am sorry to hear that [Redacted s38(1)(b)]was unable to offer any flexibility in their entry requirements for the [Redacted s38(1)(b)]course.

I am writing to you in order to raise a formal complaint regarding a recent series of events whereby, the SQA has failed to follow the SQA code of practice Also, having failed to deliver on its promises in a fair and concise manner. (\*1a)

I now wish to highlight the main element of my complaint, and this also is around the systems and the failings of the duty of care towards myself.

Over the past two years, I have successfully applied and been offered a conditional place on the [Redacted s38(1)(b)], I was unable to attain the required academic qualifications at school due to my [Redacted s38(1)(b)]

The SQA promised to be generous with their marking, quote Fiona Robertson (\*1b), whereby it had been agreed that the SQA would consider the impacts of the pandemic. I feel the SQA have not fulfilled this promise. In the spirit of your statement, I'm concerned that the statements have not been considered.

After completing my final exam for[Redacted s38(1)(b)], this was submitted to the SQA, with my appeal. (\*1c, grades given by [Redacted s38(1)(b)]) They were as dismayed as I was with the final outcome of the appeal. Both Lecturer & Head of the department are fully supportive of my appeal and support my Grade[Redacted s38(1)(b)]. Within the appeals literature it states that the appeals process involves looking at both my evidence and my final exam. The SQA promises to award the higher grade. However, for me to be given a [Redacted s38(1)(b)], must be a result of my pre-lim examinations being down marked, by the SQA accessor. This clearly acknowledges that my lecturer and head of Science from the Centre, have incorrectly marked my pre-lim exams, which myself and the Centre disagree with. This downgrading also supports that the promise of marking generously has not come to fruition. I believe I should have been awarded the [Redacted s38(1)(b)]grade; the outcome was far from generous. (\*1d)

I received a response from [Redacted s38(1)(b)] (\*1e), in relation to not being successful with the appeal. I must add here that I feel there is a proven problem with this system, which also does not provide any feedback or any opportunity to complain to the appeal subcommittee, even my college are unable to pursue feedback. It's totally unfair that someone has this power over my future, and it has left me lacking trust in the SQA. [Redacted – information not in Scope] I trust my complaint will be thoroughly investigated and my hope is for an amicable resolution, considering the above system failure.

[Redacted s38(1)(b)]- UNSUCCESSFUL APPEAL TO SQA WHICH SOUGHT TO INCREASE GRADE AWARDED IN ADVANCED HIGHER [Redacted s38(1)(b)]- FROM A 'B' TO AN 'A'

Thank you for your letter of 28th October 2022 in response to my e-mail of 22nd September 2022 in connection with the above-mentioned subject. I am very disappointed with the generality of the response received and its non-specific nature insofar as[Redacted s38(1)(b)] particular and specific circumstances are concerned.

[Redacted s38(1)(b)], as I have previously advised, was awarded a B Grade in her summer SQA examinations falling 2% below the boundary for an A Grade. Her school, [Redacted s38(1)(b)] lodged an appeal against the result as a priority case to the SQA supported by evidence from Prelim examinations she had sat. Since last writing to you we have established that[Redacted s38(1)(b)] sat two Prelim examinations, referred to by the school, as FAB 1 and FAB 2. [Redacted s38(1)(b)] achieved 92% in the FAB 1 examinations which covered 75% of the course and 90% in the FAB 2 examinations which covered 100% of the course. The school have recently advised us that the papers sat by [Redacted s38(1)(b)] in her FAB 2 Assessments have now been reviewed by four[Redacted s38(1)(b)]- teachers, three from within the school and one external to the school. All four teachers have advised, in their professional opinions, that the FAB 2 papers which[Redacted s38(1)(b)] sat were considered appropriate as evidence to support an appeal when compared to the guidance issued by schools/centres by the SQA, to which I will make further reference later. The school have also advised that[Redacted s38(1)(b)] FAB 2 paper has been re-marked by a [Redacted s38(1)(b)]- teacher external to the school who awarded her 87% rather than 90% but still well within the boundaries for which any reasonable person would expect a B to be upgraded to an A.

You have stated the following in your letter of 28th October 2022;

'In relation to Prelim exams, it is important to note that although they are commonly used, they are not a formal part of the process for awarding SQA qualifications. SQA does not set, mark, grade or quality assure Prelim exams. As such the marks and grades awarded for Prelims by centres have no formal standing in the SQA awarding process. Because Prelims are not quality assured by SQA they vary in standard, as well as in breadth of the course coverage, between different centres. This means

it is not possible, when they are used in the appeal process as evidence of attainment, for SQA to accept the marks and grades applied by centres without additional checks.

As well as conducting a clerical check on the examination script, for each appeal SQA appointees will have reviewed alternative assessment evidence that learners have completed through the year. If, following this review of evidence, the appointee assesses that a higher grade has been achieved, then this will be awarded.

The evidence provided by your daughter's school in support of her appeal would have been reviewed by an SQA appointee who would have applied their professional judgement to the standard and coverage of evidence against the national standard. As per the fourth provision on page 8 of the attached SQA pages relating to appeals, " (if) a clerical check confirms there is no change required to the grade on your certificate and your alternative assessment evidence does not demonstrate a higher grade", then " your grade will remain the same".

Whilst I note the SQA's position that Prelim exams are not a formal part of the process for awarding SQA Qualifications and that it is not possible accept the marks and grades applied by centres without additional checks, it is important to recognise that the SQA issued advise to all centres in its paper 'Appeals 2022, General Information' in May 2022 as to the type of alternative evidence that could be submitted in support of appeals. That paper stated, inter-alia, the following:

'Prelims or mock exams are likely to be the most reliable indicator of performance in a question paper component. The most convincing examples of these will accurately predict attainment in the skills, knowledge, and understanding assessed by the question paper. They will be clearly aligned to the course specification, content, level of demand, and assessment conditions as exemplified in the specimen question papers and past papers.

The way in which prelim or mock question papers are produced can vary. They tend to fall into three main categories: centre produced papers; papers generated co-operatively by a group of centres; and commercially produced question papers. All of those have the potential to generate robust evidence for appeals. In all cases, the validity, reliability and security of the evidence should be checked before being submitted to SQA.

Centres generating their own prelims sometimes incorporate elements of SQA past papers. This can be a valid approach. Please note, though, that an SQA past paper or specimen question paper in its entirety will not be accepted if it is the only evidence submitted. These papers and their marking instructions are in the public domain and can be accessed by learners. The subject-specific ACM 2021 Assessment Resources available on the SQA secure site cannot be used in their entirety as the only evidence to support appeal requests. These resources are not secure and should be treated in the same way as SQA past papers or specimen question papers.'

In the SQA Document entitled 'Appeals 2022 – what you need to know' the assessment of appeals is explained. There are two circumstances set out where the grade would remain the same following an appeal. These are as follows:

- 1. A clerical check confirms there is no change required to the grade on your certificate and your alternative assessment evidence does not demonstrate a higher grade.
- 2. A clerical check highlights that you have achieved a lower grade than the grade on your certificate; however, your alternative assessment evidence demonstrates the same as your certificate. The same document cites the following circumstances where a higher grade will be awarded:

- 1. A clerical check demonstrates that you have achieved a higher grade than the grade on your certificate.
- 2. A review of your alternative assessment evidence and SQA coursework demonstrates a higher grade than the grade on your certificate.
- 3. A clerical check highlights that you have achieved a lower grade than the grade on your certificate; however, your alternative assessment evidence demonstrates a higher grade than the grade on your certificate.

[Redacted s38(1)(b)] school (i.e. [Redacted s38(1)(b)]) is adamant that the Prelim papers (FAB 1 and FAB 2) sat by [Redacted s38(1)(b)] were compliant with the guidance issued by the SQA referred to. That position is supported by the professional opinions of three [Redacted s38(1)(b)]- teachers within the school and one teacher external to it.

You state in your letter that the evidence provided in support of [Redacted s38(1)(b)] appeal would have been reviewed by a SQA appointee who would have applied their professional judgement to the standard and coverage of evidence against the national standard. Am I to take from this that the papers sat by [Redacted s38(1)(b)], which had been prepared by her school, did not comply with the evidence required by the SQA or am I to take something else from it or am I to take nothing at all from it? Clarification would be appreciated as it seems irrational that four maths teachers can hold the professional opinions that a grade should be increased from a B to an A based on the evidence submitted whereas the SQA appointee has formed an opposite opinion. Might the irrational outcome be down to a simple administrative error on the part of the SQA?

If that is not the case and if the papers were deemed inappropriate and failing to meet the national standard, the system employed by the SQA has clearly failed our daughter and as a consequence serious questions must be asked of the SQA as to why the Guidance issued by them could generate such a scenario and why schools/centres were not properly advised/trained as to what would and would not be considered as acceptable evidence in support of appeals lodged.

By way of further update I have also attached for your attention a copy of a letter issued to the SQA by my lawyers in connection with this matter and a copy of a reply received from the SQA's lawyers who have stated that they will revert with a substantive response to the issues raised within 14 days of 21st October 2022. My lawyers have already been instructed to instigate judicial proceedings against the SQA in the event of that response not addressing the issues raised satisfactorily.

I look forward to hearing from you further.

Thank you for your email of 22 September regarding your [Redacted s38(1)(b)] and subsequent appeal to SQA. I apologise for the delay in responding while my officials sought clarity on the position with the SQA.

I understand that studying toward qualifications can be stressful at the best of times, and appreciate the disappointment that learners face when they do not get the grades that they had expected.

While there was a return to exams in 2022, it was not a return to normal. In recognition of the disruption that learners have faced over the last two years, and the different approaches to assessment, SQA took a more generous approach to grading than in a normal exam year. SQA experts (also known as appointees) – experienced teachers and lecturers who are not SQA employees – took an expert judgement based on a wide range of evidence as they do every year.

In addition, acknowledging the disruption this year, the appeals approach goes further than in recent pre-pandemic years. Where a learner received a lower grade than the estimate submitted by their school, they could request an appeal.

SQA provided centres with guidance for determining estimates for 2022. SQA also published roles and responsibilities for Appeals 2022 on their website. These documents outline the evidence gathering approach with regards to estimates as well as what is expected of SQA, centres and learners during the Appeals 2022 process.

Operational delivery of the appeals process is a matter for SQA, and Scottish Ministers are unable to Intervene in individual cases. However, I have checked the general position with the SQA and I have set this out below.

In relation to Prelim exams, it is important to note that although they are commonly used, they are not a formal part of the process for awarding SQA qualifications. SQA does not set, mark, grade or quality assure Prelim exams. As such the marks and grades awarded for Prelims by centres have no formal standing in the SQA awarding process. Because Prelims are not quality assured by SQA they vary in standard, as well as in breadth of the course coverage, between different centres. This means

it is not possible, when they are used in the appeal process as evidence of attainment, for SQA to accept the marks and grades applied by centres without additional checks.

As well as conducting a clerical check on the examination script, for each appeal SQA appointees will have reviewed alternative assessment evidence that learners have completed through the year. If, following this review of evidence, the appointee assesses that a higher grade has been achieved, then this will be awarded.

SQA Appeals 2022 - what you need to know.

With the considerable demands on the wider system to deliver the evidence-based Appeals 2022 service, SQA has advised that there is no opportunity to provide individual feedback regarding appeal outcomes. In addition, as the outcomes are academic judgement made by subject experts there is no further appeal route.

I hope you will find this reply helpful, and I would like to wish your daughter every success in her future endeavours.

# **Priority Appeals and Conditional HE Places for Students**

# Purpose of meeting

To discuss SQA priority appeals timescales (reached in line with UCAS clearing deadlines) and earlier internal deadlines set by some higher education (HE) institutions for finalising conditional offers, and determine what can be done to minimise the impact on learners awaiting appeals outcomes going forward.

#### Background

As part of SQAs appeals service, a priority appeals process operates for learners requiring the outcome of an appeal for immediate progression to university, college, training or employment.

The timescales for outcomes of these priority appeals to be finalised is arrived at each year in line with the UCAS clearing deadline. In 2022, this was 6 September. This date is determined by UCAS and is the same date for all UK Awarding Bodies.

However, we are aware that some HE institutions set earlier deadlines to meet their internal processes in line with individual term start dates.

This differential in timescales caused concern for learners and their parents who were awaiting appeals that were required for conditional offers. There was an increase in correspondence on this issue this year, with some applicants indicating that they missed out on preferred courses or had to defer their place until next year.

While many institutions aimed to provide flexibility around entry requirements and/or deadlines where priority appeals were being progressed, it is recognised that there were challenges for some universities, particularly for high demand courses including medicine, law and vet.

## Particular challenges around appeals in 2022

In recognition of the disruption last year, SQA's appeals approach went further than in recent pre-pandemic years. It built on the approach undertaken historically in Scotland, taking alternative learner evidence into account in the appeals process. This comprehensive appeals process was agreed by stakeholders across the education sector and was put in place to ensure fairness and equity for learners.

SQA is dependent on centres to advise on conditional offers when it comes to priority appeals. It does not have sight of these ahead of the requests which centres have to validate at the same time as they submit their learners' evidence digitally. Due to the number of priority appeals and the resources required to progress these, SQA did not have flexibility to process appeals any earlier.

Along with all other 2022 arrangements, SQA will carry out an evaluation of how the Appeals 2022 service performed. The results of this evaluation will play an important

part in informing the decisions around what type of service will be taken forward for 2023, and there is an ongoing discussion with stakeholders through the National Qualifications 23 Group about the approach.

Each year the SQA disappoints Scottish students and often leaves them feeling invisible and disappointed. 2022 was no different with only a tiny fraction of appeal requests going

through leaving many students devasted and unable to apply for their favourable university choices.

Signing this petition will tell the SQA that we are not happy with their so-called "robust" marking. If we do not take action then our children have no chance of getting the grade their teachers estimated them to get based on their evidence.

If this petition gains enough traction we plan to organise a peaceful protest at the SQA HQ in Glasgow

#### **Key Points from Meeting**

Purpose of the meeting was to discuss the difficulties and challenges encountered this year in relation to the exam results appeals process. Although there was a priority appeals process in place to prioritise those students who had submitted an appeal, the outcome of which would decide whether the student had achieved the results to attend the university of their choice, the deadlines for the appeals results and the start dates of various universities and courses did not align and this caused issues for some students with conditional offers who were not able to secure a place in the current academic year.

SQA set out the key elements of their priority appeals process for 2022:

- In order to submit an appeal, eligibility criteria had to be met. In particular an
  estimate of exam result had to be in the system and this had to be higher than
  the exam mark achieved.
- Schools had to submit the appeal by 19 August (the submission start date was results day – 9 August).
- Schools had to provide digitised evidence, gathered throughout the year, to support the appeal.
- Difficulties with regards to this tight timeline was compounded as many schools were not back by 19 August so meeting this deadline was difficult. SQA had many discussions with teaching unions etc about staff working during the summer holiday in order to ensure the 19 August deadline was achieved.
- By accessing the UCAS portal, schools could establish which students would require a priority appeal which could speed things up a bit but this was not done by all schools.
- In addition, SQA had 1,420 appeals to process, 3-4 times more than the norm or expected. It was not clear why that was the case and whether it would be indicative of appeals volumes in future academic years. [Redacted s30(b)(ii)]

• In previous years, schools did not have to provide the additional evidence. Instead the exam paper was re-examined to check that the correct grade had been given. [Redacted s30(b)(ii)]

Colleagues in attendance from HEIs confirmed that many institutions were commencing their academic years from an earlier date than in the past. From around 2010 Scottish courses have started earlier to assist students e.g. to ensure able to finish first semester prior to Christmas so students can timeously travel home, get pre-Christmas holidays. Start date moved from early October to early September. – meaning many instituions required confirmation of student places by 31 August, one week prior to the UCAS clearing deadline.

# **Conclusions Reached/Next Steps**

- [Redacted s30(b)(ii)]All attendees felt, however, that clear, effective communication with students was essential to mitigating problems in future years and managing expectations. HEIs indicated that, where students with conditional offers who did not obtain their expected grades contacted them proactively to keep HEIs advised of their situation, they would always strive to be flexible and it was important for students to receive that message.
- All agreed that timescales tight all round and that want learner to be there
  from the start of their HE education experience for student welfare, getting
  accommodation, widening access agenda etc.
- Noted SQA & US worked together during covid, so can do so again.
- SQA advised that the appeals process for 2022 was being evaluated in partnership with UCAS, Russell Group and Universities Scotland. This would inform decisions on the appeals process for 2023.
- It was agreed by all that all attendees should reconvene for a further meeting in December, ahead of SQA finalising plans for the appeals process for 2023.
- Also agreed that it would be useful to have UCAS in attendance at the next/future meeting(s).
