## Sturgeon must make statement on transgender criminal chaos

The Scottish Conservatives are demanding a parliamentary statement from the First Minister on the safety of female prisoners to clarify Scottish Government policy in the wake of "chaos, confusion and U-turns" by SNP ministers.

Shadow community safety minister Russell Findlay also confirmed his party would put forward an amendment to the SNP's Bail and Release from Custody Bill to introduce a legal ban on violent transgender criminals being housed in women's prisons.

The move would make permanent the temporary halt on trans prisoners with a history of violence against women being housed in female jails, which Keith Brown announced on Sunday.

The justice secretary's latest U-turn came after growing public and media outcry over the cases of a double rapist – now identifying as a female, [redacted] – who was initially sent to a women's jail and another violent trans criminal – Tiffany Scott – who had been approved for transfer to a female jail.

Russell Findlay – who has submitted a Topical Question on this issue to the Presiding Officer – also urged the SNP to take evidence from the United Nations expert on torture, Alice Edwards, who tweeted about her concerns over the safety of women prisoners in Scotland.

**Scottish Conservative shadow community safety minister Russell Findlay said:** "After days of SNP chaos, confusion and U-turns, Nicola Sturgeon must come to parliament as a matter of urgency. She needs to explain her government's shambolic mess and make clear how the safety of female prisoners can be guaranteed.

"We need full transparency because the only thing clear at the moment is that the justice secretary is in complete disarray. Keith Brown was only shamed into this dramatic U-turn after a sustained public outcry over two highly dangerous criminals.

"But a 'pause' on criminals with a history of violence against women being housed in female prisons does not go far enough. We need a permanent ban to safeguard vulnerable female inmates.

"The Scottish Conservatives will seek to amend the SNP's Bail and Release from Custody Bill, which is due to come before parliament in March, in order to make this temporary ban permanent.

"The last few days have exposed Nicola Sturgeon as being completely out of touch with public opinion. Putting the rights of highly dangerous criminals ahead of those of vulnerable women is utterly perverse.

"I have also submitted a Topical Question seeking answers from the Scottish Government about the review of Scottish Prison Service policy on transgender criminals in the wake of the [redacted] scandal.

"I would also urge the SNP to take evidence from the UN Special Rapporteur on Torture who shares widespread public concerns over the safety of women prisoners."

#### Criminal Justice Board members

You will be aware of the current significant public, media and parliamentary interest in the issue of transgender prisoners, in particular the placement of transgender female prisoners in the female prison estate. This email seeks your assistance as part of our response to these issues.

Transgender prisoners account for around 0.2% of the prison population. As with other prisoners, appropriate robust risk assessment processes are in place within prisons to assess risks associated with individual transgender prisoners and to determine the most appropriate location, etc.

However, in light of the public and parliamentary concern raised about two cases in recent days, following engagement between SG and SPS, the Cabinet Secretary for Justice and Veterans announced on Sunday 29 January a number of actions which the SPS have put in place to provide immediate assurance around the protection of female prisoners. A copy of the Cabinet Secretary's statement is provided below. The actions are being taken forward by SPS, but I am seeking your assistance specifically with the following commitment:

2. No newly convicted or remanded transgender prisoner with any history of violence against women will be placed in the female estate. Violence against women includes sexual offences against women.

There will sometimes, but not always, be intelligence in advance about someone who might either be remanded in custody or receive a custodial sentence. Whilst the current commitment is in place, it is clearly vital that SPS is made aware as soon as possible if there is any possibility of a female transgender prisoner with any known history of violence against women or girls (taking the wide SG definition of VAWG, which includes, sexual offending, physical and psychological abuse, stalking, etc.) being remanded or sentenced to custody, so that necessary arrangements can be put in place. We recognise that this is not straightforward and will be easier to determine for some prisoners than others (e.g. there may be limited notice for people remanded through the custody courts), but it is vital in the current context that any intelligence on such instances is communicated to SPS when it is known. In the immediate term we would be grateful, for those organisations where this is a relevant issue (e.g. Police, Crown and Courts), **we would be grateful if you could identify urgently a named individual to liaise with SPS on this issue.** SPS are exploring the potential for a Memorandum of Understanding to help clarify arrangements, as far as possible.

### Extract from Ministry of Justice/ HMPPS (England and Wales) policy on Care and Management of Individuals who are Transgender:

• All individuals in our care must be supported to express the gender with which they identify.

• Their preference does not oblige us to allocate them to a men's or women's prison or approved premises accordingly; it is one of many factors that may influence such decisions.

• However, all individuals who are transgender must be initially allocated to part of the estate which matches their legally recognised gender (or best-known evidence where legal gender is not known).

• The only exceptions are when allocation decisions are approved by a Prison Group Director or the Community Interventions Deputy Director 10 via a Complex Case Board, or YCS Head of Casework or Band 8 Senior Case Manager.

• A balanced approach must be adopted when making allocation, care and management decisions relating to transgender individuals, balancing the risks and well-being of the individual with the risks or impact on well-being that the person may present to others, particularly in custodial and residential settings.

• Additional structured risk assessments and resources are required before a person is allocated or transferred to part of the estate which does not match their sex assigned at birth, including where a person has gained legal recognition of the gender with which they identify.
