The exceptions applied in this instance are:

Some information has been withheld under regulation 10(4)(e) (internal communication). This exception is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exception. We have found that, on balance, the public interest lies in favour of upholding the exception. We recognise that there is some public interest in releasing the information as part of an open, transparent and accountable government. However, this is outweighed by the greater public interest in allowing a private space for officials to share confidential information on the development of any given policy.

Some information has been redacted under regulations 10(4)(e) (internal communication). This exception is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exception. We have found that, on balance, the public interest lies in favour of upholding the exception. We recognise that there is some public interest in releasing the information as part of an open, transparent and accountable government. However, this is outweighed by the right to legal client privledge.

In addition, some of the information has been redacted from the documents disclosed under Regulation 11(2) – Personal Data as it contains personal information and disclosing it would contravene the data protection principles in Article 5(1) of the General Data Protection Regulations (GDPR) and in Section 34(1) of the Data Protection Act 2018. This exception is not subject to the 'public interest test'.

Thank you Kevin, good conversation with FM just now, I emphasised:

- 1) Reasonable expectation of decision on IMA exclusion in April we appreciate all efforts to get this over the line to remove uncertainty, so let's keep working all channels robustly with UKG
- 2) Emerging business support package is welcomed, and early view is we should maximise this to support small retailers and producers to de-risk the scheme, as per your good advice – please keep pushing the boundaries here e.g. to maximise small producer/retailer/hospitality easements as far as we can whilst ensuring the scheme is viable. Easements could always be timelimited of course too, to reduce volume/risk in early years subject to future review
- 3) Rescheduling, we discussed the balance of risk; and the additional SG integrated assurance work underway with CSL, and the emerging consensus that some limited additional time could help de-risk with more time to test and assure delivery confidence, and align the operating environment, so all could prepare properly once uncertainty was removed and the revised scope is clear, as per points 1 and 2 above. It seems reasonable that having made the changes in business support, we give industry time to adjust and plan accordingly

- 4) The additional point which FM made could we have some form of milestone moment/additional testing phase/pilot from August – to support de-risking; please continue to exhaust options on this and advise accordingly
- 5) FM appreciates the work ongoing to advise Cab Sec and Ms Slater, and I would prefer accountable Ministers to address optimism based on your robust advice, via evidence and assurance, to ensure FM receives sound advice on an optimal delivery plan so the scheme can go live in a safe and secure way (as best feasible recognising this is complex transformation); please work hard on this in the coming days
- 6) Please do the best you can to use all the evidence, assurance and data available to make a recommendation on when optimal to deliver the scheme to agree with your Ministers if you can. Please copy advice to FM's office
- 7) Chris will be in touch to arrange a meeting for you and your Ministers with FM next week, which I will join too Roy/Kevin/Michelle all welcome, so we can ensure the evidence from the Gateway review, integrated assurance activity, CSL/ZWS/SEPA feedback is all included in the discussion
- 8) From my PAO perspective, you are doing all the right things, with integrity; please continue to do so. Your draft Comms below all look good to me, and you can package that up in your advice for agreement if possible, recognising that step 1 is to secure the UK IMA exemption.

With thanks to David and Michelle, in advance of your meeting with the FM tomorrow please see a brief sitrep of ongoing DRS policy work following our submission to the FM on Monday.

We are looking to translate the note below into a further submission which we plan to send on Wednesday evening to Ms McAllan and Ms Slater (on leave next week) with a view to discussing it with them on Thursday (following a good discussion with them last Friday). I don't want to pre-empt these further discussions with Ministers so I am keeping this note to a narrow list of officials for now.

We had hoped that the FM could join a ministerial discussion but we understand he is n/a this week. Grateful if you can test the shape of this with the FM tomorrow. Thank you.

DRS sitrep

IMA exclusion (readout from discussion with DEFRA DRS Director 4/4 – further discussion scheduled 6/4)

- DEFRA welcomed the Cab Sec letter of 3 April to the SoSs for DEFRA and Department for Business and Trade (DBT) on the issues of the Internal Market Act and trading standards with respect to DRS, and recognised this represented a clear intent to proceed with Scotland's DRS.
- DEFRA also recognised SG's need for urgency on a UKG decision on an IMA exclusion for DRS and sought to reassure that they were actively working through navigation of political considerations within UK Government in order to reach an outcome.
- Given the time critical nature of discussions within UKG (over the recess period), DEFRA emphasised that SG's position was clear and that the proposed bilateral with Scottish Ministers, although welcome, was not essential.
- SG stood ready to support DEFRA, as required, and urged that DEFRA work with UK departments to decouple considerations on DRS delivery (which were for SG) from with UKG considerations on an IMA exclusion. DEFRA appreciated that the issues were not interdependent and any risks to delivery should not be taken as reason not to grant an exclusion.

Options for Business Support and Rescheduling

- Framed as "<u>Business Support</u>" we are firming up a recommended package to right size the obligations of DRS on producers (targeting small producers in particular):
 - o Increased comms on SEPA's light touch enforcement approach
 - Removing products with less than 5000 SKU's a year further analysis is needed, but initial work suggests this would remove a significant number of small producers from DRS obligations whilst only sacrificing a very small % of the overall volume of empty containers on the market (ie reduce political pushback at minimal cost to policy recycling objective)
 - Removing products less than 100ml from DRS (ie "miniatures")
 - Removing return point obligation on off-sales for hospitality premises where off-sales are < 10% of total sales (possibly increasing to nearer 20% depending on evidence)
 - o [Redacted]
- Framed as "<u>Rescheduling</u>" (to avoid the lethargy associated with "delay") and subject to completion of the Assurance work above, we are likely to recommend a 6.5 months delay to DRS (from 16 August to 1 March) which would give businesses 10 months from 1 May to prepare. There are risks to delay (including loss of overall momentum) but on balance it will be welcomed by many.
- <u>Communications</u> around the above package would draw on your earlier steers and would be along the lines below including crucially a public restatement of commitment from the FM and a clear new date for all to work to:
 - DRS is the right thing to improve recycling, reduce littering and emissions and is central to our mission to achieving Net Zero in Scotland
 - Committed to delivering DRS safely and securely in Parliament, responding to feedback (especially to support smaller retailers and producers and ensure a consumer experience that is as smooth as possible)
 - Continue to seek an exemption from the UK IMA, expected from the UKG in April, to remove uncertainty.
 - Ministers have write to the PM to reaffirm commitment to rolling out DRS in this Parliament
 - Reassured by sustained levels of public support in Scotland for the DRS scheme

- We have listened to business: all want to DRS and some are ready but many are not and are calling for a delay.
- We want to manage this complex transformation safely and securely and accordingly....
- We are announcing a package of Business Support and Rescheduling to allow extra time for all stakeholders to be ready.
- The rescheduled launch of DRS will not be without challenge and we will all need to work together to secure the benefits it will bring to this generation of citizens and the next.

As you are aware Ms Slater held separate meetings with DRS producers and retailers following your earlier statement on the DRS delay. In general they were anxious for assurance that an IMA exclusion will materialise and that the extra time to prepare will be well used with clear timelines, milestones and accountabilities (as you have also asked for). Separately, Ms Slater met with the Circularity Scotland Limited (CSL) Chair and CEO who reiterated the importance of the First Minister taking a meeting with the CEOs of its retailer, and especially producer, members. Accordingly, I <u>recommend</u> that the First Minister take this meeting as proposed below.

Purpose of the meeting:

- to personally <u>reaffirm</u> the First Minister's commitment to successful implementation of DRS on 1 March 2024
- an opportunity for the FM to demonstrate leadership in <u>engaging</u> with some of the largest businesses in the country
- to thank producers and retailers for their efforts in preparing for DRS to-date
- to ask them to now work on a "<u>team Scotland</u>" basis to deliver the Scotland's DRS scheme paving the way for other schemes across the UK
- to <u>explain</u> in more detail the rationale for the simplification package and the rationale for DRS delay (Ms Slater)
- to continue to listen to business concerns
- to urge them to call on UKG to do the right thing on the Internal Market Act exclusion

Timing Thursday 20 April: 1 hour between 4 - 6pm subject to the FM's diary

- One meeting of CSL's producer and retailer members together. A large meeting but enables the FM and ministers to underline the whole system nature of DRS and the differing perspectives.

Engaging retailers is an opportunity explore with them what milestones they can deliver to demonstrate their intent to be ready for 1 March 2024. Reciprocally they will want assurances that we will work across the system to establish clear timelines, milestones and accountabilities.
