He then raped her, before later returning to pour petrol on her and setting her alight.

During sentencing, Lord Arthurson branded the violence "feral". He told Bennett: "The available evidence tells the horrible truth that your victim was still living at the time that the fire was set. To be crystal clear - you burned her alive." Scotland's courts are a joke thanks to your government's change in the guidelines. This is an absolute disgrace and you and your Party should be ashamed.

## Good afternoon

I am writing to you to highlight my absolute disgust, that once again, a man who carried out the heinous crime of a brutal rape and murder by setting his victim on fire while still alive, had his sentence reduced due to being under 25.

You'll no doubt excuse this by parroting the, "we can't intervene, and nor should we,

with sentencing". This is absolutely correct of course, but time and again, judges remind us that they are required by guidelines brought in by this current administration, to take into consideration the fact that someone is under 25.
