INDEPENDENT REVIEW OF THE SKILLS DELIVERY LANDSCAPE

Dear Ministers,

Thank you for meeting with me on 25 April to discuss my progress on the Independent Review of the Skills Delivery Landscape.

In line with the timescales that I set out when we met, I am writing to you now to submit my final report and recommendations. This builds on the early draft report that I submitted to the Scottish Government in March.

Whilst the substance of the report and the recommendations are largely unchanged, as indicated, I have further refined and developed my thinking, building in particular on the independent analysis of the call for evidence responses and further discussions with key stakeholders. I wish to flag some of the additions I have made:

- For most of the recommendations, I have added more detail as I have considered the issues and their interdependencies in more depth.
- I have reframed and reordered some of the recommendations and accompanying text to improve the narrative and to ensure that the rationale for my recommendations is clear.
- I have sought to achieve a balance in how prescriptive I am about aspects of my recommendations, including, for example, the status of new public bodies that I am proposing.
- I have added concluding chapters that summarise and contextualise my recommendations including within the wider programme of related reforms and reviews that are underway.
- I have sought to differentiate between recommendations for structural reform of the public body landscape and those that relate to operational delivery of the system.

Alongside the report containing my recommendations, I am submitting a report containing an independent analysis of the submissions that I received to the written Call for Evidence for the Review. Where respondents have given their permission, I understand that the individual responses will also be published on the Scottish Government's consultation hub, Citizen Space, to coincide with the publication of the reports.

As confirmed when we met, my understanding is that publication of the report and sharing the recommendations with the relevant public bodies will be a matter for the Scottish Government. Following your receipt of my report and consideration of timings, I should be grateful if you could confirm the planned date of publication with me in advance. I also want to reiterate my offer to support the communication of my findings to relevant stakeholders should that be helpful.

I want to thank you for the opportunity to work on the Review over the last seven months. It has been an engaging and thought-provoking experience. I began this process excited about the potential of our skills delivery system to play a central role in Scotland's economic transformation over the coming years. The many people and organisations I have met during my review have only re-emphasised this. Change is never easy, particularly the substantive change I am proposing, but I believe this is a moment of real opportunity to embrace it, with all the benefits it could deliver.

Finally, I would like put on record my sincere thanks to the Review Secretariat team. [redacted] have been a huge support to the process and to me personally; without them, the review would not have had the breadth and depth it has had.
