Hello [Redacted],

Please see below the spreadsheets that will need reuploaded in place of the current publications (14 in total). For awareness, the most recent changes (2021 – 2022) are due to a series of recurring meetings with the green party being missed out as offices mistook these for **internal rather than external**. The changes that date back (2016 – 2017) are **small changes to change the status of ministerial gifts from “On Display” to “Purchased by Minister”** due to the changes in administration. If you need a specific description of these it would be most appreciated if you could note something along the lines of “minor amendment made to spreadsheet”

I have provided a list below alongside the updated spreadsheet that is to be uploaded. If ok timewise we would like to undertake republication on **Monday 6<sup>th</sup> March** if this would be possible? If you need anything further can you please let us know, I have included the URL links for all of these also.

COMMS – For awareness, the changes have been seen by our DD and PPS to the First Minister Christopher Mackie who is content, this has also been cleared by our C2 [Redacted] who leads on Open Government within our division. The changes are mainly ad-hoc ones e.g. FM has bought the book that was previously On Display. Regarding the green meetings, this was a small oversight from Private Offices who assumed the meeting with Greens was internal due to the BHA, however it is a regular meeting with MSPs in the Green Party that are not members of the government and therefore external, thus they need to be published and this has been rectified going forward.
