# **Matters Discussed**

- 1. Welcomes and introductions were offered. The meeting was conducted in the Japanese language with contemporaneous translation to English.
- 2. A company overview was provided, covering domestic and international markets, followed by a Q+A session.
- 3. The company's interest in the Kincardine project was noted, and the Cabinet Secretary explained that, while he is generally supportive of offshore wind development and in exploratory discussions around maximising inward investment and supply chain opportunities, he would offer no view on the merits of the proposed development, with applications being independently assessed in due course. No project specific details were discussed in the course of the meeting.
- 4. Scotland would like to learn from Japan on the use of hydrogen as part of a balanced energy mix what innovation and market lessons can be shared, and what investment potential/ opportunities for Japanese businesses? There are gaps in the Scottish supply chain which could be reinforced by Japanese expertise. SDI could have a role in facilitating introductions that would deliver mutual benefit for Scotland in meeting supply chain requirements, and commercial opportunity for investors. Keen to maintain a dialogue.
- 5. TEPCO highlighted the uncertainty associated with lack of clarity around renewables subsidy. No final investment decisions can be taken pending confirmation of the strike price. The Cabinet Secretary acknowledged that the conditions must be correct for commercial investment to be made.

- 1. Parties agreed continue to dialogue, including through SDI, to identify future opportunities for mutual support.
- 2. The Cabinet Secretary agreed to write to the UK Government to highlight the need for clarity in the subsidy to be awarded through contracts for difference.

- 1. Welcomes and introductions were offered.
- 2. Marubeni outlined three key challenges to the delivery of its offshore wind aspirations in Scotland supply chain, grid and skills.
- On supply chain, investment in port infrastructure is required to accommodate floating structures. The Cabinet Secretary welcomed feedback on specific requirements around location and specification of requirements, and noted his personal determination to ensure that supply chains are robust to facilitate project delivery.
- 4. On grid, Marubeni noted that projects cannot proceed without clarity around National Grid's Holistic Network Design, with UKG decisions already having been delayed by several months. The Cabinet Secretary will continue to engage with UKG, but encourages Marubeni not to underestimate their own influence with UKG as a key investor.
- 5. On skills, Marubeni expressed concern about access to sufficient people and kills to deliver complex projects. The Cabinet Secretary acknowledged this. The Scottish Government is continuing to engage with UKG to seek relaxation of border controls to improve access to skilled workforce, and is investing in its domestic skills development programme to ensure ready to support project delivery.
- 6. There was a general discussion around hydrogen and the need to develop offtake projects at scale.

- DJ glad to be Sumitomo's link into HMG.
- YS noted they will make an investment decision in March importance for energy security for the UK to have a cable factory here. Demand for cable will far outstrip supply. Sumitomo want a stable market for the long term, with Government support. Setting up a factory requires a large investment, especially coming from the Far East.
