One amendment from me, based on a quick exchange with [REDACTED] and some rounding clarifications. It turns out Scotland is actually 4 times that of England. Otherwise looks good, happy for it to go.

In 2022, Scotland had by far the highest volume of installed renewables capacity per capita of any part of the UK - more than double that of Wales, and more than four times that of England.

The only angle of challenge I can think of on this is the point raised a few times previously: that renewables sited in Scotland are therefore heavily subsidised by consumers across the rest of GB (because the subsidies for renewables are recovered from consumer bills at the GB level) – in case you want to prep for follow-up questions.

On Thursday 22 June at FMQs and in response to Labours proposals to headquarter a public energy company in Scotland the First Minister said the following:

“Of course the GB energy company would be based in Scotland because we have the majority of the renewables and the natural resources here in Scotland.”

Liam Kerr MSP raised a point of order asking:

“[FM] said ‘we [Scotland] have the majority of renewables here in Scotland.’ But in the year-end 2022, Scotland had 21% of total UK renewables installed capacity, and 26% of renewable electricity generated [so will he correct the record].”

Officials have also received an FOI asking: please provide any information held by the Scottish Government which substantiates the above statement.

We do not hold such information. Scotland (as of mid-2021) has around a quarter of the UK's renewable electricity capacity and generates a quarter of the UK's renewable electricity.

Following discussion with SpAds we recommend that the record is corrected to the following:

“Of course the GB energy company would be based in Scotland, Scotland has a majority of UK onshore wind generation and a quarter of the UK's renewable electricity capacity and generates a quarter of the UK's renewable electricity despite having less than a tenth of the UK population’ (2021 mid-year estimates indicate that 8% of the UK population was in Scotland).

If you are content with this approach we will take the appropriate steps to correct the record and respond to the FOI request that we have corrected the record for this statement.

We would be grateful for a swift response in order to action the FOI reply in good time.

I've discussed options with [Redacted] around natural resources and we came to the below conclusions:

My initial idea is a no goer. The more we looked at it, the more concerned we were that it could end up causing more problems down the line (in a similar manner to the offshore wind potential figure).

We can talk to the Natural Capital Accounts team in RESAS and see if they can get something together that could be used. This will include oil resources and I'm not sure if you want to include this. I don't know how quickly they could turn it around either.

If you want to focus on renewables alone, then that is trickier and I'm not sure it is even possible. Again, we can have a conversation with colleagues in RESAS to see whether anything can be done, but this is likely to be more work and so I anticipate that it will take longer.

Let me know if you want me to pursue either of the above Natural Capital Accounts options and what your views are on the inclusion of oil as a natural resource.

Doing a quick and dirty analysis of uncleaned data, I get a figure just shy of 35%. However, there is a considerable difference in the Scottish pipeline figure used in this calculation and our official pipeline figure, so it could be closer to 50%. On the flip side it could also be further away.

I'll discuss with my colleague when they are back in and see what we can do. This may come up again, so it would good to know how feasible it is to work out an equivalent UK figure.

So, I'm trying to reverse engineer the Scotland figures on the hub so that I know what is and isn't counted. Then hopefully it should just be the case of applying the same filters to get the rUK figures, although I am aware that there are quite a few duplicate records in the Renewable Energy Planning Database that will need to be removed.

At FMQs this afternoon, FM responded to questions from Anas Sarwar around proposals for energy transition. On Labour's proposals to headquarter a Public Energy in Scotland, FM said:

*“Of course a GB Renewables Company would be based in Scotland because we have the majority of the renewables and the natural resources here in Scotland.”*

Liam Kerr asked a Point of Order at the end:

*“[FM] said ‘we [Scotland] have the majority of renewables here in Scotland.’ But in the year-end 2022, Scotland had 21% of total UK renewables installed capacity, and 26% of renewable electricity generated [so will he correct the record].”*

Sorry, I'd do myself but we've a variety of issues we need to deal with this afternoon. Can I possibly ask you to dig out the relevant Scottish and wider UK figures mentioned above, please?

We can then consider a line if required – post-FMQ briefing is about to take place and suspect there will be a variety of requests for clarification and comment.
