We have been approached, as below, by the Scotsman (and subsequently the Daily Express) about a Twitter thread published by These Islands group accusing Ms Slater of "misleading Parliament" yesterday when answering a question on when Ministers first became aware of the accuracy of the statistic that Scotland has 25% of Europe's offshore wind potential.

At Topical Questions, Liam Kerr asked: "When did ministers first become aware that they were using a figure that, to quote Scottish Government officials, had not "been properly sourced"?

The Minister responded: "Ministers became aware of the issue on Tuesday 8 November ahead of the publication of the report by These Islands."

These Islands are claiming that email correspondence released under FOI around the use of a statistic in a speech Mr Wheelhouse was giving, show that Ministers were aware as early as 2020. Full Twitter thread: https://twitter.com/staylorish/status/1592617334715256832

The journalist has asked whether we stand by the claims that Ministers were first made aware of issues with this statistic on 8 November.

We have considered with policy leads and SpAds today and suggest the following response.

A Scottish Government spokesperson said:

"As Ms Slater said in the Chamber, Ministers became aware of the report by These Islands on 8 November. In relation to the Freedom of Information requests associated with this report, we recognise that there was correspondence between officials about the use of the statistic in late 2020, and we are now undertaking a further examination of our records, alongside work to provide an updated estimate.

"However, Scotland remains at the forefront of the developing offshore wind industry in Europe and ScotWind, the world's largest floating offshore leasing round, represents a massive step forward in delivering an energy revolution. The potential pipeline of offshore wind in Scotland – subject to planning and consenting decisions and finding a route to market – is over 40 Gigawatts. This is the equivalent to produce enough electricity to power every home in Scotland for 17 years, or every home in the UK for over a year and a half."

If any follow-ups from journalists with regard to our plans to update Parliament, we will refer journalists to the Official Record.

Relevant extract below:

At the time when they cited it, Scottish ministers understood that statistic to be accurate. Now that it has come to our attention that it is not, we are working to update the statistics on how our offshore wind potential compares with that of other countries. We will update the

Parliament once that is done and, at that point, we will consider how any legacy documents might need to be updated.

In the Twitter thread here, and in the FOI, it appears clear that former energy minister, Paul Wheelhouse, was aware of that fact given the statistic was discussed extensively when considering whether to use it in one of his speeches. Is the government suggesting that no-one within Mr Wheelhouse's ministerial or private office flagged this to him at the time and that this discussion happened without his knowledge?

Minister Slater specifically was asked about when ministers were aware they were using a figure that was "never properly sourced". The answer appears to be October 2020, not November 8, this year.

In the Twitter thread here, and in the FOI, it appears clear that former energy minister, Paul Wheelhouse, was aware of that fact given the statistic was discussed extensively when considering whether to use it in one of his speeches. Is the government suggesting that no-one within Mr Wheelhouse's ministerial or private office flagged this to him at the time and that this discussion happened without his knowledge?

The Scotsman, Times and Daily Mail have asked for a comment on the attached material gathered by the *These Islands* group, criticising the SG statistic – first set out in the <u>2010</u> offshore wind routemap – that "Scotland has an estimated 25% of Europe's offshore wind potential."

The attached points to more recent examples of the 25% being used. "With Scotland enjoying a quarter of Europe's wind potential." – is referenced in <u>NSET (p23)</u>.

The attached also contains Official-level comments, gathered under FOI, which suggest (to *These Island* and the journalist) that the 25% figure is outdated and the evidence base not strong enough to support the figure.

We've agreed the following response with Policy and SpAds. Grateful for Mr Matheson's clearance, please.

A Scottish Government Spokesperson said:

"Our abundant natural resources, expertise and proven track record in decarbonisation make Scotland perfectly placed to become a global powerhouse of renewable energy.

"ScotWind, the world's largest floating offshore leasing round, represents a massive step forward in delivering an energy revolution with ambitions to deliver 27.6 Gigawatts of power - nearly triple our renewable energy generation currently in operation.

"The statistic relating to Scotland having 25% of Europe's offshore wind potential was set out in a 2010 publication and was calculated accurately at the time. We recognise that changes in technology and use of marine space mean that this statistic now requires updating and will be undertaking work to update the figure. However, we are confident that Scotland remains at the forefront of the developing offshore wind industry in Europe."

As discussed, These Islands, a pro-union think-tank have given us sight of a new paper they are publishing tomorrow which debunks the claim Scotland has 25% of Europe's offshore wind energy potential.

The report is attached, but alongside the debunking of the claims themselves, I've got some additional questions around the internal communications on this question.

Specifically, these comments from officials:

"Whilst the 25% figure has been used in the past, we tend not to use this anymore. It has proved very difficult to source." (9th October 2020)

"the 25% estimate has never, to my knowledge, been properly sourced" (20th October 2020)

"Other than our recent exchanges on this request, of course, I've nothing to offer – my search of the G drive having unfortunately yielded up nothing more on the [redacted] study in 2001 and why it should have been associated with the "25%" estimate." (12th January 2021)

"Yes we did recycle those figures quite robotically without really checking them." (18th January 2021)"

Can you explain why, given the fact the figure has "never been properly sourced", it was repeated by senior Scottish Government politicians and published in papers such as the National Strategy for

Economic Transformation?

Has the Government been misleading the public on Scotland's offshore wind potential for decades?

Why are civil servants repeating figures, in official documents, which don't stand up to scrutiny?
