No, I'm afraid not – the changes in this Bill are really quite low impact compared to imposing a near-total ban on evictions (with exceptions for criminality, anti-social behaviour, domestic abuse) for at least 6 weeks of the year (with amendments to extend this expected during the passage of the Bill) which is what we're working up for Ministers at the moment and which SGLD are looking closely at in terms of competence and balance. It is also of much less impact than rent controls.
