Hello,

Thanks for this. Haulage would be via LGP tractor and trailer to a yard opposite Colnae. Dropped pin <https://goo.gl/maps/kYgumuRhMaTVT3g8A> From here it would be dispatched by HGV North to the A702 (approved). I will liaise with [REDACTED] well in advance to commencing works.

Spoken with Milnton house & cottage who welcome the felling works over the road. All other land is in hand with [REDACTED]

MB [*mixed broadleaves*] would be felled on the roadside on stability concerns post CF [*clear fell*] however stable trees out with the falling distance of thr roadside would be retained.
