During the last catch up call between Mr Yousaf, the Chief Constable and DCC [redacted] Mr Yousaf asked for an introductory meeting with the Chief Constable, and a debrief following the incident at Kenmure St to be put in the diary with any new Justice & Immigration ministers. The Chief Constable is keen that these focus on the strategic aspects of Kenmure Street, alongside their engagement with partners given operational matters have been well documented and commented upon.

In terms of GCC attending this first meeting Mr Brown is aware of your advice and will consider; likely to be tomorrow before confirming his views.
