## **REASONS FOR NOT PROVIDING INFORMATION**

#### An exemption applies

An exemption under **section 38(1)(b)** of FOISA (personal information) applies to some of the information requested because it is personal data of a third party, i.e. names and contact details of non-senior staff and disclosing it would contravene the data protection principles in data protection legislation. This exemption is not subject to the 'public interest test', so we are not required to consider if the public interest in disclosing the information outweighs the public interest in applying the exemption.

#### Exemptions apply, subject to the public interest test

An exemption under **section 30(c)** of FOISA (prejudice to effective conduct of public affairs) applies to some of the information requested. It is essential for the Scottish Government to be able to communicate, often in confidence, with external stakeholders on issues such as buffer zones. Disclosing the content of these discussions is likely to undermine their trust in the Scottish Government and will substantially inhibit communications on this type of issue in the future. These stakeholders will be reluctant to share their views fully and frankly if they believe that their views are likely to be made public, particularly where these discussions relate to a sensitive issue, such as buffer zones. This would significantly harm the Government's ability to carry out many aspects of its work, and could adversely affect its ability to gather all of the information it needs to make fully informed decisions.

This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of open, transparent and accountable government, and to inform public debate. However, there is a greater public interest in allowing officials a private space within which to communicate with appropriate external stakeholders as part of the process of exploring and refining the Government's position and appropriate options on issues relating to abortion buffer zones. This private space is essential so that decisions can be taken based on informed advice. Premature disclosure is likely to undermine the full and frank discussion of issues between the Scottish Government and these stakeholders, which in turn will undermine the quality of the policy making process, which would not be in the public interest.

An exemption under **section 36(1)** of FOISA (confidentiality in legal proceedings) applies to some of the information requested because it is legal advice and disclosure would breach legal professional privilege.

This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have

found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is some public interest in release as part of open and transparent government, and to inform public debate. However, this is outweighed by the strong public interest in maintaining the right to confidentiality of communications between legal advisers and clients, to ensure that Ministers and officials are able to receive legal advice in confidence, like any other public or private organisation.

Finally, an exemption under **section 29(1)(a)** of FOISA (policy development) applies to some of the information requested. This exemption applies because it relates to discussions about the development of Scottish Government policy on buffer zones. The exemption recognises the need for officials and Ministers to be able to consider fully the development of policy on an issue, such as buffer zones, before reaching a settled public position.

This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of open, transparent and accountable government, and to inform public debate. However, there is a greater public interest in allowing officials and Ministers a private space to consider the information and evidence available on matters of such importance before reaching a settled public position.

#### Dear Ms Sturgeon

I am writing to you in support of the Back Off Scotland campaign. As I'm sure you're aware, Back Off Scotland are campaigning for the Scottish Government to create 150m buffer zones around ALL clinics and hospitals that provide abortion services in Scotland. It's imperative that the government step in to protect our right to harassment-free access to essential medical services, particularly in light of the recent events in the United States.

**[text redacted]**, I grew up watching these fringe groups hassling women coming in and out of clinics and hospitals. **[text redacted]**. I know how frightening and angering it is. I have watched as abortion clinics across the US have closed and practitioners have murdered

because the government stood by and did nothing - this effectually gives some individuals the idea that what they are doing is government sanctioned and therefore, totally appropriate.

Does the Scottish Government think that this behaviour is appropriate? Does it sanction the harassment of women? It certainly appears that it does from my, and my friends' and acquaintances' points of view. We are voters, and WE ARE LIVID. We have had enough of all of this violence against women. We are murdered, harassed, and humiliated. When it will it stop? Condemning it in speeches is simply not enough.

This letter comes at the time of anti-choice protests returning to various sexual health clinics around the UK, including Scotland. In 2021, a Humanist Society Scotland survey showed that 82% of Scots believe that buffer zones should be created. But unfortunately the Scottish Government disagree and describe a ban as a 'disproportionate' response. Across the UK, 49 hospitals, GP surgeries, and clinics have had protests outside their gates. 7 of the NHS premises targeted are in Scotland. And in 2019, over 100,000 women went to clinics that anti-choice demonstrations targeted last year. This is absolutely disgusting behaviour and has nothing to do with freedom of speech - it is flat out intimidation, and a ban is certainly not disproportionate. The Scottish Government's reticence to instate buffer zones is a sign that it does support a woman's right to choose, and I am absolutely infuriated by its lack of response to this threat. These 'protests' are nothing but thinly veiled attacks on women's privacy and meant to control and monitor our behaviour in order to keep us 'in line' with outdated, religious, and patriarchal ideals.

Is this how the Scottish Government views women? I have always admired you and your leadership, but the inactivity around this very sensible and fair approach needs to stop. I cannot see how this would set any sort of negative precedent for other types of protests and do not understand why nothing has been done.

As a result of Covid-19, some people having abortions are having to attend appointments alone – meaning they may not have the support they need to cope with this type of presence. Some women have no support at all, and they have every right to attend these appointments without outside influence or harassment.

The type of activity differs across the country, and they're organised by many different groups. There are people who stand outside hospitals with graphic posters and signs, people who approach service users and passers-by and give out false messages about abortion care and vaccines, people who shout at patients and intimidate them, telling people who have had abortions that they will get cancer.

The clinics and hospitals targeted do not exclusively offer services related to abortion, therefore any anti-choice activity is not targeted exclusively at people seeking this element of healthcare. Such clinics often offer services to victims of sexual assault, services regarding menopause and premenstrual syndrome and gay men's clinics to name just a selection. These visitors may prefer to remain anonymous or may be vulnerable to approaches from anti-choice individuals. The presence of anti-choice activity at such close proximity to the entrance of the medical facility therefore risks preventing a range of people from accessing vital healthcare. For visitors with mental health issues, learning difficulties and past trauma, it can already be difficult to access this type of healthcare, even without physical barriers, and missing appointments can be severely detrimental to their long-term health and wellbeing.

Buffer zones would put a stop to this harassment – moving anti-choice activity away from the clinic and hospital gates and allowing people to access care free from harassment, alarm, and

distress. Anti-choice groups would still be able to protest outside Holyrood, on the High Street, on the internet – but wouldn't be able to target individual patients who are trying to access legal, essential services.

Why does the Scottish Government feel the need to allow these groups to protest at medical facilities that are KNOWN to have vulnerable individuals entering and exiting?

Buffer zones like this are already in place in three English councils, and have been upheld by two separate courts. In Ealing in London, a persistent protest over many years led to an atmosphere of tension, intimidation, harassment, and distress – not just for abortion patients but for people living in the local area too. The council told the court that some of the past users of the clinic were still 'significantly affected by their encounters with the activists' many years on. Judges in the High Court and Court of Appeal in London ruled that a buffer zone was necessary to protect the rights of service users to access care confidentially and without fear of harassment, while only requiring the protesters to move a few hundred metres down the road.

Across Scotland (and the UK), this type of activity continues unchecked. Existing laws are not enough to put a stop to this activity and the police do not have the powers they need to take action. Anti-choice individuals take advantage of the insufficiency and incompleteness of the existing law to impinge on a person's access to care.

That is why I am asking you to support the introduction of a new legal provision, based on laws already in place in Canada, Australia, and the Isle of Man, to move these protesters away from the hospital entrance. Not to stop protest, but to tell them that harassing people trying to access healthcare is not acceptable.

This change in law is supported by the Royal College of Obstetricians and Gynaecologists, the Royal College of Midwives, the British Medical Association, the British Pregnancy Advisory Service, Scottish Humanists, and Scottish Women's Aid.

We would ask for your support and hope to protect anyone seeking vital medical services from harassment and allow patients the anonymity and privacy they deserve.

Protecting abortion healthcare in Scotland

The Scottish Government has been repeatedly asked to take urgent action to protect access to safe and legal abortion in Scotland. I am sorry to say that the failure of Scottish ministers to take swift and decisive action has led to an increase in protests aimed at women and people accessing abortion healthcare.

By refusing to introduce protest-free buffer zones around abortion healthcare facilities, Scottish Ministers have emboldened anti-abortion campaigners. In recent weeks, this has culminated in an organisation that self-describes as 'the world's largest grassroots movement to end abortion' celebrating a 'great campaign' in Glasgow, which at its peak saw 103 anti-abortion protestors assembled outside the Queen Elizabeth University Hospital.

Enough is enough.

Legislating for protest-free buffer zones at abortion healthcare facilities It is no surprise that these upsetting events have prompted clinicians and pro-choice campaigners to question the Scottish Government's lack of action. The Back Off Scotland campaign group has called for your resignation and 76 doctors have signed an open letter to you, putting the weight of their clinical expertise behind this vital public health campaign.

It is time to break your silence and make a clear commitment to introduce legislation for buffer zones at abortion healthcare facilities. After all, this was a promise made in the SNP's manifesto and the Scottish Government's Programme for Government. A timescale is now needed.

Abortion is a basic healthcare need and is fundamentally linked to protecting and upholding the rights of women, girls and others who can become pregnant. It continues to be a hotly contested issue globally, resulting in barriers to safe, free and legal abortion. Under your watch, Scotland is now seen as an easy target by those who wish to end abortion.

The escalation of co-ordinated protests near clinics provides clear evidence that access to abortion healthcare is under attack in Scotland. Please confirm that the Scottish Government will keep its promises and outline when national legislation will be introduced?

#### GLASGOW QUEEN ELIZABETH UNIVERSITY HOSPITAL

I write regarding an upsetting and distressing scene outside the maternity unit at Glasgow's Queen Elizabeth University Hospital on Sunday 10<sup>th</sup> April 2022.

Around 100 chanting anti-abortion protestors stood outside the entrance to the hospital grounds in full sight of all those walking or driving to the hospital. These protesters carried a range of posters and anti-abortion placards which contained slogans and images calculated to embarrass, harass and distress those attending and using hospital maternity services and of course the staff who provide these essential services.

As we all know, service users will access maternity services for a multitude of reasons including accessing an abortion, the birth of a child, support and medical care following a stillbirth, ectopic pregnancy or miscarriage. To have patients accosted, shamed, shouted at, intimidated or embarrassed while accessing medical care is wholly unacceptable and could result in some patients avoiding clinically urgent or important appointments for fear of being harangued in this manner at their greatest time of need, to fail to take urgent steps to bring about exclusion or buffer zones outside these facilities will serve only to further harm service users and cause

increased angst and stress for those working to provide care and support to these patients.

I am aware of several approaches made to your government and your ministers from the organisation, Back Off Scotland. We are perpetually holding ourselves out as a country which is open, welcoming and progressive, yet a country which permits patients, often at the most vulnerable times of their lives, to be intimidated, embarrassed and shamed outside the very medical facilities from which they seek care and support.

I would implore you to make urgent representations to your minister with the intention of creating an exclusion or buffer zone of 150m around our hospitals and clinics which provide abortion services. I am entirely confident that Back Off Scotland would take the opportunity to work with you and your ministers and those of us in the civic sector who believe abortion services should be accessible, free of charge and safe to access.

I do of course fully support the aims and objectives of Back Off Scotland and join their call for the above. Let's take this opportunity to build on the creation of a stronger, safer and healthier Scotland. In the interests of transparency, I have posted a copy of this letter online.

The Scottish Government have been exceptionally slow off the mark to address the intimidating protests outside abortion clinics where women are seeking sensitive care, with the scenes in Glasgow suggesting that protests have now reached a new intensity.

This is bad enough and has been discussed widely in the media but there was also a protest today by two individuals the Sandyford sexual health clinic. This clinic covers a large selection of services including the assessment, treatment and counselling of rape and sexual assault survivors. **[redacted]**, the only place in the area, and would be disgusted to think they would be intimidated and traumatised again by dangerously naive protestors. It would appear that police in attendance were under the impression they did not have the power to disperse the protester who were shouting into the building, something which I know many professionals would consider breach of the peace. This noise and disruption caused today left a number of vulnerable patients in tears, damaging the health of patients and meant that services were disrupted as rooms facing the protesters were unsuitable for consultations.

I would ask that you, **[redacted]** support measures to control this infringement of the right to safe access to healthcare. This in includes rules on buffer zones but could also include better guidance for police as to when a protest like this is breaching the rights of others to allow them to respond more positively with confidence.

#### Ministerial Working Group – Abortion Buffer Zones

I am deeply troubled that the Scottish Government Ministerial Working Group is considering using statutory powers to 'restrict gatherings' in the context of peaceful, prayer vigils near abortion facilities (Ministerial Working Group – Abortion Buffer Zones minutes: 9 December 2021)

The peaceful vigils, often involving members of Scotland's 700,000 strong Catholic community, provide practical and emotional support to women who may wish to exercise their right to choose an alternative to abortion. This includes support and advice about pregnancy, benefits and housing advice, the provision of food, baby equipment, accommodation, and support with existing children. Denying vulnerable women experiencing an unexpected pregnancy the choice of crucial support would be reckless and deeply inconsiderate. It is a tragedy that women in the most deprived areas of Scotland continue to have abortion rates twice as high as those from wealthier areas.

A crucial point that must not be overlooked is many years of reliable and credible evidence from Police Scotland and NHS Boards who have repeatedly said there is no evidence of harassment or intimidation by vigil attendees outside abortion services in Scotland. A nationwide ban seems out of proportion to the scale and severity of the situation.

Another aspect of this also troubles me. Whereas freedom of assembly, freedom of religion and religious expression and free speech are all deeply held values in Scotland and elsewhere, what impact would such a ban as you propose have on these values? It would seem that enormous free gatherings protesting against climate change, climate justice, demonstrations against the possession and use of nuclear weapons and a plethora of other causes, are not only tolerated – but also even encouraged – whereas a small, prayerful, peaceful group of conscientious, and often religious citizens would be prevented from freedom of association and freedom of assembly. Not all Scottish citizens accept in conscience the practice and law of Scotland since 1967 on abortion. Why can they not peacefully offer their prayers and charity for those pregnant women who request it?

If there are concerns about prayer vigils these ought to be addressed through dialogue and a genuine desire to reach a reasonable solution which meets the needs of all parties, not the criminalisation of peaceful, law-abiding people and prayer.

Dear Maree,

My name is **[redacted]** and I am one of the founders of Back Off Scotland – a small, student-run grassroots campaign that wants to see the implementation of harassment-free 'buffer zones' around clinics and hospitals providing abortion services in Scotland.

In April, this email popped into my inbox:

"I am haunted by an image from a poster, held by one of the protesters I spotted as I left Edinburgh Royal Infirmary. 2 weeks earlier, at my 20-weekscan, we had had a diagnosis that our much longed for baby had a condition that was 'incompatible with life', meaning we had a very difficult choice to make. The most humane thing for us was to have a termination for medical reasons, which meant ending the pregnancy, delivering the baby and saying goodbye. Outside the hospital as I left, at a required distance but still very visible to all passing them, was 40 days for life protest holding signs and posters. I was in my car stuck at the traffic lights, sobbing, and there were placard and images that I can't forget even now making me feel so much worse about the termination I'd just gone through, and undoing all the good work the health professionals had done to support me with dignity and care. Weeks later that image starred front and central in my flashbacks and I needed to rely on health professionals to get access to counselling and prescriptions to help bring me back."

No one should have to go through what this woman went through, and it's almost unimaginable to think that this happened in Scotland last year. But it did, and it still continues to happen every day across the country.

I receive hundreds of emails like this every month from women who share their story with me about the trauma they have endured because of harassment by these antiabortion groups outside clinics and hospitals.

The levels of harm these groups are causing are untold, and we need to put a stop to this activity taking place at the doors of hospitals. This is why Back Off Scotland, along with the British Pregnancy Advisory Service (BPAS) and 38 other women's rights organisations are supporting Gillian Mackay as her buffer zone bill makes its way through the Scottish Parliament.

I'm really keen to meet with you to discuss the campaign further, tell you about the experiences of women who have been traumatised by these anti-choice groups, and answer any questions that you may have about Gillian's Bill or the campaign. #### Dear Maree,

We write in relation to the recent campaign of harassment of women accessing abortion services in Scotland as part of a coordinated religious campaign. I am sure you will be aware of the specific protests outside the Queen Elizabeth Hospital in Glasgow where over a hundred individuals coordinated attempts to intimidate patients and staff on the basis of their worldview that other individuals should be barred from having the choice of safe, legal and regulated abortion services.

These regular attempts to block women and girls from timely access to abortion services, which are legal and a necessary healthcare provision, cannot be allowed to continue. We raised this issue in our manifesto shared with political parties ahead of the 2021 Scottish Parliament election. We welcomed the statement made in the Scottish National Party's manifesto that: *"We are clear that those accessing abortion*"

services should not be targeted for choosing to access this right."

We note the Scottish Government's Women's Health Action Plan, published August 2021, which said on this matter: "NHS, Local Authorities, Justice agencies and Scottish Government to work together to find ways of preventing women feeling harassed when accessing abortion care due to protests or vigils."

However we are dismayed that almost a year has progressed since the 2021 election and no timely action has been taken to stop harassment of women and girls accessing legal health services. We echo the sentiments of the 76 consultants who released a joint statement this month calling for urgent action now.

We have read with interest the December minutes of the Ministerial Working Group on this issue. However the minutes reveal the group would appear to be focussed on longer term actions involving more research etc. While this may be appropriate to do, lack of immediate action alongside this will result in continued negative outcomes for individuals accessing healthcare provision, as is their right.

We implore you to take urgent action now, alongside your ministerial colleagues, to end the harassment of women and girls accessing healthcare services as well as healthcare workers. This important issue cannot be left to a working group to consider for any more years.
