Ukraine Response: Utilising Passenger Ships for Welcome Accommodation

Scotland is continuing to see a rise in Ukrainian displaced persons entering the country. Current estimates of upcoming arrivals suggest a minimum of 110 'super sponsor' arrivals per day and a need for between 1500-2350 rooms over the next 4 weeks.

The challenge to ensure appropriate accommodation is available for new arrivals is great and becoming harder as we move fully into the summer period. There is a real risk that at very short notice we could run out of accommodation options available across Scotland and have to utilise emergency accommodation, such as camp beds at the Edinburgh Hub.

To reduce the risk of using emergency accommodation, and to secure a sizable portion of the rooms needed over the next few weeks, one option being actively pursued, subject to Ministerial approval, is to utilise passenger ships.

Berthing a passenger ship at Leith is an option being considered. This would see the M/S Victoria (739 cabins) used to accommodate Ukrainian arrivals. The M/S Victoria could be mobilised at short notice (it has a 5 day lead time) and be available for use w/c Monday 11 July.

The ship offers a similar standard of room accommodation to current welcome accommodations and all of the services a hotel offers (food, housekeeping, child's play area, functioning shop etc.). As with hotels, there are a range of cabins from suites to single use.

The passenger ship would operate with a full crew and with a 24-hour manned reception desk, enabling displaced persons to come and go as they please. Additional external security would also be provided and utilising third sector partners to mobilise both paid staff and volunteers to work on the passenger ships is also being explored.

As with welcome accommodations, the Scottish Government would cover the full costs of utilising the passenger ships and any reasonable costs incurred by City of Edinburgh Council for providing welcome support to meet the safeguarding and wellbeing needs of displaced persons.


