

The Turnaround Directors August report confirmed these numbers and his subsequent June 2021 report maintains these costs. This means £193-197m will be paid for the vessels against a revised contract price of £98.5m.

It brings the total COVID-19 costs to £4.3 million, which is treated as an exceptional item and does not affect the overall project budget. The overall project budget remains stable and unchanged at £110.3 million to £114.3 million.

Recruitment challenges since late 2020 have caused a delay of eight weeks as the shortage of local skilled labour meant that Ferguson's had to meet resource requirements by subcontracting smaller fabrications to Scottish businesses, which has supported 25 jobs, and introducing overseas workers.

The report also outlines achievements and progress to date, including a major milestone in the build of MV Glen Sannox with the completion of structural work.

Progress is visible with the installation of a reworked funnel and newly constructed mast, as well as completion of the structure around the stern and inside the hull. Remedial work has been completed on hull paintwork and the first layers of protective paint have been applied to the aluminum superstructure. Completion of the structure makes way for outfitting of the vessel, which includes the installation of 10km of pipework and extensive equipment, plus the creation of public spaces and cabins and full furnishing.

Despite the challenges and delays, shipyard management remains positive based on improved capability built over the past 18 months, including a highly qualified and capable leadership team in place. The senior management team now has 130 years of combined shipbuilding experience, with other new expert appointments and existing high-calibre employees promoted into key positions.

4.5.1 Summary of Unions Call

You met with Trade Union representatives on 20 July 2021. A summary of the discussions can be found below.

Introductions

- Ms Forbes welcomed the opportunity to meet and work in partnership with the unions. She stressed the importance of the Ferguson Marine workforce locally and nationally. The vessels under construction are of national importance and are critical to the areas they will serve.
- She is mindful of the uncertainty the workforce have had to deal with and is keen to work closely with them to get a feel for what is happening on the ground at the yard. She is aware of the GMBs "Fight for Ferguson" campaign and would like to work more closely to on this.

Future

- Ms Forbes stated the priority for the yard is to finish the two vessels currently under construction. Whilst the construction continues, work around improving productivity will carry on while the yard explores future contracts in public and private sectors.
- The yard needs to be able to compete on a Domestic, European and Global scale. This means the yard must demonstrate its competitiveness to secure a long term future that is able to supply a pipeline of work. Ms Forbes wants to work with the yard and unions to get to a place where this can happen. She asked the call what more do they think needs to be done to help.
- Union colleagues appreciated what has been said so far and welcomed the offer
 of further regular meetings. They praised the "fantastic" workforce at the yard, who
 have had to work through a difficult period with COVID-19. It was acknowledged
 that the organisation on the ground within the yard could be better.
- [redacted] called for a pipeline of future work for the yard and for future contracts
 to have a form of standardisation in types of vessels the yard will bid on and build.
 Building to different specifications has potentially caused delays and cost overruns.
 He also recommended collaborating with local yards to agree "through life"
 packages where local yards can be used for maintenance instead of those further
 afield.
- Ms Forbes was aware of the importance that the yard has to the success of the local economy as a large employer and was keen to see a pipeline of apprenticeships. She agrees that improved levels of morale is linked to higher productivity and wanted to inspire the workforce to realise how important they are. A workforce with continued low morale could result in further delays. The yard management is currently investigating options to accelerate the delivery of the vessels.

Working Practices

- [redacted] attributed the low morale to not being able to settle the recent 2021/2022 pay award and the ever changing senior management team.
 [redacted] was of the view that the senior management team is trying to replicate structures and ways of working in place at BAE systems, which in his view is incompatible. Commercial Shipbuilding on the scale at which Ferguson Marine operates needs to be "lean and mean" to compete.
- [redacted] and [redacted] echoed [redacted] comments in regard to high numbers of managers/supervisors and low morale. They believe it is partly down to the lack of work at the moment, which means colleagues are idle for long periods per shift. The recent negative media stories in relation to the previous owners and the future of the yard has the workforce anxious about their jobs.
- [redacted] attributes some of the workflow issues to the large numbers of contractors involved at the yard. He also said the planning systems in place from management weren't working and this has been raised at board meetings for 6-7 months. The senior management response was that further planning managers are being recruited.
- The practice of having a weekend shift instead of night shift was implemented without any negotiations with the unions. There was discussion that nightshift can work better due to the handover of work process from morning to night and vice versa.
- [redacted] highlighted his concerns in relation to the contractor design work, which in his view isn't fit for purpose. Some of the structure they are being asked to fit are heavy and will impact the final weight of the vessels.

Closing Remarks

- Ms Forbes is keen to visit the yard soon and help fix the issues that have been raised on the call today. She was also keen to set up regular meetings to find out what is happening on the ground and the progress being made.
- Ms Forbes reiterated the need for an improvement in productivity and competitiveness at the yard. She asked those on the call to take back the message that she has heard their concerns and she will act on them as far as she can.

Completion of the structure makes way for outfitting of the vessel, which includes the installation of 10km of pipework and extensive equipment, plus the creation of public spaces and cabins and full furnishing.

Despite the challenges and delays, shipyard management remains positive based on improved capability built over the past 18 months, including a highly qualified and capable leadership team in place. The senior management team now has 130 years of combined shipbuilding experience, with other new expert appointments and existing high-calibre employees promoted into key positions.

On 6 August 2021 officials provided a further update to Ministers on progress to deliver vessels 801 and 802. The Cabinet Secretary will receive such updates on a regular basis.

4.8 Options to Accelerate Delivery of 801/802

You requested that officials investigate all potential options to accelerate the delivery of vessels 801 and 802. The latest position on the progress of consideration and implementation of the possible options is listed below.

A number of the options are already in the process of implementation. These are:

- Bring 5 ICE engineers to the shipyard and use local ICE team to be the interface with ICE Romania (discussions underway with ICE).
- Recruit additional project engineering support to manage the remaining engineering work scope (underway).
- Increase outfitting at the unit stage before assembly on to the ship (opportunities under investigation).
- Manage the customer's representative (CMAL) such that they are approving presented work rather than policing partly completed work (Fergusons and CMAL agreeing terms of joint working).

- Change relationship with CMAL to make review and feedback more structured and efficient (Fergusons and CMAL agreeing terms of joint working).
- Additional Maritime and Coastguard Agency and Lloyds Register representatives to accelerate approvals and acceptance, to be based full time at yard (discussions commencing shortly).
- Increase overseas workers to resource fabrication 24/7 (to be implemented when appropriate planning in place to maximise value).

These options were in addition to a number of more minor changes to working practices, which didn't make the options list, but were instead implemented immediately as opportunities for improvement, which the yard routinely acts on when identified.

Additional to the options presented to you, further capability improvements have since been made in project management and planning to ensure more efficient operations, and support detailed management of work packages and control of materials.

These options progress alongside ongoing improvements targeting the smooth build out of the ferries, identified in the Turnaround Director's June 2021 report to Parliament on the revised delivery schedule.

Consideration of one residual option is ongoing. This is the option to delay the commissioning of the vessels' LNG systems to allow an earlier entry into service, but requiring a withdrawal from service at a later date to allow for the system to be commissioned.

A meeting between SIAD, TS and CMAL colleagues took place on 21 July as planned. [redacted]

4.9 Future Work

Direct Award [NOT IN THE PUBLIC DOMAIN]

Officials are exploring the potential for the direct award of SG-funded vessels to Ferguson Marine. While direct award could provide a pipeline of work for the yard, this is a complex issue with legal, procurement and policy implications.

Procurement and the Teckal exemption

Whilst procurement law generally requires contracts to be subject to open competition, direct award is permitted in certain narrow circumstances, including under the socalled Teckal exemption. Teckal allows a public body to directly award a contract to an entity over which it has control, or for award between two entities which are controlled to a similar degree by a parent body.

Competition Rules and Value For Money

It is also necessary to consider competition law as the direct award of contracts has the potential to distort the market, in particular by providing overcompensation to the recipient. Our understanding is that direct award would have been compatible under EU State Aid rules provided that Teckal compatibility was met and a robust

benchmarking exercise undertaken. As the transition from EU State aid to a UK subsidy control system has not yet concluded, we do not know what adequate benchmarking looks like in practice and what guarantees it might offer against legal challenge from other yards or jurisdictions [redacted]

In all direct award scenarios, we anticipate a benchmarking exercise to be a key part of the process. Benchmarking is intended to ensure that a contract is priced competitively, even where it has not been competitively tendered, and that a yard can deliver efficiently and effectively in comparison to its competitors. This is to ensure there is no overcompensation to the recipient that would have the potential to distort the market. It would also seek to provide assurance that any contract award would satisfy public finance value-for-money and accountability requirements, and ensure the contract can withstand any scrutiny in the Scottish Parliament and from Audit Scotland.

Ferguson Marine recently commissioned a broad benchmarking exercise to assess their productivity against competitors and identify areas for improvement. [redacted]

General Update

- Tim explained how there has been positive progress in the yard since the last time he spoke with Ms Forbes and momentum is still building as time progresses.
- Some significant developments are in relation to the new inventory management system and the hiring of a new head of planning (started 26 July), who has a lot of experience.
- There is also rapidly improving planning systems in place, with better KPIs and progress monitoring systems. More overseas workers are due to start when planning systems develop further.

STATE AID ACCUSATIONS RELATING TO SG INTERVENTIONS

8 May, Herald: Concerns raised that Ministers failed to notify the European Union about any of its interventions in companies connected to Scotland's ferry building fiasco. EU Commission not notified of either its involvement in supporting Caledonian Maritime Assets Limited (CMAL) or Ferguson Marine. This revelation sparks concerns that Ministers have been involved in unlawful state aid – having previously been found guilty of illegal interventions involving Scottish airports.

6 Feb, Herald: Reported suggestion that the SG will not recoup £50m in loans and interest given to Prestwick Airport, raising concerns that the SG has "sanctioned unlawful state aid".

Detailed Herald accusations (8 May):

- 1. SG did not contact EU about state aid when it provided a £106m special incentive to ensure the contract went to Fergusons after yard unable to offer guarantee. SG was favouring one yard by acting as guarantor with a crippling cost to the taxpayer.
 - Edward Mountain MSP said: "The SNP's decision to waive the **Builders Refund Guarantee** has proved extremely costly to the Scottish taxpayer.
 - "Around £80m has been lost from this decision alone and now there are big questions as to whether this arrangement met state aid rules.
 - "Would this special incentive have been offered to the other bidders for the ferry contracts? If not, it would then appear that there was not a level playing field in the tendering process.
- 2. EU sources confirmed there was no notification of any intervention with Ferguson Marine, either about the award of £45m loans or the nationalisation.
 - Ministers claim loans were to provide "working capital and diversify the business" but SG internal documents show the real reason was to stave off administration.
- 3. The **Competition and Markets Authority** has previously expressed concern about the "potential risks" of state control over the way ferries are operated, run and paid for.

Background

The Scottish Public Finance Manual sets out the considerations and decision-making process undertaken by Ministers when considering investing public funds.

Media query

Seeking SG response to a couple of stories.

Concerns surface after it emerged that SG failed to notify the European Union about any of its interventions in companies connected to Scotland's ferry building fiasco. Been confirmed that EU was not notified of either its involvement in supporting Caledonian Maritime Assets Limited (CMAL), the Scottish Government-controlled firm that owns and procures CalMac's ferries or shipbuilding firm Ferguson Marine. The development has prompted new concerns that ministers have been involved in unlawful state aid - having previously been found guilty of illegal interventions involving Scottish airports.

It has been confirmed that ministers did not contact the EU about potential state aid when it stepped in to provide a £106m special incentive to ensure that a ferry contract went to Jim McColl-led Ferguson Marine three years previously - after it was unable to provide the guarantees.

It resulted in taxpayers losing £80m when Ferguson Marine went into administration, as CMAL says the loans were eliminated. The ferry owners would have expected to have been paid off over 25 years by CMAL using revenue from the lease of vessels like the

ferry fleet of state-controlled ferry operator CalMac and harbour access charges. In the seven years since the contract was awarded, the Ferguson's yard has been nationalised by the Scottish Government after it fell into administration while the estimated delivery of two lifeline vessels has been pushed back by at least five years, along with an increase in costs to at least £250 million.

EU sources have also confirmed that there was no notification of any intervention with Ferguson Marine, either about the award of £45m loans or its state intervention in nationalising the Inverciyde shipyard firm.

Under EU rules, member-state governments are required to notify the European Commission – which is in charge of treaty compliance – about proposed state aid moves.

The intent of state aid rules is to avoid financial assistance given by a government that favours a certain company or commercial group and has the potential to distort market competition.

Highlands and Islands MSP Edward Mountain, the former convenor of the rural economy and connectivity committee which branded the procurement of the two new ferries a "catastrophic failure" called for a public inquiry, saying there were "big questions" over whether ministers were complying with state aid rules, adding that he was "not surprised the SNP government continues to face allegations of corruption". The ministerial deal was set up to ensure the contract for two ferries was given to Ferguson Marine to reassure the ship owners who had "severe misgivings" over the yard's inability to provide financial guarantees were not out of pocket if anything went wrong.

It came with a crucial pledge that they would not have to repay anything until after the vessels had been delivered.

And they promised other public funding to cover other performance risks to ensure it did not lose out and further money to meet any debts to ensure CMAL remained in existence.

It has been suggested that the financial support flouted EU Market Economy Operator Principle rules and is unlawful state aid - as the Scottish Government was favouring one yard by acting as guarantor - with a crippling cost to the taxpayer.

Before ministers stepped in in October, 2015, CMAL chairman Erik Østergaard told ministers that the best option was to "bin" Ferguson Marine - which had been chosen as the preferred bidder - and start the tender process from scratch on the basis of its initial contract requirements, which was to have full builders' refund guarantees.

Some procurement experts have told the Herald on Sunday that the failure to go through the process again left CMAL open to legal action from those who had sought the contract but lost out to Ferguson Marine.

An internal Scottish Government memo sent to Mr Mackay, who was then transport minister warned: "In addition to the financial risks, absence of a full refund guarantee in the final contract represent a considerable departure from the advertised contract terms and may rise significant procurement risks.

"In the case of a challenge, CMAL would robustly defend their position on the basis of the legal advice they have received and the steps they have taken to bring the final contract clauses into broad comparability with the tender specification."

Before Ferguson Marine's collapse and the subsequent state takeover, ministers issued two commercial loans worth £45m to the shipyard firm.

Just last month, finance secretary Kate Forbes was still insisting that the £45m, delivered in two tranches in 2017 and 2018 was put up to "support the business with working capital and business diversification".

Then finance secretary Derek Mackay used a similar line when telling the public about the 2018 £30m loan that it was "to further diversify their business".

But internal documents have shown that the real reason was that Ferguson's was in

financial trouble and at risk of falling into administration.

A confidential memo about the "urgent" loan from Mary McAllan, director of economic development, to Mr Mackay said that Ferguson Marine required the funding "immediately if severe cost-cutting measures and further significant delays to the CMAL order are to be avoided".

Without access to the further finance Ferguson Marine's next planned step was to issue redundancy notices to the bulk of the core staff at the yard – around 230 from a total headcount of 280, she said. Administration was "a real risk".

Her memo reveals the £30m due to be paid back in ten years came with it a "right to buy" if the company fell into insolvency.

The EU has refused to comment on the Ferguson Marine and CMAL case, but confirmed the Commission remains the competent authority for any state aid granted prior to the end of the transition period on December 31, 2020.

If a state aid investigation was launched and found proven, the commission could ultimately demand the recovery of money.

The Competition and Markets Authority has previously expressed concern about the "potential risks" of state control over the way ferries are operated, run and paid for. Edward Mountain MSP said: "The SNP's decision to waive the Builders Refund Guarantee has proved extremely costly to the Scottish taxpayer.

"Around £80m has been lost from this decision alone and now there are big questions as to whether this arrangement met state aid rules.

"Would this special incentive have been offered to the other bidders for the ferry contracts? If not, it would then appear that there was not a level playing field in the tendering process.

"The questions continue to mount up and I am not surprised that this SNP Government continues to face allegations of corruption.

"We've had two damning reports about the SNP's ferry failures, one from the REC Committee and one from Audit Scotland. However, to uncover the full extent of this ongoing scandal we now need a full public inquiry."

Priority

2. Routine.

Background

- 3. In 2020-21 and 2021-22, retail, hospitality and leisure (RHL) relief did not amount to state aid/subsidy, in Scotland or England. This meant there was no cap on the relief offered, nor did the relief contribute to any threshold of total support received (e.g. minimal financial assistance of 325,000 special drawing rights (approximately £335,000) over three fiscal years established by the EU-UK Trade and Cooperation Agreement).
- 4. In 2021-22, although the UK Government introduced cash caps for their RHL relief, their published guidance to local authorities did not mention subsidy control regime constraints. Officials later confirmed that the relief was not capped by the minimum financial assistance (325,000 special drawing rights over three fiscal years), or by any other temporary framework cap.
- The position in Scotland in 2021-22 was also that the RHL relief should not be a capped subsidy. The Scottish Government published its annual non-statutory NDR relief guidance to that effect.
- 6. The fact that there was consistency in the state aid/subsidy approaches across the UK for 2020-21 and 2021-22, meant that the approach was less at risk of challenge. **[redacted]**
