The new figures show nearly 60,000 pupils attend schools rated to be in a 'poor' or 'bad' condition – over 8% of all pupils.

Scottish Labour has warned that these figures may be masking the true scale of the problem by not taking account of whether schools are fit for purpose in terms of Covid safety.

Commenting, Scottish Labour's Education spokesperson Michael Marra said:

## Query

Good morning. I spoke to a man this morning whose wife waited 20 hours for an ambulance and then spent a further three hours in the back of an ambulance on Tuesday morning to wait to get inside the hospital. Sheila Anderson of Flat 3/3 704 Dumbarton Road, Thornwood, Glasgow, G11-6RB first called for an ambulance at 1.20pm on Monday.

She did so on the instruction of medical staff at the Golden Jubilee Hospital from where she had been discharged two days previously after having a hip replacement operation. She had called them

Medical staff thought she was having a severe reaction to a nerve blocking injection and said she should dial 999.

The family were told there was a large volume of calls and she may have to wait a while but they did not expect that long a wait.

And her husband, George, was upset when he called back at 6am to be told very abruptly: "Unless her condition has changed don't call back, This is an emergency service."

The ambulance arrived at 9.20am on Tuesday and she was transported to the QEUH where she spent more than three hours waiting in the back of the ambulance. George says the current triage system is not working because symptoms can be interpreted in different ways depending on which administrator is spoken to. Looking for a Scottish Government comment.

# Ambulance waiting times unacceptable, Sturgeon admits

Nicola Sturgeon has admitted that wait times for ambulances are "not good enough", with patients now waiting an average of six hours.

Challenged by Scottish Conservative leader Douglas Ross over deteriorating response times for the emergency service, the First Minister argued that problems had been "significantly exacerbated" by the coronavirus pandemic.

Speaking at First Minister's Questions, Ms Sturgeon acknowledged that the long waits being reported were "not acceptable" and insisted the Scottish Government were working with the Scottish Ambulance Service to improve the situation.

"We know the pressure the ambulance service is under right now because of many of the other pressures in our National Health Service that have been caused and indeed exacerbated in some respects by the pandemic," she said.

"While any individual wait is unacceptable – and we need to work to resolve that – it is worth bearing in mind that, despite all of the challenges and despite our ambulance service serving some of the most rural areas in the UK, over 2020-2021 our crews responded to over 70% of the highest priority calls in under 10 minutes and over 99% in under 30 minutes."

Douglas Ross argued that problems "started long before Covid-19", citing Scottish Ambulance Service surveys from 2018 and 2019 suggesting a fifth of the workforce believed there were not enough staff.

"Just yesterday, the Unite convener of the Scottish Ambulance Service said serious adverse events have been on an upward trajectory; since the start of the year they have gone through the roof," Mr Ross said.

Ms Sturgeon replied: "There were pressures before Covid but I don't think anybody can or should deny that those pressures have been significantly exacerbated by Covid."

Quoting the figures for the week ending September 5, Ms Sturgeon said ambulance crews responded to 10,435 emergencies and the response time for immediately life-threatening incidents was nine minutes and 30 seconds, describing it as "not good enough".

Emergencies in the "amber" category of risk experienced an average wait of 21 minutes 26 seconds, Ms Sturgeon added.

She said: "That's slightly higher than we want it to be – the target is seven minutes – so the ambulance service is working hard under incredibly challenging circumstances.

"My job and the Health Secretary's job is to support them through funding and other support to make sure that they can meet these challenges for the sake of the patients."

Mr Ross gave examples of a patient in Dumfries who called for an ambulance at 2.30pm after suffering a suspected stroke but paramedics did not turn up until 4.45am the following morning, as well as a father whose son collapsed on a roadside and, with no ambulance in attendance within half an hour, drove the 17-year-old to the hospital himself.

In response, Ms Sturgeon addressed the father and said: "I'm extremely sorry that the wait you had happened and I don't think that's acceptable."

She continued: "We know that our Accident and Emergency (departments) are under pressure, we know that is a backlog of treatment so one of the issues that the ambulance service faces is longer turnaround times which then puts a lot of pressure on ambulance resources.

"I recognise all of this and we are working hard with the ambulance service to address that."

Prior to FMQs, Scottish Labour health spokeswoman Jackie Baillie said: "Paramedics, nurses and doctors are doing the very best that they can but the NHS is in crisis.

"The Scottish Government has lost control and the Cabinet Secretary is nowhere to be seen.

"Patients and staff deserve so much better than this."

Scottish Labour have accused the SNP of "hiding behind the pandemic" as new figures confirm they missed last term's affordable housing target by 7,000.

In the 2016 election, the SNP promised to deliver 50,000 affordable homes over the next term – however, new figures confirm that they fell short by almost 15%, delivering less than 43,000 in that time.

We've been asked to comment on the Labour news release at the bottom of this email thread, which claims a staffing crisis at QEUH with a rise in covid-related absences, and nursing particularly hit.

NHS GGC have provided their statement, which I've pasted in below.

Grateful for clearance of the following lines. Policy and SpAds are content.

A Scottish Government spokesperson said:

"Staffing levels in Scotland's NHS have reached a new record high after an increase of over 5,000 whole time equivalent staff in the last year. Thanks to nine

consecutive years of staffing increases we have an extra 25,000 staff working in our health service, an 11 per cent increase in qualified nurses and midwives and a steady rise in places on pre-registration nursing and midwifery undergraduate training programmes.

"We recognise the acute workforce capacity challenges across NHS services and we are working hard to bring in new capacity and realign existing services to continue to provide timeous, effective and appropriately prioritised care.

"Current absence levels at QEUH are 20 – the quoted figure of 56 comes from a week in August when Scotland saw a rise in COVID cases after schools returned.

"NHS Greater Glasgow and Clyde is taking steps to bring in 670 newly qualified nurses – with 578 already in post and the remaining 92 starting as soon as their registration is processed. In addition, around 500 more Health Care Support Workers are joining the Board's bank during the winter.

"Our NHS Recovery Plan has more than £1 billion of targeted investment, including a commitment to provide £11 million for new national and international recruitment campaigns and to establish a national Centre for Workforce Supply."

# NHS GREATER GLASGOW AND CLYDE STATEMENT

NHSGGC has highly skilled and dedicated nursing workforce. We are extremely grateful to staff and we are working closely with them and partnership colleagues to consider ways we can support them during this difficult time.

While recognise there are staffing challenges at the QEUH, we would highlight our most recent figures (October 04) show that across QEUH there are 20 individuals absent due to COVID-19, which is proportionately in line with HSCPs and other directorates. Furthermore, the figures quoted by Ms Baillie are from the last week in August which coincides with schools returning and reflect a period when there was a higher level of community based transmission across Scotland. This spike in absences is not unique to the QEUH.

We have taken a number of measures to increase staffing levels across sites and have been able to reassign some non-clinical staff to support frontline operations and we are starting to see positive changes as a result. We have brought on board 578 newly qualified nurses with a significant number taking on roles at the QEUH over the past month. A number of these staff joined us early to provide support to our services.

Furthermore we have undertaken targeted redeployment of medical staff as well as seeking support from clinical academics. We are actively recruiting additional healthcare support workers and taking steps to build our resources in our staff bank, with around 500 more Health Care Support Workers HCSWs joining our Bank to support us during winter.

Finally, we have robust infection prevention and controls in place alongside a testing policy which sees staff take twice weekly lateral flow tests. This means that if a staff member does test positive, we're able to minimise any potential cross-transmission within the hospital setting.

Commenting on the news that PricewaterhouseCoopers has been awarded an £100,000 contract to help design the National Care Service, **Scottish Labour deputy leader Jackie Baillie said**:

"It is deeply troubling to see this contract to design the National Care Service being handed to a single private sector bidder.

"Serious questions need to be asked about the procedure surrounding the tendering of the contract and why only one private sector body formalised a bid. But perhaps of more significance, why is there not the expertise within the public sector – in health and social care or with the army of civil servants in Edinburgh?

"If we are to have a National Care Service worthy of the name, then care users, social care workers, the third sector and experts must be at its heart."

## **STUC** comment

STUC General Secretary [redacted 38(1)(b)] said:

"Whilst this is only a small contract, beginnings matter. We will vigorously oppose any move towards outsourcing the vital project of creating a National Care Service to companies with a vested interest in privatised provision. We note that there was only one bidder for the contract. We also see no reason why the skills and expertise of directly employed civil servants are not being utilised. South of the border, the past year has seen the continued growth of the consultancy gravy train with massive contracts awarded to companies with clear interests in private sector provision of public services, we do not want this replicated in Scotland."

Scottish Labour has today called on the SNP government to act now on school ventilation, as temperatures are set to plummet as we head into winter.

During the summer, the Scottish Government announced a £10 million fund to better ventilate classrooms.

This however is equivalent to just £4,030 per school, and the inspection of classrooms will not be complete until the October holidays – over ten weeks after schools returned.

Scottish Labour has highlighted research which shows how proper ventilation in classrooms is key to stopping the spread of COVID-19 in schools, amid a high number of absences linked to the pandemic.

Anecdotal evidence from the frontline in education has also suggested that the work carried out so far has often been inadequate or flawed.

With winter fast approaching, Scottish Labour has said that the idea that the government's ventilation scheme amounts to keeping windows open is 'farcical and dangerous.'

Labour has accused the government of wasting a summer by not carrying out inspections and has called for urgent action to improve air quality.

Commenting, Scottish Labour education spokesperson Michael Marra said:

"The SNP government has had all summer to act to improve ventilation, but far too little has been done.

"With cases in schools very high and winter on the way there is simply no time to waste.

"Winter is looming, with temperatures set to plummet. That the SNP's ventilation strategy currently amounts to keeping the windows open is both farcical and dangerous.

"We simply cannot have children huddled together in freezing classrooms this winter.

"Make no mistake – failure to act now will put our pupils, teachers and their families in danger."

"Smaller class sizes, even on a limited basis, such as P2 and P3 or S1 and S2, would mean more teacher time per pupil and assist with targeted interventions where the pandemic has impacted disproportionately on children's lives.

"As a country, we need to be bolder in our ambitions for our youth"

### Mr Rowley added:

"I encourage parents to speak up on class sizes. It is not right that the ability of parents to pay for education gives some children a better chance to achieve. We need more teachers, more teaching assistants and smaller class sizes if we are to achieve equality for all in education. Given what pupils have been through, we must be more ambitious for education recovery".

Hi spads

We have been approached by the P&J to ask about the attached FOI on ambulance turnaround times.

We have lines from yesterday, which have been slightly updated by policy colleagues, grateful for views please.

A Scottish Government spokesperson said:

"The Covid-19 pandemic has been the biggest shock the NHS has suffered in its 73-year existence and has heaped pressure on our ambulance service and wider NHS. The Scottish Ambulance Service are working closely with Health Boards to reduce turnaround times at hospitals.

"The Health Secretary recently set out £20 million of additional funding to help increase ambulance service capacity, improve response times and staff wellbeing.

"The ambulance service is also carrying out a national review of demand and capacity which will help to ensure they are working as efficiently as possible and have resources in place to meet both current and projected future demand.

"We are committed to supporting this work and recently announced a further £20 million in funding for the review. As part of this review, the service will see new ambulances introduced

and almost 300 additional staff in place throughout the country. This will reduce the requirement for on-call working in some of our more rural communities."

# Query

We are working on a piece about increasing turnaround times for ambulances at Aberdeen Royal Infirmary, Dr Gray's Hospital in Elgin and the Royal Aberdeen Children's Hospital.

Attached is the data we got back from an FOI request, which dates back to 2014.

Some of the relevant points -

In 2014, of 21,410 trips to ARI, the average turnaround time was 19 minutes and 40 seconds.

That has steadily increased every year since then, reaching 26:27 by 2018 and soaring to 34:38 for the 14,260 trips between this January and the end of July.

The number of times an ambulance was stuck outside ARI for more than an hour went from 136 in 2014 to 420 in 2019.

The pandemic made matters much worse, with it happening 1,686 times in 2020 and 2,828 times in the first seven months of this year.

The number of ambulances waiting more than two hours went from seven in 2014 to 637 in 2021 so far.

Meanwhile 104 have had to wait more than three hours this year and a dozen have had to idle for more than four hours.

Figures show that a number between zero and five had to wait more than five hours.

The longest turnaround time recorded in 2014 was four hours. In 2021, the longest wait was just over 23-and-a-half hours.

At Dr Gray's Hospital in Elgin, the average turnaround time went up from 15:40 in 2014 to 24:34 this year.

At the Royal Aberdeen Children's Hospital, ambulance waiting times went up from an average of 14:41 in 2014 to 21:16 this year.

There were seven occasions when ambulances had to wait more than an hour before dropping off their young patients in 2021.

We have had comment back from Deputy Leader of Scottish Labour, Jackie Baillie, and Scottish Conservatives leader Douglas Ross. Copied below.

"Ambulance services across the north east have been underfunded for far too long by the SNP. Ministers cannot continue to hide behind Covid for their failure over a number of years to support overwhelmed ambulance staff.

"Humza Yousaf and Nicola Sturgeon failed to accept this crisis as it unfolded in front of them. I would hope the situation will now be improving due to the support from our British Armed Forces, but the SNP Health Secretary must maximise their use.

"Every effort must be made to avoid these turnaround times completely spiralling out of control."

Statistics published today have shown that only 71.3% of people at A&E were seen within 4 hours in the week ending 10<sup>th</sup> October, the same record low percentage as the last week of September.

Of this percentage, some 1,871 spent more than 8 hours in A & E and 612 people waited longer than 12 hours.

Worryingly only 41% of patients were seen within 4 hours in NHS Forth Valley – the worst performance on record for any health board.

Scottish Labour deputy leader and health spokesperson Jackie Baillie said:
"Week after week we are presented with the cold, hard fact that A&E services are being overwhelmed.
"We have been calling on the government to act for months, but instead they have dragged their heels and failed to support staff.
"With the army being called in to support several health boards, the Health Secretary cannot continue to pretend everything is rosy.
"Thousands of Scots are waiting several hours in pain for treatment. And health boards, like Forth Valley, are recording the worst statistics on record.
"Things have to change now, or else we face a winter of chaos."

A&E waiting times remain at record breaking levels, with the number of people being seen within the four-hour target time remaining at 71.3%, the same as last week.

The number of people this represents increased slightly, with 7,264 people waiting more than four hours, 1,871 people waiting more than eight hours and 612 people waiting more than twelve.

Commenting, Alex Cole-Hamilton said:

"Patients are in pain and are waiting too long. Staff are overstretched and under resourced. Those facts are now hallmarks of life in Scotland's 14 years with the SNP in government.

"This crisis has escalated to levels that would have been unimaginable just months ago. These waiting times are not sustainable, and staff cannot and should not be expected to work through another six months of this.

"The pressure, stress and anxiety are off the scale, because people are not receiving the timely treatment they should be able to expect. In the worst cases, the under resourcing may well lead to unnecessary deaths. That's why we need to see an independent review. "Fixing this workforce crisis should be a personal priority for the Health Secretary. NHS staff deserve nothing less."

HOSPITAL ONSET COVID HITS SEVEN MONTH HIGH

### **EMBARGOED: 00.01 MONDAY 25 OCTOBER**

Scottish Labour has accused the SNP of "complacency" as cases of hospital onset Covid reach their highest point in over seven months.

Analysis of the most recent Public Health Scotland data, which covers up to September 26, has revealed a sharp spike in "definite hospital onset" Covid cases.

These cases shot up by a shocking 70 per cent in a single week, from 37 cases in the week ending September 19 to 63 in the week ending September 26.

This takes levels to their highest point since mid-February.

In addition to the 63 definite cases in the week ending September 26, there were a further 36 "probable" cases of hospital onset Covid and 34 "indeterminate" hospital onset cases.

Overall, there have been more than 4,000 cases of definite hospital onset Covid recorded.



### HOSPITAL ONSET COVID HITS SEVEN MONTH HIGH

**EMBARGOED: 00.01 MONDAY 25 OCTOBER** 

Scottish Labour has accused the SNP of "complacency" as cases of hospital onset Covid reach their highest point in over seven months.

Analysis of the most recent Public Health Scotland data, which covers up to September 26, has revealed a sharp spike in "definite hospital onset" Covid cases.

These cases shot up by a shocking 70 per cent in a single week, from 37 cases in the week ending September 19 to 63 in the week ending September 26.

This takes levels to their highest point since mid-February.

In addition to the 63 definite cases in the week ending September 26, there were a further 36 "probable" cases of hospital onset Covid and 34 "indeterminate" hospital onset cases.

Overall, there have been more than 4,000 cases of definite hospital onset Covid recorded.

Scottish Labour have said this is a sign of the pressure hospitals are under, calling for the SNP to do more to keep hospitals safe and ensure staff can get their booster vaccines.



### Lines

"We have taken unprecedented action to support people during the pandemic. The Scottish Welfare Fund provides a vital safety net for households facing an unexpected financial crisis. That is why we have committed to maintaining the budget for the Fund at £41 million and to undertaking a full independent review to ensure that it works as efficiently as possible across the whole country.

People on low incomes, children and people at risk of homelessness will need more support this winter against a backdrop of rising living and fuel costs. That is why today we have announced a new Winter Support Fund which includes:

- £10 million to help people who are struggling to pay fuel bills.
- £25 million flexible funding to help local authorities support wellbeing and respond to financial insecurity based on local needs.
- £6 million for third sector partners to support low income families

Scottish Labour has warned that households are at crisis point as new figures show record rates of people repeatedly applying for crisis grants.

New figures for the Scottish Welfare Fund show that repeat Crisis Grant applications are at their highest point since the fund began, with more than 3 out of 4 applications now coming from people who've already applied in the past.

From April to June this year 76 per cent of crisis grant applications were repeat applications. This has increased sharply over the last year, from 64 percent in the same period in 2020 – and it has sky-rocketed since 2013 when it was just 17 per cent.

Most recent figures show a third of applications to the fund were rejected, with applicants facing a postcode lottery due to huge variation in approval rates between local authorities.

Scottish Labour have said these figures highlight the need to move quickly to deliver a real Minimum Income Guarantee instead of the "sticking plaster" approach from the SNP.

Commenting, Scottish Labour's Social Security and Social Justice spokesperson Pam Duncan-Glancy said:

"More and more people are living in a state of constant crisis, relying on piecemeal grants to make ends meet.

"Crisis grants are an important lifeline – but they aren't a substitute for a real safety net.

"Things are only set to get worse as bills soar and the Tories' shameful cut to Universal Credit hits.

"We need more than sticking plasters to tackle poverty in Scotland.

"The SNP must act urgently to deliver a real Minimum Income Guarantee for every Scot."
