Purpose

The purpose of this paper is to provide an update on progress towards the outcomes and outputs identified in the Energy Action Scotland workplan 2022/2023 for Q1.

1 Introduction

The following report provides a detailed account of the activities of Energy Action Scotland during Q1 2022/2023.

2 Achievements

There has been considerable media attention during Q1 because of continually rising energy prices and forecasts and UK/Scottish Government responses. We will quantify this in due course but there has not been a single week without major media attention and coverage. We have participated in local and national radio, live television, national news and consumer affairs programmes, been interviewed and quoted across all major print media titles.

During Q1 of this year:

- We submitted responses to BEIS on the Warm Home Discount for Scotland and the Energy Bills Support Scheme. We responded to the Scottish Commission on Social Security to reiterate our concerns about the impact of changes proposed in Scotland through the introduction of Low Income Winter Heating Assistance. (Frazer)
- We submitted evidence and participated in a session on the energy crisis by the NetZero Committee of the Scottish Parliament (Frazer, Kate)
- Our Warm Home Discount Industry Initiative funded project Aiming Beyond Cancer completed the delivery of support to people with a cancer diagnosis in Orkney and Shetland. The project was extended to end of April 2022. (Frazer, Siobhan)
- We have received a grant offer and returned a contract to the William Grant Foundation to deliver a £250,000 Fuel Poverty Challenge Fund focussed on addressing inequalities. It is expected that this will launch in Q2 of 2022/2023. (Frazer, Siobhan)
- Negotiations with funders including Scottish Power, OVO, Good Energy and Octopus for Warm Home Discount Industry Initiative support are all at various stages of deliberation. (Frazer)
- We continue to be represented at the monthly Ofgem engagement sessions with charities and other third sector organisations in GB. (Frazer)
- We have participated in several Ofgem workshops on the future shape of the Energy Price Cap and market stabilisation measures with other third sector partners. We have shared our concerns that all proposals are at the detriment




- of vulnerable and low-income households, putting profit before people (Frazer)
- We completed the updating of the Child Poverty Action Groups highly respected Fuel Rights Handbook. This is produced professionally and is available for purchased through online retailers. (Frazer)
- Delivered a keynote address at the Scottish Energy Efficiency Awards in Glasgow. (Frazer)
- Delivered presentations at conferences and events including the STUC/Poverty Alliance cost of living conference. (Frazer)
- We commenced a wider collaboration with third sector partners including the Robertson Trust, The Poverty Alliance, Joseph Rowntree Foundation, SFHA, CPAG, Age Scotland and the Institute of Public Policy Research. (Frazer, Kate)
- We continue to participate in strategic groups including Gas Goes Green, All-Party Group on Consumer Protection, Energy Consumers Commission, and the South Lanarkshire Council Fuel Poverty Sub-group. (Frazer, Kate, Siobhan)
- We have instigated with the Poverty Alliance a First Minister led Energy Summit. This is a tripartite meeting of Government, Suppliers and third sector organisations. (Frazer)
- Over 40 candidates commenced City and Guild Energy Awareness qualifications. This is higher than this time last year and there is a strong pipeline of potential candidates (Christine, Siobhan)
- Contributed to the management and strategic direction of the Existing Homes Alliance. We provide the financial management and administration for the Alliance. (Frazer)
- We continue to be represented on the boards of Aberdeen Heat and Power and National Energy Action both of which met during Q1. (Frazer)
- Policy updates continue to be regularly circulated to members. (Christine)

- Scotland will experience varying levels of COVID-19 restrictions to the end of March 2022.
- Normal operations, including face-to-face meetings to any great extent would not resume before the end of Q4.
- Large group gatherings related to our work would not be encouraged before the end of Q4.
- Workplace measures taken by our partners and contractors would enable the delivery of our funded projects.



Funding and sponsorship from partners will be provided as expected.

7 Conclusion

Reductions in funding and the availability of people provided the greatest risks to delivery, affecting training, events and potentially the implementation of measures in our partner funded projects across Scotland. Mitigations were introduced and we delivered most events online, reshaped our industry and charitable organisation funding and delivered our conference virtually.

Warm Home Discount Industry Initiative funding provides a significant proportion of our turnover. There is ongoing uncertainty over the future of this funding stream. This is of great concern. A successful project submission with the William Grant Foundation will mitigate the impact on income to some extent should we be unable to deliver any WHD funded project work.

Our staff levels are below what was needed to deliver the full work plan, contracted support will provide capacity. It is proposed to recruit Business Development and Policy & Research capacity. This has been budgeted for in our outline plan for 2022/2023.

Performance Report 1 July 2022 to 30 September 2022

Purpose

The purpose of this paper is to provide an update on progress towards the outcomes and outputs identified in the Energy Action Scotland workplan 2022/2023 for Q2.

1 Introduction

The following report provides a detailed account of the activities of Energy Action Scotland during Q2 2022/2023.

2 Achievements

There has been considerable media attention during Q2 because of continually rising energy prices and UK/Scottish Government responses. There has not been a single week without our involvement in major media attention and coverage. We have participated in local and national radio, live television, national news and consumer affairs programmes, been interviewed and quoted across all major print media titles. This increased dramatically during Q2.

During Q2 of this year:

- We initiated discussions with Scottish Fire and Rescue to raise our concerns about the potential for the public to carry out dangerous and illegal activities that could result in fires or carbon monoxide poisoning. A meeting was held with the Deputy Assistant Chief Officer where the creation of a information leaflet for community safety staff to share with vulnerable households was identified. (Frazer)
- We contributed to an online discussion led by the Cabinet Secretary for NetZero Michael Matheson during August. This event focussed on cost of living and supports needed to help people in Scotland (Frazer, Kate)
- We launched our Fuel Poverty Challenge Fund, funded by the William Grant Foundation, promoting it widely through our membership and social media. It is expected that awards will be made, following a review by a panel drawn from the board and with the WGF, during Q3 with projects starting in December 2022. (Frazer, Siobhan)



- Project submissions were drafted and shared with Good Energy, Octopus and OVO during Q2 with a view to securing funding in excess of £250,000 to help vulnerable households, provide advice and guidance and, training to build capacity within the advice sector. Projects submissions were delayed due to delays in the process for the regulations for Warm Home Discount in Scotland. If successful these projects will provide support to over 200 vulnerable households with an active cancer diagnosis or similar life impacting condition, train 350 frontline workers to introductory level, 20 to city and guilds energy awareness and provide access to advice services to 14,000 low income vulnerable households in social tenancies. (Frazer, Siobhan)
- We continue to be represented at the monthly Ofgem engagement sessions with charities and other third sector organisations in GB. (Frazer)
- We have participated in Scottish Government workshops as part of a series of NetZero focussed events during July. Attending events in Greenock and Glasgow. (Frazer)
- Delivered presentations at conferences and events including Hannah Mackay housing event, NEA conference online, Neighbourhood Networks Scotland and, Holyrood conference on the cost of living cost of living conference. (Frazer)
- We supported third sector partners including the Robertson Trust, The Poverty Alliance, Joseph Rowntree Foundation, SFHA, CPAG, Age Scotland and the Institute of Public Policy Research on high profile campaigning and influencing on financial support for households in Scotland. (Frazer, Kate)
- We delivered an online advice forum attended by over 150 advice professionals with presentations from Utilita, Money Matters Lanarkshire and Greener Kirkaldy. (Christine)
- We continue to participate in strategic groups including Gas Goes Green, All-Party Group on Consumer Protection, Energy Consumers Commission, and the South Lanarkshire Council Fuel Poverty Sub-group. (Frazer, Kate, Siobhan)
- Following on from our joint letter with the Poverty Alliance the First Minister led an Energy Summit during August with the largest GB energy suppliers with leading third sector organisations in attendance. A follow up meeting was held during October (Frazer, Kate)
- Over 60 candidates commenced City and Guild Energy Awareness qualifications by end Q2. This is higher than this time last year and there is a strong pipeline of potential candidates. It is anticipated that this will reach 100 by the end of Q3 and 140 by end Q4. (Christine, Siobhan)
- We attended and contributed to meetings/events/workshops with Marie Curie, the Wise Group, the Fuel Poverty Advisory Panel, the Poverty Alliance and Strathclyde University Centre for Energy Policy (Frazer)
- Contributed to the management and strategic direction of the Existing Homes Alliance. We provide the financial management and administration for the Alliance. (Frazer)
- We continue to be represented on the boards of Aberdeen Heat and Power and National Energy Action both of which met during Q2. (Frazer)



Policy updates continue to be regularly circulated to members. (Christine)

3 Staff

Recruitment was put on hold until all outstanding funding is confirmed. Contractors have been appointed where appropriate to complete a number of outputs in our work programme.

Additional PR/Communications support has been provided on an ad-hoc basis by Cowbrough Communications.

continues to be engaged to provide consultancy support to Clackmannanshire Council on our behalf, where we are engaged to monitor the performance of its 15 property BEIS funded whole house retrofit project.

4 Office Accommodation

A formal meeting with Stelmain, the management agent for our offices at Ingram House, was held during August. A formal process has commenced to end our tenancy at Ingram House. A dilapidations report is expected during Q3 consistent with our termination obligations specified in our lease. At this stage we are not pursuing an alternative or equivalent level of accommodation. Staff will work remotely and flexibly into 2023/24.

7 Conclusion

Funding uncertainty limited our ability to increase the staff compliment beyond our intern. Additional capacity provided by contractors will partially fill gaps but we remain below the level needed to deliver the full work plan.

Demands on our resources have shifted significantly as the year has developed. Increased demand for training has meant more time has been allocated to the management and administration of this. Delays in the regulations for the Warm Home Discount in Scotland has delayed the development and delivery of projects to support vulnerable people. Unprecedented levels of media have introduced new challenges albeit we have begun to see an upturn in membership and in donation.

Performance Report 1 October 2021 to 30 December 2021

Purpose

The purpose of this paper is to provide an update on progress towards the outcomes and outputs identified in the Energy Action Scotland workplan 2021/2022 for the Q3.

1 Introduction

The following report provides a detailed account of the activities of Energy Action Scotland during Q3 2021/2022.

2 Achievements

There has been considerable media attention during Q3 as a result of rising energy prices and the increase in the number of energy supplier failure. A separate paper covers our media activity during this time.

During Q3 of this year:

- We submitted responses to BEIS on proposed changes to Warm Home Discount and to the Energy Company Obligation. Ahead of these attended briefing events and we co-hosted a consultation response development session for our members and others with Citizens Advice Scotland. (Frazer, Kate)
- Our Warm Home Discount Industry Initiative funded project Warm at Home continues to deliver support to households with a cancer diagnosis. Our project remains on track to deliver support to over 150 people this winter has commenced. Funding has been secured from Scottish Power and deliver through referral partners in Central Scotland is resulting in approximately 10 referrals per week from households with a person with a cancer diagnosis. Our delivery partner BRB Electrical Ltd provides heating systems installs and white goods as assessments determine. (Siobhan, Frazer)
- Our Warm Home Discount Industry Initiative funded project Aiming Beyond Cancer was approved for delivery on 23 December 2021. The project has been reframed and expanded to include Shetland, Orkney and the Western Isles. At this stage only people in Shetland will receive a heating system install with Orkney and the Western Isles supplying white goods only. (Frazer, Siobhan)
- A proposal to the William Grant Foundation has been submitted. We aim to deliver a second Fuel Poverty Challenge Fund focussed on addressing inequalities. This has been met favourably and at the instigation of WGF we are looking at some independent evaluation support Based on feedback and a review of the landscape it was felt that a focus on harder to reach communities or interest consistent with 'protected characteristics' was an area of unmet demand where we could learn more. (Frazer, Siobhan)



- Stay Warm Stay Well funding was secured through a submission led by National Energy Action (NEA). We delivered sessions to over 350 frontline, third sector participants with 20 being identified for City and Guilds Energy Awareness awards. We are providing support sessions ahead of the first exams being held on 7 February. This activity is funded by OVO. (Siobhan, Christine)
- We continue to be represented at the monthly Ofgem engagement sessions with charities and other third sector organisations in GB. These have been become less frequent as the energy crisis has taken effect. (Frazer)
- We have participated in a number of Ofgem workshops on the future shape and operation of the Energy Price Cap with other third sector partners. We have shared our concerns that all proposals are at the detriment of vulnerable and low income households. (Frazer)
- Our Q3 Energy Review was published during October. Articles related to decarbonisation, buildings, and a Just Transition. This Energy Review had the largest amount of content of all our reviews and a breadth of commentary that was well received by our members (Kate)
- We delivered our second Fuel Poverty Advisors Forum which are funded by Utilita. Over 250 advice professionals registered for the session and over 150 attended online. Presentations were delivered by Utilita, the Fuel Bank Foundation and Citizens Advice Scotland. (Frazer, Christine)
- We published in partnership with National Energy Action the Fuel Poverty Monitor in support of National Energy Action. It was launched at a UK parliamentary reception and Alison Thewliss MP spoke at the session. (Frazer)
- We published a Fuel Poverty winter information leaflet funded by SPEN during October ahead of the winter period. It focusses on health and wellbeing and provides no cost and low cost tips and advice to households to help them stay warm. (Cowbrough Comms)
- During November we gave evidence at the Scottish Parliament Social Justice and Social Security Committee on the Fuel Poverty Strategy. In a session with the Existing Homes Alliance and Citizens Advice Scotland we expressed concern regarding the strategy, whether it truly met the requirements of the Fuel Poverty Act in terms of mapping out how the targets will be met and our concerns on proposals for Winter Fuel Payments and Cold Weather Payments. (Frazer)
- Our Winter Campaign on Essential Warmth went live during November. It is focussed on fundraising to provide essential items including duvets, hot water bottles and flasks to households struggling this winter and beyond. As of end January our initial target of £10,000 was exceeded following corporate donations from SSEN, SPEN, SGN and Scottish Gas. We have now reach £14,000 including public donations via JustGiving. (Frazer)
- In November we were awarded highly commended in the international Energy Institute award for our Winter Campaign 2020/21. (Frazer)
- A Scotland dissemination event, supported by Smart Energy GB, with presentations from St Andrews Environmental Network, Smart Energy GB and



Energy Action Scotland was held on 27 October. 50 delegates registered for the event and over 40 attended. (Frazer)

- We presented at an opening session of COP26, an online breakfast event on 1 November (Frazer)
- We presented at a Holyrood conference on the Just Transition on 15 December (Frazer, Kate)
- We held a number of meetings with constituency MPs and MSP during Q3. (Kate, Frazer)
- We continue to participate in strategic groups including Gas Goes Green, All Party Group on Consumer Protection, Energy Consumers Commission, and the South Lanarkshire Council Fuel Poverty Sub-group.
- We have contributed to ongoing energy network consultations and engagement with SGN, SSEN and SPEN. (Frazer)
- Contributed to the management and strategic direction of the Existing Homes Alliance. We provide the financial management and administration for the alliance. (Frazer)
- We continue to be represented on the boards of Aberdeen Heat and Power and National Energy Action both of which met during Q3. (Frazer)
- Policy updates continue to be regularly circulated to members. (Christine)

Looking ahead

- We have an BSG meeting due in February (Christine)
- We have an Advisors Forum with over 200 registered delegates during January (Christine)
- Presentations at Public Policy Exchange and EVH events (Frazer)
- We will complete the work on the Child Poverty Action Group (CPAG) to provide fuel poverty handbook. (Frazer)
- We will liaise with National Energy Action to ensure that the funds it received from MoneySavingExpert's Martin Lewis will be able to demonstrate a cross UK reach (Frazer)

3 Staff

Recruitment was put on hold until all outstanding funding was confirmed. Contractors have been appointed where appropriate to complete a number of outputs in our work programme.

has completed two thought leader reports for us on Decarbonisation and one on Underoccupancy, both in relation to Fuel Poverty.

Additional PR/Communications support has been provided on an ad-hoc basis by Cowbrough Communications.

has provided sessional support for exam invigilation as required.

drafted some analysis on the impact of winter support for older households which we have shared with Citizens Advice Scotland with a view to



influencing the direction the adoption of the Cold Weather Payment System and the Winter Fuel Payment.

has been engaged to provide consultancy support to Clackmannanshire Council on our behalf, where we are engaged to monitor the performance of its 15 property BEIS funded whole house retrofit project.

has been engaged to produce a piece on Fuel Poverty and Inequality. This will be delivered during Q4.

4 Office Accommodation

The Scottish Government guidelines did not support a return to office working conditions during Q3. Staff worked productively at home. There have been occasional office visits by staff to collect essential items to support their work. This was authorised and communicated.

In light of recent relaxation of the rules regarding working in office we will begin to utilise our office accommodation to a greater extent during Q4. We will continue to work to the flexible working practices identified during 2020. The health and safety of the staff is paramount, and we will not be returning to full time office working.

5 Operational approach and assumptions

To forecast the delivery of outputs we had to make assumptions, and these are under constant review.

During Q3 we assumed that:

- Scotland will experience varying levels of COVID-19 restrictions to the end of March 2022.
- Normal operations, including face-to-face meetings to any great extent would not resume before the end of Q4.
- Large group gatherings related to our work would not be encouraged before the end of Q4.
- Workplace measures taken by our partners and contractors would enable the delivery of our funded projects.
- Funding and sponsorship from partners will be provided as expected.

6 Summary of performance

The table identifies 50 outputs. The table identifies movement. Two outputs are now red which relates to the unsuccessful application to the Scottish Government Adapt and Thrive grant scheme administered by SCVO and to the cancellation of the delivery of City and Guilds Renewable Energy qualifications. 7 Conclusion

Reductions in funding and the availability of people provide the greatest risks to delivery, affecting training, events and potentially the implementation of measures in our partner funded projects across Scotland. Mitigations are in place as we intend to deliver most events online, reshaping some of our industry and charitable organisation funding and delivery our conference virtually.

Warm Home Discount Industry Initiative funding provides a significant proportion of our turnover. There is ongoing uncertainty over the future of this funding stream. This is of great concern. A successful project submission with the William Grant Foundation will mitigate the impact on income to some extent should we be unable to deliver any WHD funded project work.

Whilst our staff levels are below what is needed to deliver the full work plan, contracted support will provide capacity, but it is still proposed to recruit to provide Business Development and Policy & Research capacity. This has been budgeted for in our outline plan for 2022/23. Training capacity is low, but Siobhan has the capability to deliver training to the standards required. At the present time City and Guilds is only available through NEA's online delivery. Therefore, there is reduced need for Energy Action Scotland to provide a dedicated support at this time.

Interviews with journalists were shared across titles, for example, an interview with the publisher DC Thomson on fuel poverty in Tayside appeared in the Press & Journal, Dundee Courier and Dundee Evening Times over a period of days. Our content has also been picked up by news agencies (what we usually hear referred to as 'the wires') and consequently have run across a number of other titles, online and were attributed in other stories.

Christine, our longest serving member of staff, says that we have never received this volume of coverage and indeed it has grown over the past 3 months to account for a significant amount of our work.

2.0 Past Activity

Partner and member organisations agree with us that despite a regular contribution to this key issue in the media, it was historically a challenge to attract interest for any sustained period or in proportion to the scale is the issue as it affects households in Scotland. The appetite for our contribution to debate grows with our profile and is humbling when considered against the impact we are seeing on human lives.

3.0 Optimising our Engagement Opportunities

This quarter has been so consistently busy that it would be easy to look at the volume of coverage as the measure of success.

When fuel poverty falls down the agenda as it inevitably will in the months to come, it will be with the knowledge that we are seen as the key agency for comment, for briefing and for help.

Both broadcast and print journalists now come to us regularly to support their understanding of issues including: Government policy both in Westminster and in Scotland; the price cap; energy company failure; bills and levies, and; advice for customers. This is the real place of strength and a significant.

We were represented across 23 national and local radio broadcasts during September to end January. Several of these were syndicated across local independent stations and we have only been able to account for these based on the original interviews. These included Bauer Media and Global Media.

We appeared on 4 national TV broadcasts and 2 podcasts for specialist interest organisations.

With our members and partners, we have been able to provide household/ consumer voices to speak to the lived experience of fuel poverty and have become a key contact for every major media outlet in Scotland as well across the UK as awareness grows of the disparity between billing and consumption levels in Scotland compared to elsewhere.

4.0 Our Voice

To ensure that we maximise our advantage in this place of focus, we have commissioned several 'think pieces' which we will look to place in order to develop the narrative and understanding of the wider issues concerning us.

The time to do that will be when consumer fear recedes (and spring approaches), party politics de-escalate and when we can engage pro-actively with the new levels of awareness and understanding.

New resources like the fuel poverty map of Scotland the forthcoming film in partnership with Scottish power give us visual resources we have found to be a challenging lack in the past. This has resulted in increased pick up from the online versions of the traditional print media. Articles in the Daily Record and pick across independent newspaper titles. We instigated or responded to journalists from the print media resulting in 7 major articles.


This is a real opportunity to lead the debate and encourage new thinking and debate around fuel poverty and our goal remains to consolidate and expand our position as the central voice of fuel poverty in Scotland.

5.0 Other Platforms

Outside the traditional media we continue to create engagement and influencing opportunities of our own with online dissemination events including our Advisers Forums which are proving hugely popular. The most recent one in January attracted over 200 participants demonstrating both our reach as well as the devastating level of need in our communities.

Looking ahead we have commissioned content on under-occupancy, decarbonisation, financial supports, health and housing, and inequalities which will give us more, quality content to communicate.

Twitter reflects both our regular engagement as well as the peaks of focus on both fuel poverty and EAS. For example, March 2021 was an early engagement peak for us with the Annual Conference and the lead up to the Scottish Parliament elections. However, January 2022 saw double the levels of engagement of any other previous month. I general, engagement has spiked over the price cap and energy company failure as increasing numbers of people seek out information on an issue which is affecting thousands more every month.

The worst areas for fuel poverty in Scotland revealed.

As industry and charities call for urgent action to support people with their energy bills this winter, the extent of Scotland's fuel poverty problem has been geographically captured for the first time.


