You may have already picked this up but Tighean Innse Gall is closing its insulation business in the Western Isles. This will have an impact on households. TIG are the main island contractor/sub-contractor for other fuel poverty programmes including the HEEPS: Area Based Schemes and the Energy Company Obligation for the Western Isles. They have delivered excellent work over many years but as we identified, in representations to governments, last year the burden of quality standards and the lack of flexibility was putting businesses and programme budget spend targets at risk.

The loss of TIGS service will be a devastating blow to its small but professional workforce and yet it comes at a time where it is likely that over half the islands population are in fuel poverty and are in need of help. Insulating people's homes is even more important than ever in the current climate of escalating energy costs. It is worrying that some of the modelling costs for the October price cap are moving higher than original estimates of £400 to somewhere potentially approaching £900 on that average dual fuel bill.

I thought you should have a heads up in case ministers are asked to comment on TIGs media release.

Re: Scottish Government's Heat Networks Regulation Working Group

The Scottish Government's "Heat Network Regulation" team would like to invite a representative from Energy Action Scotland to participate in our forthcoming working group on *Heat Network Licences and Powers of Licence Holders*. I would be grateful if you could recommend a suitable colleague whom I could invite? (This may of course be yourself).

Please find attached a basic outline of the Scottish Government's Heat Network Regulations Working Groups – I'd draw your attention in particular to Working Group 4 ("Licensing and powers of licence holders"). Note that the start date is TBC, but as a rough indication, it will not commence until after the summer.

The Heat Networks (Scotland) Act 2021 requires the Scottish Government to introduce a licensing regime to regulate the heat networks market so that homes and businesses are supplied by solvent, fit and proper operators, whilst requiring networks to be developed and maintained to high standards. This includes provisions that licensing must give regard to the applicant's ability to operate a heat network in a manner that: (1) contributes to meeting fuel poverty targets; (2) takes account of the just transition principles; (3) minimises greenhouse gas emissions.

As such, we would very much welcome Energy Action Scotland's input on shaping the secondary legislation and guidance around these requirements.

I look forward to your reply.

I am incredibly disappointed that after many years of support the Scottish Government is withdrawing any financial support to Scotland's only fuel poverty charity. This modest yet vital core funding has always been part of our income and underpins our viability. It is shocking that the Scottish Government now appears to place such little value on the work that Energy Action Scotland has delivered and intends to deliver during 2022/23.

This runs counter to discussions that we had last year with SG during Q3 2021/22 about the important role our charity plays in working to eliminate fuel poverty. Indeed discussions with your colleagues and our chair we very much about how to reset our working relationship with a view to a longer term approach.

The withdrawal of funding is likely to have a significant detrimental impact on our charity as we have already budgeted for this income and as a result are running at a deficit. Indeed for the last two financial years formal agreement on funding has not been finalised until early in Q3. This has placed us at risk but we have progressed on good faith on the reasonable expectation of support.

This is a crucial time for fuel poor households and the advice and support sector which are at the core of our charity. Member organisations support over 3000 households each week and we provide a voice for those organisations, who are working tirelessly at the frontline, to regulators, industry, the wider third sector and government.

During 2021 into 2022 we have provided guidance and information more publicly to help households and signpost to other services. We have produced an shared more information to help households than ever before working with Scottish Power Energy Networks, Smart Energy GB, Child Poverty Action Group and revising our go-to reference material for the advice sector.

To be honest it beggars belief that at a time such as this Scottish Government is unceremoniously removing funding from the national fuel poverty charity.

We appreciate that budgets are tight, they always have been, but we are already a quarter in to 2022/23. It will be extremely difficult for us to respond to this savage cut to our funding. It puts staff at risk of redundancy and the economic viability of Energy Action Scotland into question.

I will share the news immediately with our Trustees and I am sure they will be as shocked and surprised as I am right now.

The charity stands ready to work with government to benefit the people of Scotland.

Hi Frazer

Firstly, thank you for some early productive and positive discussions together, coming in new to the Fuel Poverty agenda last month, these have been very helpful.

Secondly, I advised I would come back to you this week in respect of the funding proposal from EAS for 2022/23, which I have reviewed and discussed with my own managers. As discussed, the current financial landscape is an extremely challenging one across the public sector as you know, which the budget statement given to Parliament by Ms Forbes earlier this year set out.

Our directorate has been impacted alongside others in rigorous budget scrutiny and with identifying efficiency savings. In essence within Fuel Poverty, there is no available budget beyond the committed Fuel Insecurity Fund, which has been allocated across our third sector partners, Fuel Bank Foundation, Scottish Federation of Housing Associations and Advice Direct Scotland. Unfortunately, this means we are not in a position to approve the Energy Action Scotland funding proposal, submitted to the team in May this year, or any ongoing funding to support EAS core costs in 2022/23.

I understand this decision will be deeply disappointing news for yourself and Energy Action Scotland, as well as for the board members. I hope you can equally appreciate the constraints, which the SG is operating under at this time, and we can still forge a strong collaborative relationship between our respective teams to support the strategy and panel over the next few years.

We did start a campaign on people donating any rebates. Across the GB it did yield a few donations for NEA but not really for us. The council tax rebate was applied differently in Scotland so people didn't experience it in the same way. NEA tended to apply donations to support its advice work or to provide crisis payments to people identified through its call centre.

We have general donations to Energy Action Scotland which started up in the last two years. Over the last couple of winters we have pushed on donations from the public and partners. Last winter it was about £15,000 in donations. It tends to work better in line with the Winter Fuel Payment. At least it did in the past.

Over the last month we have received several unsolicited donations. It looks likely that donations will exceed last years by a considerable margin but it is early days.

We've received donations from members of the public explicitly stating that it was the Winter Fuel Payment but more often than not it is an anonymous donation. We do this through JustGiving and we are registered for Gift Aid.

Where we have raised funds this way we have disbursed this through member organisations where they have identified the beneficiaries and provided additional resources to support those households. We have usually called on members to identify themselves as being willing/interested to take part.

We are just about to do something similar in relation to a deal we have struck with a manufacturer to access heavily discounted air fryers and programmable pressure cookers. We provided over 500 of these in winter 2020/21 and they proved popular in the areas where they were distributed, Paisley, East Ayrshire, Livingston, Glasgow and Dundee.

A revamp of our website is close to finish and one of our aims is to make it easier to join Energy Action Scotland and donate to us.

The publication date is largely dictated by our partner NEA but it is likely to be mid November. I suspect that will be before the longitudinal data from the Scottish House Condition Survey 2021. Albeit those FP stats will not be relevant for the current time.

Ideally, we could hang on and leave space for any SG analysis in light of the current cap as is or for any revision should UK Gov act which would affect modelling.

The earlier modelling ahead of April 2022 rise was a useful marker but it feels like we are missing a credible revision to reflect the current cap and known mitigations

Last week associated with some of the media were updated estimates on the fuel poverty figures. They were modelled against the £2800 estimate increase in energy costs trailed by Ofgem and took account of the value of support provided associated with that. I couldn't see anywhere the uplift in extreme fuel poor households as things focussed on the headline level. Is/was there a calculation for that?

Your colleagues, in the past, were always helpful in providing stats to ensure that there was a fair reflection of the work of government.
