MV Clansman could possibly also offer an additional service on Saturday evening following the Coll/Tiree service, not to the detriment of the community. There is a lot to consider and work through, but they will publish updates as soon as they can. Stakeholders were asked that they cascade to passengers that they need to advise CFL in advance if they need any assistance with travel in between ports to use alternative routes.

3. Open Forum – main points raised:

What is the issue with the steelwork and why was it not picked up? <sup>[redacted</sup> advised that previous checks showed the steel was still within the tolerance levels, however this time was without. Alasdair Allan pointed out that perhaps more extensive checks are required.

- Dry dock has been extended this year. CFL are spending £34m this year in comparison to £21m 5 years ago. However, this is just to address the issues with an ageing fleet.
- Sound of Barra strengthening of this route has to be a priority.
- Communications there needs to be greater focus on this, and done in a more timely manner. Consideration also needs to be given to communicating with any communities affected by their service providing resilience elsewhere in the network.

4. Summary – <sup>[redacted]</sup> advised that it is hoped the vessel will leave dry dock on Sat morning and will be back operating on Sunday. There will be a decision made depending on weather which port she will sail to on Sunday.

### MV Isle of Lewis – Technical issue

#### <u>Issue</u>

The vessel operates on the Oban-Castlebay route. At 12.15pm on 7 October the vessel lost use of bow thruster on approach to Oban.

The vessel required an alternative mainland berth and moved to James Watt Dock, Greenock on Saturday 8th October. Replacement parts were been sourced from the Original Equipment Manufacturer and were shipped from Norway. CalMac had looked at having parts made in the UK, but this would have taken longer than shipping from the continent so was discounted as an option.

There was a slight delay in the parts clearing customs which was down to a UK wide issue with customs systems. The part was fitted today (11 Oct), and the vessel has now left Greenock heading to Castlebay. She is due to resume timetables service tomorrow at 07:00.

#### **Disruption to services**

Services were cancelled, and displaced passengers were offered travel on Lochmaddy-Uig services via the Sound of Barra.

CalMac did consider sailings between Oban and Castlebay on Sat (return on Sunday) by MV Clansman after her Coll/Tiree service – however the weather forecast for Sunday would have meant that the vessel would have been storm-bound in Castlebay until Monday, impacting on sailings to Coll/Tiree and Colonsay on Monday, so the decision has been made not to go ahead with that sailing.

On Sat 8 Oct, all food goods were shipped via Lochmaddy and Sound of Barra service. Local Area Operations Manager spoke directly with Barratlantic and the Coop to prioritise exports. However, original plans had to be cancelled due to a technical fault with MV Lord of the Isles.

# MV Lord of the Isles (LOTI) – Technical Issue

#### <u>Issue</u>

On Sunday 9 October at 19:00 CalMac reported a technical issue identified as steelwork corrosion to the hull. The vessel currently covers the service between Mallaig/Oban – Lochboisdale. There was no available vessel to cover as the MV Clansman was providing a service to Colonsay yesterday (Mon).

#### **Disruption**

A repair plan has been agreed with the MCA, which will allow the vessel to return to service once complete.

Some work has already been carried out to allow the vessel to move to a mainland port where additional work will be required. The vessel will transit to Oban on Wednesday 12 October, arriving 09:00. Surveyor and contractors will attend on arrival. The return to Lochboisdale will be confirmed once Asset Management and Marine have confirmed if the vessel is available for service.

# Please note that there is no overnight berth for MV Lord of the Isles in Oban, if unavailable for service she will have to return to Lochboisdale or transit to Clyde.

The vessel is due in dry dock for her annual overhaul 10 November, and the Class approved repair work will see her through until then at which point a permanent repair can be completed. There are currently no ships that can provide relief on the route today as the MV Clansman is required to ship essential supplies to Colonsay.

The Minister met with the CMAL Board on 20 October. CMAL produce a fairly detailed minute of all of its Board meetings but also produce a redacted version on its website. CMAL have shared the draft below and I suggested the Minister may want the chance to comment prior to these being finalised. The paragraphs in yellow will be redacted in the published minutes. I would welcome any comments to allow me to confirm to CMAL that they can circulate these more widely to the board (thy wont be published until after approval at the next meeting).

#### Transport Minister

Jenny Gilruth, the Transport Minister, arrived at 1000.

A summary of the points discussed are below

- JG thanked CMAL and the leadership team for all the good and consistent work that we carry out, noting that KH had been very supportive since she was appointed.
- The Minister noted that CMAL have a positive approach to problems and seek solutions.
- Congratulated Morag McNeill on the appointment as the Chair and Murdo MacLennan on the appointment as NED - welcoming his background as an island-based appointment.
- Reflected that the BBC Disclosures programme presented some challenging • and concerning issues but was not reflective of her experience of the work that CMAL carries out. [redacted]

- The Minister discussed Project Neptune and reiterated the point that CMAL the skills within CMAL were essential and that any changes cannot risk this current level of performance [redacted]
- Discussion took place regarding the challenges impacting the lifeline ferry network - in particular on the west coast and where possible improvements could be made [redacted]
- KH summarised the forthcoming projects that would be delivered within the 5year IIP period.

KH also reiterated that there were 3 projects that additional funding (amounting to £300m) would be requested. The most urgent that has been under active discussion was the additional 2 Major Vessels with a request for £115m. The Minister acknowledged that there were active discussions regarding agreement and that the Perm Sec and DFM were alreadv involved and supportive.

#### CALEDONIAN MARITIME ASSETS LIMITED - BACKGROUND

1. Caledonian Maritime Assets Limited (CMAL) owns ferries, ports, harbours and infrastructure necessary for vital ferry services serving the west coast of Scotland and the Clyde Estuary, and the Northern Isles. They are wholly owned by the Scottish Government with Scottish Ministers as the sole shareholder. CMAL is classified as a public corporation and was formed as a new corporate entity in 2006, when assets were separated from operational services performed by David MacBrayne and its subsidiaries. CMAL has a proud and long-standing heritage as part of Scotland's maritime history. Under the auspices of Project Neptune, Ministers are currently considering the corporate structures of the organisations delivering lifeline ferry services in Scotland.

2. The sponsorship relationship for CMAL is managed through the Aviation, Maritime, Freight and Canals division within Transport Scotland. The governance relies on strong working relationships between key individuals at Transport Scotland and CMAL, which allows for active discussion on risk and alignment of strategic priorities.

3. CMAL has updated its three-year corporate plan to 31 March 2025. The document outlines key achievements over the past year, and details key business priorities and deliverables going forward. The plan summarises, planned projects over the next seven years to include the financial year from March 2024. **The Corporate Plan can be accessed** <u>here</u>.

4. The table below provides information on the current CMAL non-executive Board members. A number of CMAL's key Executive Directors also sit on the Board.

#### **PROJECT NEPTUNE**

#### BACKGROUND

- 1. The purpose of Project Neptune was to reflect on the governance arrangements between CMAL, Calmac and Transport Scotland, having regard to the overarching objective of effective, efficient and economic delivery of lifeline ferry services to enhance passenger experience and support the local island economies.
- 2. It does not make specific recommendations on policy decisions, such as direct award, but does outline how different models could impact these. It offers some suggestions for more immediate short-term improvements around governance of ferry services and procurement.
- 3. The initial phase Project Neptune has now been completed with publication on 8 September 2022.
- 4. This phase provides a comparative analysis of alternative governance models drawn from international practice, to develop a preliminary "short list" of options for detailed consideration. The initial phase also considers short term changes that could be made to shareholder and project governance, to deliver interim improvements while next steps are under consideration. Next Steps will entail more detailed analysis and diligence on the short listed options to inform final decisions on how to proceed.
- 5. There has already been targeted third party engagement to inform the content of the review but Angus Campbell will lead further consultation with key stakeholders.
- 6. This is a significant piece of work which should not be considered in isolation. The outcome of Project Neptune will have implications for future policy decision by Scottish Ministers, such as the procurement strategy for future ferry services contracts.

#### **Project Neptune impact on CMAL**

- 7. CMAL are aware of the potential of a focus on assimilation option and have raised concerns on how this would be done to ensure CMAL staff do not view it as a CalMac takeover. Less focus was previously placed on the Governance elements of the report and some issues such as culture and behaviour (within the tripartite) will need to be addressed.
- 8. This is particular sensitivity for CMAL staff, who may perceive any exploration of options to bring CMAL and DML together as an implied criticism. There is a concern among the CMAL executive team that any uncertainty created by Neptune may lead to staff losses, or impede any future recruitment. It is important that any publication or consultation be handled sensitively.
- 9. CMAL have been engaged with the process, attended meetings alongside tripartite partners in 2021.

#### Next steps/outstanding work

10. Further consideration is required to set the scope and timescales for consultation with key stakeholders and any further work required to consider options outlined by Project Neptune.

11. Refreshing and refocusing the remit of the Network Strategy Group (TS, CMAL and CalMac) will also be undertaken.

#### <u>Top lines</u>

12. I very much value the ongoing work of CMAL, Calmac and Transport Scotland in delivering lifeline services, but recognise there is room for improvement in governance and strategic alignment

#### **Report Findings – Current Arrangements**

- 13. We broadly recognise many of the key messages in the report and the need for further actions and improvements.
- 14. The report was independent with a range of views so there was no expectation that each party would sign it off indeed it would be wrong to do so.
- 15. Many of the criticisms of current arrangements have already been set out in the RECC and Audit Scotland Reports and much progress has been made in addressing these issues but we accept there is more work to be done.
- 16. We accept there is further work to be done in terms of agreeing a strategic framework for the three organisations that will help further define roles and responsibilities.

#### Future Options

- 17. There are several options for reform set out in the report that include enhancing current structures or wider reform.
- 18. This work will take time and require detailed consideration on the best model before a decision is taken.
- 19. Much of this work will be of a technical nature, but the views of key stakeholders will be important.
- 20. No decisions have been taken at this stage.
- 21. Assimilation and integration are set out in the report as options to be considered but there are also opportunities to further strenghten and align the work of all parties involved in delivering ferry services.
- 22. This is about a decision to place value in all organisations to ensure the governance is robust, transparant and efficient.
- 23. Let me be absolutely clear, the work of both organisations and the individuals within each organisation are hugely valued.
- 24. While it was the right approach to give the consultants a wide remit in undertaking their work, we have clearly signalled that we will not consider options around unbundling or privatisation.
- 25. Our current view is that introduction of a Commissioner would not bring benefits to the way we deliver ferry services. But we would welcome input on when we consult on this matter.

#### **Engagement and Next Steps**

- 26. Engagement with staff will be a key part of the consideration of next steps but we also
- 27. need to seek the views of communities in this regard. I have asked Angus Campbell to lead on this work.

- 28. In his role as Chair of the Ferry Community Board Angus is well placed to seek and collate the wider network view on this matter.
- 29. We are currently finalising the details around this work and will set that out alongside timescales shortly.
- 30. I will also be speaking to stakeholders on this issue as part of a range of engagements.
- 31. We welcome input on the future arrangements, but would highlight that there are related technical and financial issues that need to be addressed and will require expert advice to inform decisions.
- 32. We also recognise the important overlap this work will have with other ferry work including the Islands Connectivity Plan and CHFS3 development.

#### INVESTMENT/FUNDING

#### **Investment Strategy**

1. CMAL support Ministers in the delivery of investment in vessels and infrastructure to support island transport connectivity. This is supported by £580 million in the 5 years from April 2021 to March 2026. A number of the vessel and infrastructure projects that they are involved in, as the procuring authority, with appropriate input from relevant ferry operators (CalMac or Serco NorthLink) along with Transport Scotland are listed below:

- Vessel Projects New Mallaig-Lochboisdale vessel, MV Loch Frisa, Gourock, Dunoon, Kilcreggan vessels, Small Vessel Replacement programme, two new Islay vessels, Craignure-Oban Future Vessels project, NIFS freighters.
- Infrastructure Projects Gasay ferry terminal development, Cumbrae slipway reconstruction, Port Ellen terminal development, Gourock, Dunoon, Kilcreggan harbour development, Armadale & Mallaig, Uig & Lochmaddy & Tarbert harbour developments, Islay enabling works and Port Ellen project, Oban Masterplan
- Small port projects for example the recent linkspan rope replacement at Lochboisdale, as well as Oban, Coll, Tiree and others. CMAL furnish TS Head of Infrastructure with updates on these projects (via a spreadsheet that is regularly updated).
- They also have a duty to maintain, improve and enhance their current assets across the network such as vessels and the land and property around piers and harbours.

2. CMAL has worked with Transport Scotland to develop the new Islay vessels project and on 11 March 2022 announced the preferred bidder to build the two new major vessels. CMAL, as Procurement Authority, awarded the contract to the Cemre Marin Endustri shipyard in Turkey.

3. Ministers have recently approved the funding of a further 2 such vessels and CMAL will be taking forward this new procurement.

#### Funding Mechanisms

5. CMAL generates most of its revenues from the operators of the Clyde and Hebrides Ferry Services (CHFS) and the Northern Isles Ferry Services (NIFS). CMAL's operating costs are funded from these revenues.

6. Scottish Ministers provide 100% loans to fund capital expenditure on vessels. The company makes applications to Scottish Ministers for Grant in Aid funding of up to 80% towards the costs of harbour infrastructure projects, with the balance of funding being found from its own resources.

7. We recognise the key role that ferry services play in supporting the economic, social and cultural development of island and remote mainland communities. Scottish Ministers have

committed to investing a further £580m in ports, harbour and vessels over the next five years as announced in February 2021.

8. CMAL can also provide further detail directly on the breadth and detail of their on-going work supporting ferry services, on behalf of Scottish Minister's, across Scotland.

#### ANNEX F

#### FLEET REPLACEMENT

1. Following our announcement in February 2021 of £580m investment in ports and vessels during the 5 years to March 2026, we are working constructively with key partners to progress a sustainable and efficient fleet replacement programme.

#### Top lines

- CMAL are working with Transport Scotland on development of a number of vessel replacement projects including the Small Vessel Replacement Programme, new vessels for Dunoon and Kilcreggan, further major vessel replacements for Mull and South Uist, and replacement freight ships for Orkney and Shetland. This is in addition to 4 new vessels now on order – 801/802 and the 2 new Islay vessels.
- Ministers have recently approved the funding of a further 2 such vessels and CMAL will be taking forward this new procurement.
- We share CMAL and CalMac's objective of increasing resilience through a "spare vessel" and by deploying a second vessel in summer on the Uig-Tarbert/Lochmaddy routes.

#### Second hand tonnage

2. The Scottish Government and Transport Scotland continue to task CalMac and CMAL with seeking potential second hand tonnage to improve operational resilience, particularly on the Clyde and Hebrides ferry routes.

#### Top lines

- Scottish Ministers have always said we would look to the second hand market for additional vessels to support our island communities.
- The previous charters of MV Arrow and CMAL's recent purchase of the MV Utne (now MV Loch Frisa) is evidence of this ongoing commitment and hard work, Scottish Ministers are sure it will be welcomed by local residents and visitors to Mull.
- <u>MV Loch Frisa</u> sucessfully entered service in June 2022 serving Craignure-Oban.
- It was disappointing not to secure the purchase of the MV Arrow but grateful to CMAL for attempting this, and demonstrating the positive business case for Government funding.

#### Catarmarans

3. Ministers and TS are neutral on hull form and expect CMAL – and the naval architects employed on individual projects – to consider a range of viable designs when considering options and to be able to explain decisions persuasively.

4. As part of the Dunoon concept vessel design, a variety of hull forms of varying lengths have been considered. These include monohull, catamarans, single and double-ended variants.

#### Top lines

• A parametric study was undertaken assessing hull forms of up to and beyond 40 metres in length, which included monohull, catamarans, single and double ended variants.

- Following discussions between the Working Group and design team BMT, a double-ended catamaran vessel with overall length of 40 metre was selected.
- The MV Pentalina was considered for possible charter in 2021 but was withdrawn from availability by its owner before the formal agreement was signed.
- We are working with CalMac exploring a charter option and are considering the terms and affordability. This would be a relatively short-term arrangement to support resilience until new tonnage is delivered.

#### New Islay Vessels

5. CMAL has worked with Transport Scotland to develop the new Islay vessels project and on 11 March 2022 announced the preferred bidder to build the two new major vessels. CMAL, as Procurement Authority, awarded the contract to the Cemre Marin Endustri shipyard in Turkey.

- The new vessels will bring an almost 40% increase vehicle and freight capacity on the Islay routes, a reduction in emissions and improve the resilience of the wider fleet.
- The first vessel is expected to be delivered by October 2024 and will enter service following sea trials and crew familiarisation. The second vessel will follow in early 2025.
- The overall cost of the vessels and related port infrastructure works, including project management and delivery costs will be around £130m (around £105m related to vessels and £25m related to ports).
- Each vessel will carry up to 100 standard cars and 450 passengers. Carbon emissions are expected to be 30% lower than the largest of the existing vessels on the Islay routes and shore power improvements will allow the vessel to plug in when berthed overnight.

#### Planned new Islay ferries and vessel commissioning process

- Assessment of new vessel options for routes across our networks is led by Transport Scotland, CMAL and the relevant operator.
- Engagement with communities, businesses and representative groups is an essential, and it is maintained throughout the process.
- Regular engagement and public webinars, including Q&A sessions, are used to be as transparent and open as possible to community and stakeholder views.
- The Ferries Communities Board highlighted to the Rural Economy & Connectivity Committee that the Islay consultation process was a model that should be built upon moving forward, and this view was echoed by Islay's own Ferry Committee.
- Improved reliability, extra vehicle capacity, greater efficiency and improved customer experience that will be provided by the two new Islay vessels will bring tangible benefits to the wider Clyde & Hebrides Ferries network.
- All viable vessel and port options will be considered where individual route and network wide appraisals are being undertaken.
- For example, for the Dunoon concept vessel design, various hull forms are being considered, including monohull, catamarans, and single and double-ended.

#### ANNEX G

#### FERGUSON MARINE PORT GLASGOW LIMITED - CURRENT PROGRESS

1. The Ferguson Marine (FMPG) CEO has taken a collegiate approach with CMAL, seeing to bring their expertise on board wherever possible. Fergusons has raised the profile of CMAL's 'Owners Observation Reports' since the secondment of a senior CMAL representative into the yard's senior team. FMPG and CMAL continue to treat these as a 'snagging and defect list', which is typical of any large construction or shipbuilding project.

2. The most recent update from the CEO FMPG to NZET Committee on 22 September 2022 indicates a delivery for 801 of April 2023, however LNG commissioning may delay introduction by 1-2 months. Handover of 802 has slipped to Q1 2024. The revised delivery schedule was developed with support from CMAL who also provided assurance that the revised dates are achievable.

3. The CEO report states that "The costs to complete Glen Sannox are now forecast at a total not to exceed of £101m, which includes a contingency of £2.7m and a provision for warranty costs of £3.5m. The costs to complete 802 are now forecast at a total not to exceed of £108.6m, which includes a contingency of £3.5m and a provision for warranty of £3.5m."

#### <u>Top lines</u>

- Target for completion of 801 (Glen Sannox) remains April 2023 however commissioning the LNG system may mean slippage of 1 – 2 months.
- There is the option to run the Glen Sannox on single fuel for the 2023 season.
- Handover of 802 has slipped to Q1 2024. Lessons in the build are being learnt from the construction of Hull 801.
- There have been three main challenges at the yard design, skills and productivity.
- These vessels will not enter service without rigorous assessment that they meet the required specification by CMAL who maintain a presence in the yard as advisors to the Scottish Government.
- In addition, the vessel will not be able to enter service until it has received all clearances required by the Maritime and Coastguard Agency and Class society approval from Lloyds Register.
- Transport Scotland Officials have welcomed Audit Scotland's report and accepted all recommendations including committing to a formal review following completion of the vessels.

#### Productivity At Fergusons

Driving up productivity day-to-day is rightly an operational matter for the yard. Officials understand that the Chief Executive and Chair are working to improve this and, as part of the programme

reset, the yard has set targets for more efficient work pack planning – so that use of labour and materials is better focused. An example of this is the creation of the permit to work office on ship, so time spent walking on/off ship is minimised. A number of issues relating to design have been resolved in recent months, as part of ongoing work to get the vessels out in to service as soon as possible. CMAL is also active in finalising design tweaks and variations necessary to complete the vessels.

#### **PENSION FUND**

1. Under the terms of the CHFS2 contract, Scottish Ministers are responsible for any increased pension costs due under the CalMac Pension Scheme.

2. In March 2021, a payment of £29.5 million was paid into the CalMac Pension scheme. This payment allowed the pension trustees to refinance the pension scheme, reducing the deficit position to £4.9 million and to retain employer contributions at their current level of 30.8% for 3 years from 2021-22.

**4.** Ministers' agreed in March 2022 to make a further payment of **£4.9 million** to the CalMac Pension Scheme and agreed that a further payment of **£6.0 million** was made into the CalMac Pension Scheme to retain employer pension contributions at their current levels of 30.8%

#### ISLAND REPRESENTATION

1. On 19 March 2021, a petition (PE1862) was raised in the Scottish Parliament to address the issue of island representation on public sector boards. The Committee wrote to the Minister on 16 February 2022 seeking an update and a response was issued on behalf of the Minister on 12 March 2022, setting out plans to seek further advice on this issue, the Minister also undertook to provide a further update to the Committee in due course.

2. On 2 September, the Committee invited Ms Gilruth to give evidence on Wednesday, 26 October 2022. <sup>[redacted]</sup> will accompany the Minister providing provide official support. <sup>[redacted]</sup>

3. The recent appointments of the DML Board Chair and three Non-Executive Directors were raised at FMQ's, in PQ's and also attracted some media attention highlighting that Island communities were disappointed that none of the recent recruits came from the islands.

#### <u>Top lines</u>

- CMAL recently appointed a new Non-Executive Chair [Morag McNeil] and one new Non-Executive Director [Murdo MacLennan] to the Board on 1 October 2022, for an initial term of 3-years.Mr MacLennan is a resident of the Western Isles; and both appointments are very much welcomed by Scottish Ministers.
- We have addressed Island representation by advertising the positions widely, (also in written Gaelic) including on the CalMac vessels travelling to and from our island communities.
- Letters were issued to local Councils asking them to highlight the recruitment opportunities within their island or remote community.
- Having an understanding of island life was a key criterion for both roles. This was fully explored and assessed throughout the recruitment process.
- It is important to note that the CMAL board already carefully consider the views and input form the communities impacted by their work.
- This includes direct feedback from their engagement with communities including on development of new port and vessel projects where significant efforts have been made to strengthen the communities' role.
- I place a lot of value in the work of the Ferries Communities Board and would envisage the ongoing engagement is key to ensuring islander views across the network are fully understood.
- I would expect the role of the Ferries Community Board to be strengthened as we move forward.
