GRANT IN AID – ADDITIONAL FUNDING 2020-2021

I am writing to formally vary the offer of grant in aid as detailed in the grant in aid letter dated 16 June 2020 (the Agreement) and subsequent letter dated 2 February 2021, to provide **sportscotland** with additional capital funding of up to £3,000,000 for the Financial Year 2020-2021.

Notwithstanding the variation notified herein, **ALL** other pre-existing Terms and Conditions of Grant set out in the Agreement shall continue to apply.

Additional Capital Funding (£3,000,000)

The capital funding of up to £3,000,000 being allocated to **sportscotland** relates to the proposed Murray Legacy Facility at Park of Keir, which aims to establish a lasting and meaningful legacy from the success of both Andy and Jamie Murray on the global stage, by creating a best-in-class tennis and sports complex as part of a wider Park of Keir development. The proposal focusses on provision of grassroots facilities, which are accessible and affordable for all children and families throughout the local community and across Scotland.

The proposed six indoor and six outdoor courts would contribute to meeting demand for year-round tennis facilities for use in all weathers: despite producing world-leading tennis players and seeing a resulting growth in interest in the sport.

Variation of Offer of Grant in Aid

Following agreement by Scottish Ministers the total Grant in Aid to include both Revenue and Capital allocation has now been increased to **£39,320 million (thirty nine million three hundred and twenty pounds Sterling)** as detailed in the table below. The grant-in-aid should be re-profiled and an updated spreadsheet submitted to the sponsor team providing details of grant-in-aid already drawn down, a profile of monthly grant-in-aid requirements for the remainder of the financial year and a note of the unrestricted cash reserves held at the end of the previous month.

- ① Fiscal resource spend scores most current expenditure. It comprises wages and salaries and operating costs offset by trading and other resource income.

- ③ Financial Transactions comprises loans given and shares purchased. Policy lending transactions are not capital expenditure in as they are financial, as opposed to non-financial (i.e. spending) transactions.
- ④ Non-cash funding is ring-fenced to meet the cost of assets depreciation and impairments. The non-cash element of funding cannot be used for general expenditure.

If **sportscotland** wish to accept the offer to vary the Agreement, you should sign and date the Acceptance Form and return it to me **immediately** and in any event **to arrive no later than Monday 22 February 2021**. Failure to do so may result in **sportscotland** losing any unclaimed grant. A copy of the signed Acceptance Form should be retained for your records.
