The Scottish Conservatives have today written to Michael Matheson requesting the release of all correspondence between him and his then junior minister Jenny Gilruth over the Fife railway controversy.

Humza Yousaf agreed on Thursday to launch an investigation into a possible breach of the ministerial code by Ms Gilruth, after Douglas Ross accused the former transport minister of stopping repair works affecting her constituency "for purely selfish, political reasons".

Her interventions are detailed in a series of emails obtained by the Scottish Daily Mail.

One of those messages states that Jenny Gilruth would seek "feedback from Cab Sec on his views", a reference to Michael Matheson, who was then the net zero, energy and transport secretary.

As a result, shadow transport minister Graham Simpson is calling on the current health secretary to release details of all WhatsApp messages, emails, phone calls and meetings he had with Jenny Gilruth on the issue.

He says it's vital Michael Matheson explains what role he had in a ministerial edict that resulted in vital repair work being delayed at an estimated cost to the taxpayer of £1million. The work, which was scheduled to be carried out last Christmas, has still not taken place.

Scottish Conservative shadow transport minister Graham Simpson MSP said: "It's clear from the email chain that Jenny Gilruth sought Michael Matheson's views on her intervention to block the repair works affecting her constituents.

"If she couldn't see that her actions gave rise to a likely breach of the ministerial code – due to the conflict between her role as transport minister and a constituency MSP – the Cabinet Secretary, as her boss, should have.

"As a result, Michael Matheson has questions to answer over why he didn't overrule Jenny Gilruth and give the go-ahead for the work to go ahead as originally scheduled.

"That's why I have written to him today, requesting that he publish all correspondence he had with Jenny Gilruth over this matter.

"The public deserve transparency from SNP ministers over this controversy – rather than a repeat of the secrecy that has characterised the ferries scandal – so that they can see why and how this poor and costly decision was taken."

A copy of Graham Simpson's letter to Michael Matheson is attached.

The FOI containing the email exchanges is attached.

The relevant message, dated, October 19, states: The Minister would like this to be paused until we have feedback from Cab Sec on his views. In the meantime is there any possibility these works could be spread out e.g. over a few Sundays? Ms Gilruth discussed this very briefly with ScotRail last week, but it is going to really affect Fife communities over Christmas – and anyone travelling between Edinburgh and Aberdeen - and the Minister is still not clear that there couldn't be an alternative approach adopted by [REDACTED]. Did the mean Edin / Gla line ever close for 8 days when it was being electrified? The Minister is not content to front up comms on this either, given this is the approach [REDACTED] want to take. Ms Gilruth understands why they are doing it but it is not going to land well, particularly given the impacts of the current timetable on Fife which we have previously

discussed. The Minister does not think rushing to get this out is the right approach and am asking for a 24 hour pause to allow Ms Gilruth to get Cab Sec and [REDACTED] views.

Jenny Gilruth: "The proposed decarbonisation works on this vital rail line would have caused significant disruption across the whole East coast of Scotland – including for passengers travelling across Fife, Dundee, Perth and Aberdeen.

"As I always did as Transport Minister, I carefully interrogated such proposals to assess their impact on passengers – and in this case I was not content that everything was being done to minimise inconvenience over the busy festive period. It is worth pointing out that services had already been impacted by ongoing industrial action and unplanned cancellations at that time.

"I therefore asked Network Rail to postpone the works, which they agreed to do, to give time to engage with the communities which would be impacted by the closure.

"While safety considerations are obviously paramount, I believe that the needs of passengers should be front and centre of such decisions, which in this case related to a Scottish Government funded piece of work which was not operational in nature. Indeed, the UK passenger watchdog, Transport Focus, welcomed the postponement at the time."

<u>Daily Mail</u> – claims Ms Gilruth held rail works to benefit constituents (front page)

Paper says that Ms Gilruth, while Transport Minister, delayed rail works over festive period to enable her constituents to travel without delay, which it says would constitute a breach of the Ministerial code.

SpAds issued lines. Transport Scotland colleagues provided the below additional background info on decision making process to the *Daily Mail*.

Additional background on decision-making

- The previous Minister for Transport was not satisfied that Network Rail had examined all possibilities for alternatives to the planned festive closures in relation to these works and asked for more information.
- Following consideration of additional information provided by Network
 Rail, the previous Minister for Transport was not sufficiently satisfied
 full consideration had been given to the impact of the proposed
 closures on those passengers most affected not only in Fife but also in
 Perth, Dundee and Aberdeen.
- This resulted in a Ministerial decision to postpone the works.
- This investment to decarbonise Fife rail services currently remains postponed while we work with Network Rail to consider revised proposals in terms of timing and available budget.

- Once this work is complete, we will be able to give a further update on these particular works.
- The attached EIR response gives more detail about the decisionmaking process.

ADVICE ON THE SCOTTISH MINISTERIAL CODE COMPLAINT RAISED BY DOUGLAS ROSS MSP IN RELATION TO THE HALTING OF RAIL WORK BETWEEN HAYMARKET AND DALMENY IN DECEMBER 2022

TRANSCRIPT FROM THE OFFICIAL REPORT OF PARLIAMENT ON 18 MAY 2023 IN WHICH MR ROSS RAISES THIS MATTER

• 1. Douglas Ross (Highlands and Islands) (Con):

The *Daily Mail* has today reported that Scottish National Party minister Jenny Gilruth, who is sat just behind the First Minister, might have broken the ministerial code. The former Minister for Transport, whom Humza Yousaf promoted to be Cabinet Secretary for Education and Skills, changed plans that had been agreed for 18 months, with just weeks to go. The original plans would have involved a small closure to rail services around her constituency for a few days just after Christmas last year, to allow essential upgrades to happen. Jenny Gilruth appears to have forced a change in order to give preferential treatment to her constituents, at a higher cost to taxpayers and far more disruption to passengers. Does the First Minister think it acceptable for a minister to make a political decision for her own benefit instead of acting in the interests of all of Scotland?

• The First Minister (Humza Yousaf):

Douglas Ross is making a very serious accusation. Of course, if there are any accusations that the ministerial code is being broken, they will be appropriately investigated so, if Douglas Ross is making such an accusation, we will appropriately investigate it. However, I do not believe that the way in which Douglas Ross has characterised the situation is at all correct.

On Sunday 21 May, ScotRail's new timetable will come into effect. That is another important step, as Scotland's railways continue to recover.

Douglas Ross:

What does that have to do with the question?

The First Minister:

Such timetable changes happen regularly. When Jenny Gilruth was Minister for Transport, they happened for the correct reasons, according to the investigation that I did this morning, when the story that Douglas Ross talked about came into the public's consciousness.

We have invested heavily and significantly in railway services. We are proud to have taken ScotRail back into public ownership, and every decision that we make—every decision that any transport minister under this Government has made—is for the benefit of the entire railway network, including passengers up and down the country. I do not believe that the way in which Douglas Ross has characterised the situation is what took place, but I will, of course, investigate the issue further.

Douglas Ross:

Let us just clear up some of the things that the First Minister said. He said that he is going to investigate, but he also said that he investigated this morning and sees no fault in what Jenny Gilruth did.

He also questions my characterisation of what happened, so let us go through some of the pages and pages of the freedom of information emails that we have seen. A freedom of information response makes it clear that, instead of a few days of closures after Christmas, Jenny Gilruth pushed for changes that would lead to six weeks of disruption, including four full weekends. [Interruption.]

Jenny Gilruth is very keen to intervene, but I am just reading out what we have received—[Interruption.]

The Presiding Officer (Alison Johnstone):

Mr Ross, give me a moment.

I am absolutely sure that I do not need to remind members of the rules regarding behaviour in the chamber. I would be grateful if we could adhere to those rules.

Douglas Ross:

Jenny Gilruth seems to have a lot to say about this. It would be interesting to hear what she has told the First Minister, because ScotRail advises in these emails that the plans that Jenny Gilruth put forward would mean that 9,000 more customers every day would be disrupted. ScotRail reviewed the decision and concluded that there would be "greater costs with more customers disrupted or inconvenienced with a revised access plan".

Jenny Gilruth's decision to scrap those changes appears to have cost the taxpayer at least £1 million. Scottish Rail Holdings board papers, also released under FOI, state:

"The Board is asked to note that Network Rail and ScotRail chose to do the work at this time precisely to minimise the number of passengers impacted, and Transport Scotland were fully aware of and endorsed this approach".

How can Humza Yousaf defend Jenny Gilruth when she went against the advice of Network Rail, ScotRail and Transport Scotland?

The First Minister:

First and foremost—as I remember well from my time as transport minister—whenever such decisions are made it is crucial that we engage with communities. [Interruption.] It is so crucial that we engage with communities to understand from them what the impact of any potential closure will be. [Interruption.] I can hear groans from the parties at the sides of the chamber at the mention of engaging with communities, but we always engage with our communities when it comes to any potential disruption to our transport network.

The proposed decarbonisation works on the vital rail line would have caused significant disruption right across the whole east coast of Scotland, including for passengers travelling across—yes—Fife, but also to Dundee, Perth and Aberdeen. [Interruption.]

The Presiding Officer:

Members!

The First Minister:

The former transport minister has stated that she was not content that everything was being done to minimise inconvenience over a busy festive period when people were rightly travelling up and down the country to see their loved ones, particularly in the context of disruption that was taking place due to industrial action at the time. Therefore, and rightly in my view, she asked Network Rail to postpone the works—which it agreed to do—in order to give time to engage with the communities that would be impacted by the closure.

For me, whoever the transport minister is—whether it is Jenny Gilruth, as was previously the case, or the current transport minister—it is vital that the needs of passengers are always front and centre when such decisions are made. That was clearly the case when Jenny Gilruth made that decision.

Douglas Ross:

This is getting worse for the First Minister. He is now saying that Jenny Gilruth was right to do this. He also said that Jenny Gilruth, as the former transport minister, thought that there were problems with the matter. Well, we come to another email from 19 October 2022, which states: "Ms Gilruth understands why they are doing it but it is not going to land well."

She agreed with the proposal, but was worried about how it was going to land with her constituents. She should not even have been involved in the decision. She should have recused herself because of the clear potential for a conflict of interests.

Concerns were raised about the minister's actions. One civil servant, whose name is redacted in this FOI response, said: "It might be wise to be clear why this is appropriate for Fife in particular, because other areas might expect similar".

The political interference might even have forced a senior executive to resign. [Interruption.] Chris Gibb worked in the rail industry for more than 40 years. He chaired ScotRail in 2022. He resigned just a few weeks after Jenny Gilruth's decision—after he advised against the change. In board papers that we have seen, he raised concerns about political interference and "micromanagement by Scottish Ministers, advisors and officials."

First Minister, did Chris Gibb resign because of Jenny Gilruth's inappropriate actions?

The First Minister:

Douglas Ross is once again making really serious accusations without, I am afraid, any evidence. [*Interruption*.] He is hoping, because he is undoubtedly desperate, to throw as much mud as possible—[*Interruption*.]

• The Presiding Officer:

Members!

The First Minister:

He will throw as much mud as possible and hope that some of it sticks. I say to Douglas Ross that conflicts of interests and the Conservative Party are definitely not a combination that he should look to raise. [Interruption.]

In response to Douglas Ross reading out the emails, I say that he is being selective in what he reads out. He forgets to mention that the disruption that would

undoubtedly have been caused because of the works would have affected passengers travelling across not just Fife but to Dundee, Perth, Aberdeen and other parts of the network, too. As is absolutely right, I would expect my transport minister and any member of the Government to ensure that they take account of all those who might be impacted and affected.

I say to Douglas Ross that he should look at the facts, not just throw around mud hoping that some of it will stick. Speculation, to be frank, does not help anyone in the chamber and certainly does not help passengers for whom we are committed to improving the rail network.

Douglas Ross:

What did not help passengers was the former Minister for Transport's decision. She was emailed on 7 November 2022 at 17:40 and told by ScotRail that there would be greater costs and that more customers would be disrupted and inconvenienced with the revised plans. There will be at least £1 million extra in associated costs and 9,000 additional passengers every day will be affected because of the decision that she took, so the First Minister can cut out all that rubbish about standing up for passengers when it is clear that the decision that Jenny Gilruth took led to a poorer service.

It looks like there has been a clear breach of the ministerial code. Jenny Gilruth is smirking at that; well she might, because the First Minister already seems to believe that she is innocent. However, the ministerial code states that a minister "must keep separate" the role of a minister and their role as a constituency MSP.

This case looks not just like preferential treatment in the constituency but a truly awful decision that will cost taxpayers millions and lead to greater disruption. Five months on, the essential works that Jenny Gilruth delayed have still not happened. It looks like a clear-cut sackable offence. At the very least, it needs more than the First Minister looking at it over breakfast: it needs an urgent investigation now. Will the First Minister confirm to Parliament right now that he will launch an investigation into his minister today?

The First Minister:

To my understanding, this is not the first time that the issue has been raised. I think that it was raised months previously, as well. Of course, I was not First Minister at the time. As I said in response to Douglas Ross's first question, I will look at the accusations that are being made.

I say to Douglas Ross that Jenny Gilruth was not and is not also the MSP for Dundee, Perth or Aberdeen. The decisions were taken because the works would affect railway passengers right across the network, particularly in the north-east of Scotland. [Interruption.]

The Presiding Officer:

Members!

The First Minister:

From the information that I have in front of me, it seems to be pretty clear that Jenny Gilruth made those decisions so that disruption would not affect more passengers right across the network. I would have expected her to do that at the time and would expect the current Minister for Transport to do it. When vital works,

particularly on decarbonisation, have to take place, we have to ask how we do them in a way that minimises disruption, particularly during the busy festive period.

I say to the Conservatives that we take the ministerial code extremely seriously, which is not something that could be said about them in any way, shape or form.

Dear First Minister,

I am writing to you today to request you formally investigate Jenny Gilruth MSP over a potential breach of the ministerial code relating to the halting of rail work between Haymarket and Dalmeny late last year. As you will know, Ms Gilruth has been accused of halting vital rail work so that her constituents would not be inconvenienced over the festive period.

Because of this, commuters may now have to suffer from weeks of disruption, rather than the eight days of works that was originally planned.

If found to be true, this would constitute a breach of the ministerial code under paragraph 7.5, which states 'Where Ministers have to take decisions within their area of portfolio responsibility which might have an impact on their own constituency or region, they must take particular care to avoid any possible conflict of interest.'


You will have noted from First Minister's Questions that there were many concerns raised about Jenny Gilruth's decision in emails we have seen that were released through FOI.

Thank you for your email of 18 May, in which you asked me to investigate whether Ms Gilruth might have breached the Scottish Ministerial Code during her time as Minister for Transport, in taking the decision to postpone planned rail works between Haymarket to Dalmeny late in 2022.

I have considered this matter carefully and I am confident that it does not constitute a breach of the Scottish Ministerial Code.

It is evident not only in Scottish Government advice on these rail works but also in Scotrail's own paperwork that whilst Ms Gilruth's constituency was affected, so were many others across Fife, central Scotland and the East coast of Scotland, with the likelihood of reduced services between Edinburgh and Dundee, Fife to Edinburgh, and up to Perth. There was also likely to be service disruption on the Aberdeen to Edinburgh route. There is no evidence to suggest that Ms Gilruth's constituency would have been impacted to a greater degree than any of the other constituencies. I am therefore satisfied that there was no impropriety and that Ms Gilruth was acting entirely legitimately in seeking advice on the network wide impact of rail works on a major piece of national infrastructure.

As Minister for Transport, it is reasonable that Ms Gilruth sought assurances from Scotrail that a full range of considerations had been taken into account when planning works that involve service upgrade, and to ensure for community engagement and discussion as part of that planning process. This was particularly true of the year in which rail services had come into public ownership. Those wider considerations included the shift in working patterns, the use of the rail network and passenger demand, with weekends and public holidays no longer necessarily being the quietest periods and this being the first festive period since 2019 when people had been able to travel without pandemic restrictions. I am therefore of the view that Ms Gilruth acted in a manner consistent with her portfolio responsibilities in determining how to minimise disruption to the public, in light of these wider factors.

For the above reasons, I am of the view that there has been no breach of the Ministerial Code. HUMZA YOUSAF First Minister of Scotland
