Please see lines below around transmission. SMO has checked them. We've also found some correspondence from earlier in the programme about it. The policy team's position and advice was consistent in that there was initially no data and then limited evidence of impact on transmission. If you would like me to forward you any emails or links we have found, let me know.

Questions around the Covid passport are probably best answered by the Certification Team & Covid Ready Society. We also think that it would be worth reaching out to CMOs office, as the team recall some discussion with his office around the messaging of this.

The Evidence Paper on Transmission Risk: **3. Transmission in a vaccinated society - Coronavirus (COVID-19) vaccine certification: evidence paper - gov.scot (www.gov.scot)** is a useful one. Certain points pop out:

- Vaccines help prevent transmission of the virus as vaccinated people are less likely to become infected and ill than unvaccinated people (and only infected people can transmit the virus).
- Data from Scotland in 2021 revealed that household contacts of vaccinated healthcare workers are at reduced risk of becoming a case, at a time when the Alpha variant was dominant[45]
- The consensus view of The Vaccine Effectiveness Expert Panel (VEEP) was considered at SAGE 95 on 9 September 2021[43]. VEEP stated that "for the

Alpha variant, there is ~40% reduction in onward transmission from vaccinated but infected people after one dose of the AstraZeneca vaccine, and ~45% for the Pfizer vaccine"[44].

- Data from Israel also indicated that the vaccine helped prevent transmission in breakthrough cases at a time when the Alpha variant was circulating[46] [47].
- Given the above expert advice and evidence, vaccination was recommended to reduce transmission. Even a small effect on preventing transmission can have major additional benefits, especially in health care settings, where staff could expose multiple vulnerable patients.

As [REDACTED] search indicates, it's hard for us to answer this comprehensively.

The enquirer hasn't referred to any specific comms products and it would be significant work for us to trawl through all social posts to identify whether we ever used that sort of messaging in our organic social media content. I'm therefore not sure it'll be feasible for us to respond specifically about organic social products without clarity from the enquirer on what they mean by "across all media" and "this messaging". Ideally we need to know what posts they are talking about. Without that steer I feel this could be too vague for us to conduct a comprehensive search – we don't hold data about our social posts in that way.

Worth noting that gov.scot hosts transcripts of all the Covid briefings and these are also available in full on YouTube. There's also this interview with Jason from August 2021 which touches on this in a couple of the questions. We would need to consider whether we consider these sorts of products, and any associated sharing of them across any SG channels, as in scope too.

## FOISA Exemptions Applied

The exemptions applied in this instance were:

1. An exemption under Section 30(b)(ii) of FOISA (Free and Frank exchange of views) has been applied to information within scope of this request. This exemption applies as disclosure would (or would likely) inhibit substantially the free and frank exchange of views for the purpose of deliberation.

This exemption is subject to the 'public interest test'. Therefore, taking into account all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of an open, transparent and accountable government. However, as stakeholders were informed that comments would be in confidence, there is a greater public interest in allowing stakeholders to share their views with officials in a confidential forum to ensure free and frank discussion where views can be deliberated. Disclosure of this information could result in a breakdown in the relationship with key stakeholders and result in stakeholders sharing limited views in future which may have a wider impact on Scottish Government policy.

2. An exemption under Section 30(b)(i) of FOISA (Free and Frank provision of advice) has been applied to information within scope of this request. This exemption applies as disclosure would (or would likely) inhibit substantially the free and frank provision of advice.

This exemption is subject to the 'public interest test'. Therefore, taking into account all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of an open, transparent and accountable government. However, there is a greater public interest in allowing a private space for officials to discuss requests and to provide free and frank advice on the proposed handling of any case to ensure all relevant information is released.

3. An exemption under Section 36(1) of FOISA (confidentiality in legal proceedings) has been applied to information within scope of this request.

This exemption is subject to the 'public interest test'. Therefore, taking into account all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is some public interest in release as part of open and transparent government, and to inform public debate. However, this is outweighed by the strong public interest in maintaining the right to confidentiality of communications between legal advisers and clients, to ensure that Ministers and officials are able to receive legal advice in confidence, like any other public or private organisation.

4. An exemption under section 38(1)(b) of FOISA (personal information) applies to some of the information requested because it is personal data of a third party, i.e. names and contact details of non-senior staff and disclosing it would contravene the data protection principles in data protection legislation. This exemption is not subject to the 'public interest test', so we are not required to consider if the public interest in disclosing the information outweighs the public interest in applying the exemption.
