If not, he understands that the family and their legal team are likely to speak again to the media to put further pressure on the Pakistani authorities to resolve the case.

8. The First Minister further advised that we stand ready to work with Mr Asghar's family and legal team regarding a prisoner transfer. He said that we have made it clear Scotland has the necessary experience in prisoner transfer, a law on the statute book and the Scottish Prison Service (SPS) stands ready to facility.

You will be aware of the case of Mr Mohammed Asghar, who has been sentenced to death for blasphemy in Pakistan and whose case has received widespread publicity. Mr Asghar previously lived in Edinburgh and as a Government we have made representations to Pakistani authorities about his situation. Fiona Hyslop MSP, Cabinet Secretary for Culture and External Affairs wrote to the Consul General of Pakistan on 28 January; the First Minister spoke with Governor Sarwar on 29 January and wrote to the Chief Minister of the Punjab and Governor Sarwar on 30 January; and Mr Yousaf spoke with Mr Asghar's daughter on 5 February.

Mr Yousaf has also met with Mr Asghar's lawyer, and with Ansar Burney, a leading Pakistani human rights and civil rights activist.

1. The First Minister met with [REDACTED] Mr Asghar's daughter, and Mr Anwar, the Asghar family lawyer, to discuss Mr Asghar's current situation in Pakistan and to offer the Scottish Government's support.

2. The First Minister offered his and the Scottish Government's on-going support to the Asghar family during this very difficult time. He said how shocked we were to hear the news that Mr Asghar had been shot in prison. He explained the Scottish Government had raised our concerns about Mr Asghar's situation in prison many times over the last 9 months.

3. [REDACTED]

4. [REDACTED] explained to the First Minister that her family are under a lot of stress. She said they are frightened to receive phone calls because it could be bad news. They are even more concerned about their father's safety after the shooting and said that if he is not safe in prison how can he be safe anywhere in Pakistan.

5. She said the family had been asked to remain silent for security reasons; however, this has not helped their father as he was shot in prison. She feels that they need to speak out.

6. The First Minister thanked them both for the update on the situation. He reiterated that he and the Scottish Government had been involved in the case since January and had raised Mr Asghar's case personally with Governor Sarwar on a number of occasions and written to him. [REDACTED]

7. The First Minister proposed that under the circumstances he should speak with the Prime Minister and ask him or the Foreign Secretary to personally intervene in the case. He explained that there have been no repercussions against the Pakistani side for their delaying tactics; it was now time to send a clear message to them that if a decision is not made there will be consequences.

8. The First Minister also advised that he would suggest to the Prime Minister that either he or the Foreign Secretary meet the family in London on Friday with Mr Ellwood.

FMQ TOPICAL PICK: Mohammed Asghar: 6 November

TOP LINE:

We are shocked that Mr Asghar, a vulnerable elderly man who has a history of mental illness and suffers from poor health, has been the victim of a shooting in prison in Pakistan. Our thoughts are with Mr Asghar and his family at this very difficult time. We have repeatedly raised our concerns with the Pakistani authorities regarding Mr Asghar's condition and safety in prison over the last year. We are monitoring the situation closely and are in contact with the Foreign and Commonwealth Office, Mr Asghar's family, his lawyer and Reprieve, the human rights NGO supporting Mr Asghar and family.

KEY POINTS:

1. We remain extremely concerned for Mr Asghar's health and safety at this time and call on the Pakistani authorities to ensure he is appropriately protected.

• Mr Asghar was apparently shot by a member of the elite police force on the morning of 25 September, whilst in his prison cell at Adiala jail in Rawalpindi.

• He suffered an injury to his shoulder. His physical condition has greatly improved and he has been receiving medication. Nonetheless, Mr Asghar continues to suffer from mental illness and, as a result of his age and confinement, a degree of physical frailty.

• He was moved on 16 October to a new location where he is receiving appropriate treatment and is under close protection.

• Mr Asghar was seen on Saturday 4 October by a medical board to assess his mental health. He is due to receive a fuller medical assessment, though no date has been set for this yet. We are pushing the Pakistani authorities for this to be carried out as soon as possible so that the authorities and legal process in Pakistan are able to acknowledge that he is sick.

• I met with Mr Asghar's family on 15 October

• I spoke to the Prime Minister on 16 October and asked that the Prime Minister and Foreign Secretary provide assurances to the family that everything will be done to ensure his safety - the Prime Minister wrote to me on 3 November to assure me of the seriousness with which the FCO is dealing with this.

2. We are in close contact with the FCO and the Pakistani authorities regarding the case, as well as the family, and Mr Asghar's legal team, to secure the best possible outcome.

• The Scottish Government has repeatedly raised our concerns with the Pakistani authorities regarding Mr Asghar's condition and safety in prison over the last year. This has included writing to the Pakistani Government and four separate meetings with Governor Sarwar.

• The Pakistani authorities are committed to carrying out a full medical assessment. Governor Sarwar was reported (31 October) as saying that that they are "giving this matter a great deal of interest and care" and that legal experts were looking at resolving the case to the satisfaction of Mr Asghar's family. Scottish Government officials continue to liaise with the Pakistani authorities.

• The British High Commissioner continues to meet with both the Chief Minister and the Governor of the to discuss Mr Asghar's situation, including his security and sentence.

• The FCO and Scottish Government are liaising with Mr Asghar's family here in Scotland and his wife who is in Pakistan. I met his daughter on 15 October.

• We will continue to press the Pakistani authorities to protect Mr Asghar and ensure that his mental health is taken into consideration in the legal process.

3. Blasphemy and the Death Penalty in Pakistan

• Dysfunction in Pakistan's rule of law system, coupled with the weak legislation, leaves the way open for misuse of the blasphemy laws to settle vendettas or resolve legal disputes.

• Mr Asghar was sentenced to death in Pakistan on 23 January this year under blasphemy laws. The charges against him were brought by a neighbour who was in a dispute with him.

• Mr Asghar is a vulnerable individual. He has a history of mental illness and his diagnosis of paranoid schizophrenia (a diagnosis made in Edinburgh) was not taken into account during his trail.

The Scottish Government strongly opposes the death penalty in all circumstances.

This continues to be a very sensitive issue and Mr Asghar's current whereabouts should not be mentioned, nor should the fact that the Prime Minister spoke to the Prime Minister of Pakistan on 28 October.

Dear Governor Sarwar

I was grateful for our discussion yesterday on the worrying case of Mohammed Asghar. As I explained, I, along with many people in Scotland, am deeply concerned about Mr Asghar's situation. He is a vulnerable individual, with a history of mental illness and poor health. I therefore write to ask that the relevant authorities in Pakistan take all necessary steps to ensure Mr Asghar's safety and security.

I would like to draw attention to the concerns expressed publicly by Mr Asghar's former legal representatives ([REDACTED], JPP and the NGO Reprieve) about this case, including the evidence presented in relation to Mr Asghar's state of health.

Mr Asghar suffered a stroke in 2000, which has had a severe impact on his physical and mental health. Following the stroke he suffered from depression, grandiose and persecutory delusions, and auditory hallucinations. In 2010 Mr Asghar was diagnosed with late onset Paranoid Schizophrenia, and detained under the Mental Health Act.

[REDACTED], the psychiatrist and senior consultant who supervised Mr Asghar's treatment at the time, has completed an affidavit regarding his medical condition. I have enclosed a copy for your information. From the affidavit you will see that Mr Asghar remained seriously ill, and went on hunger strike. He was treated with antipsychotic drugs, and [REDACTED] has stated that he will need to take antipsychotics for the rest of his life. [REDACTED] feels it is unlikely that Mr Asghar continued to take this essential medication in Pakistan. It is [REDACTED] opinion that the behaviour which resulted in Mr Asghar's conviction is entirely consistent with a worsening of his schizophrenia. As a mental health professional, she is extremely concerned about his wellbeing in prison, where he has not been receiving

appropriate treatment and his condition will continue to deteriorate. There is also a serious possibility that Mr Asghar could attempt to commit suicide in prison, as indeed he has done before.

As you will appreciate, I feel it is imperative that Mr Asghar's medical situation is taken into account, and that everything possible is done to ensure that this very ill man is able to return to the medical care that he needs. I have written in the same terms to Chief Minister Muhammad Shahbaz Sharif.

1. The Minister thanked the family for meeting with him. He expressed his and the Scottish Government's full support to them and their father. He also praised them on their courage throughout this three year ordeal.

2. The Minister was advised that Mrs Asghar was still in Pakistan and was allowed to visit her husband every Thursday for one hour. His daughters have also visited; the last visit was in December.

3. The Minister was advised that Mr Asghar's appeal process could take between 3 and 5 years. [REDACTED], explained:

• Mr Asghar's doctor [REDACTED], has submitted an affidavit summarising Mr Asghar's mental health history and his NHS records;

• There is provision in Pakistan law for prisoners to have their sentence suspended on medical grounds pending the outcome of their appeal, this is like bail, and restrictions can be imposed;

• It can take at least 6 months before Mr Asghar's litigation on suspension of sentence comes before a judge;

• [REDACTED] explained that in 2010 certain powers were transferred from the Pakistani Federal Government to State Governments and this included issues around mental health;

[REDACTED] also explained that Governor Sarwar has the power to pardon Mr Asghar; Discussions did take place with one of the Deputy Prosecutor Generals of the Punjab and the Sub – Committee on Human Rights of the European Parliament wrote to the Prosecutor General about Mr Asghar's case.

5. The family advised that Mr Asghar has faced a number of security issues. Given the sensitivity of blasphemy cases no details were released about Mr Asghar's case;

- Once his case was in court information got out;
- When he was in hospital for treatment a crowd demonstrated outside;
- He has had extra security guards posted at his cell in the past;
- He is now sharing a cell with three other men, not sure if this is ideal;

6. The family advised that they are in contact with the FCO and get calls on a regular basis. Also Mr Asghar's lawyer and [REDACTED] are meeting with [REDACTED] from the British High Commission tomorrow in London to discuss the case.

Action Points

- Confirm the powers Governor Sarwar has regarding pardoning prisoners;
- Details of the Pakistani psychiatrist.

8. The Minister agreed to:

• Call Governor Sarwar's office to discuss access by a psychiatrist to assess Mr Asghar;

• Speak with the Scotland Office Minister to discuss the case and what further steps can be taken by both Governments.

• Also suggest Mr Asghar's case is brought up during the upcoming visit to the UK by the Prime Minister of Pakistan.

• Speak with Sarah Belal, Mr Asghar's lawyer to discuss his security and any other issues not covered by this meeting

12. BRIEFING NOTE ON MR ASGHAR - FOR INFORMATION

We have been advised that Mr Asghar's medical assessment was supposed to take place today (Thursday 18 December). We are unsure when the results of the assessment will be released by the Pakistani authorities.

The three possible outcomes Mr Asghar's legal team (Reprieve) are working on at the present time are:

• The medical assessment concludes and confirms that Mr Asghar suffers from severe mental illness;

- The medical assessment is not completed; and
- The medical assessment is completed but does not accurately reflect Mr Asghar's severe mental illness.

We should be prepared to issue media lines when the outcome of the medical assessment is released. I can offer the following:

The Scottish Government welcomes the outcome of Mr Asghar's medical assessment in which is confirms that he is mentally ill. We call on the Pakistani authorities to suspend Mr Asghar's sentence and send him home to his family here in Scotland.

The Scottish Government is very disappointed that Mr Asghar's medical assessment has concluded that he is not mentally ill. We dispute this and have evidence to show that he has been suffering from severe mental health issues for a number of years.

MR ASGHAR CASE: WHAT HAPPENS NEXT?

I thought it would be useful for the Minister if I set out what may happen next regarding Mr Asghar's case once his medical assessment has been completed and the various options open to the legal team.

Medical Assessment

The Minister is aware that Mr Asghar is currently undergoing a medical assessment at the [REDACTED] in Lahore. The Pakistani authorities have estimated the assessment could take up to 2 months. At the present time we still don't have a definite timeline when the medical assessment will be completed.

Reprieve has advised that they have not been given any information by the Pakistani authorities about any assessments completed to date. They have filed a litigation asking for medical records and had a hearing this week so we may know a bit more after that.

We understand Mr Asghar will stay at the Institute once the medical assessment is completed and not return to prison.

The Legal Route

[REDACTED]

Prisoner Transfer

Mr Asghar's legal team think that they should look at executive action before going back to Court. They advise that the quickest type of executive action will be suspension of sentence on medical grounds given that lengthy diplomatic negotiations about the meaning of various provisions of the Transfer Agreement would be necessary before the Agreement could be implemented in this case.

Possible visit to Pakistan by Mr Yousaf

The Minister is aware of the recent advice from the FCO regarding travelling to Pakistan to discuss Mr Asghar's case. Mr Asghar's legal team have also advised me that they think that it would be best for the Minister not to travel to Pakistan until we know the outcome of the medical assessment. [REDACTED]

If Mr Asghar's medical assessment does conclude that he is mentally ill then it may be helpful for the Minister to travel to Pakistan with the objective of ensuring that the Punjab authorities use this as a catalyst to grant the s.401 application.

If the medical assessment concludes Mr Asghar is not mentally ill then we would need to discuss with the FCO and Mr Asghar's legal team want the next steps are and if a visit by the Minister would be helpful

It should be noted that this advice is dependent on the Pakistani authorities agreeing and making decisions.

We are keeping in touch with Mr Asghar's legal team and the FCO and will advise the Minister of any further developments.

• Opportunity to discuss the current situation regarding Mr Asghar and what further help the Scottish Government could give.

What happened to Mr Asghar in prison

- Mr Asghar was apparently shot by a member of the elite police force Con the morning of 25th September, whilst in his prison cell at [REDACTED]. Another prisoner was killed in the attack.
- Mr Asghar suffered a number of injuries. His physical condition is stable and he is conscious and talking and remains under close protection.

Discussion Points

- Welcome the opportunity to discuss the latest situation regarding Mr Asghar.
- Mr Anwar has called on the UK Government to ask the Pakistani Prime Minister to release Mr Asghar. He said on Friday:

"It is unacceptable that this poor, old, seriously ill man is sat in a prison presently in a hospital - and is facing death. He needs to come home to his family."

• We have repeatedly raised our concerns with the Pakistani authorities regarding Mr Asghar's condition and safety in prison over the last year.

• We are monitoring the situation closely and have been in contact with the Foreign and Commonwealth Office, Mr Asghar's family and Reprieve.

• The Scottish Government have repeatedly raised our concerns with the Pakistani authorities regarding Mr Asghar's condition and safety in prison over the last year. The First Minister has meet and written to Governor Sarwar twice.

• The latest contact we have had with the Pakistan Government was a letter from the Minister for External Affairs and International Development to Mr Aizaz Ahmad Chaudhry, Foreign Secretary of Pakistan, on Friday 26 September expressing our concerns regarding Mr Asghar's health and safety. We requested assurances to:

Guarantee Mr Asghar's safety and security whilst in custody;

Guarantee access to Dr [REDACTED], to conduct a psychiatric Assessment of Mr Asghar; and A commitment to serious discussions with all those concerned including the Asghar family, the UK and Scottish Governments

and the Pakistani Judicial authorities to find a solution in which Mr Asghar can return to Scotland.

• UK Consular staff have continued to visit Mr Asghar since he was shot on Thursday. They visited him today and have been advised that Mr Asghar will stay in hospital for the next 72 hours.

• The British High Commissioner will be in Lahore on Thursday and Friday this week to hold high-level meetings with the Punjab Government to discuss the next steps on where Mr Asghar should be sent once discharged from hospital.

• We will continue to push the Pakistani authorities to agree to an independent psychiatric assessment of Mr Asghar by [REDACTED]. We believe this is something that the Pakistani authorities should be able to do and quickly.

• An independent psychiatric assessment of Mr Asghar is important for his current appeal, it should show that he is mentally ill and should not have been convicted and therefore should be released.

• There is a **Prisoner Transfer Agreement (PTA)** between the UK and Pakistan. It lapsed but was reintroduced in July this year.

• A PTA should be discussed with the Pakistani authorities but the main focus should be the independent psychiatric assessment.

• As far as we are aware, the key difficulty with this approach is that if the PTA process is begun, the appeal process lapses. If the PTA is rejected, a fresh appeal will need to be lodged, and the length of time Mr Asghar stays in prison is extended.

• As the PTA process needs to be instigated by the prisoner (through his legal team) there is little more that we can do to influence this process, beyond that which we have already done i.e. signalling that such a request would be considered favourably in Scotland.

I would be grateful if you could keep officials regularly updated on this as the First Minister will be happy to write again to the Governor if there continues to be no movement on the issue of access. TOP LINE:

The Scottish Government remains deeply concerned about the welfare of British National Mohammed Asghar, who was sentenced to death in Pakistan for blasphemy on 23 January 2014.

We are monitoring the situation closely and are in regular contact with the Foreign and Commonwealth Office and the NGO supporting Mohammed Asghar and his family.

• The Cabinet Secretary for Culture and External Affairs wrote to the Pakistan Consul General on 28 January

• First Minister wrote to the Governor of the Punjab and the Chief Minister on 30 January

• The UK Government have made representations to the Government of Pakistan and have met the Governor and Chief Minister of the Punjab

- Mr Asghar's lawyers are in close contact with him and his family in Scotland
- Mr Yousaf meet with Mr Asghar's family on 18 February
- First Minister meet with Mr Burney on 20 February.

• Mr Yousaf wrote to Governor Sarwar on 13 March regarding access being denied by a leading psychiatrist.

2. We have major concerns about this case

• The Scottish Government strongly opposes the death penalty in all circumstances

• Mr Asghar is a vulnerable individual. He has a history of mental illness and suffers from poor health

• We are concerned about his health and mental state which were not taken into consideration in the trial

• Minister for External Affairs and International Development meet with Reprieve and Mr Asghar's family last week to get an update on the case and Mr Asghar's current condition.

3. Current situation

• Pakistan authorities have agreed that fortnightly FCO consular visits can be undertaken.

- We are also pleased that his appeal was filed on 31 January
- Pakistan has had a moratorium on the death penalty in place since 2008

4. Concerns for his health

- Mr Asghar has suffered from mental health difficulties for some time
- We are also concerned that he does not have access to the medial support that he requires and given his state of health, through our representations we are asking the Pakistan authorities to ensure he has access to medical support.

As you are aware the Scottish Government has been monitoring the case of Mr Mohammed Asghar. I met with his family on 18 February and received an update on the case.

On Friday I was advised that the request by Mr Ashgar's legal team for access by [REDACTED] evaluate Mr Asghar's mental state had been granted by the Punjab Home Department. However, it appears that the Home Department has only forwarded the request to the Inspector General of Prisons, who forwarded it to the Deputy Inspector General of Prisons. I understand the Deputy Inspector General has advised that the request be rejected but no final decision has yet been made by the Inspector General or the Home Department.

We are concerned that this evaluation has been delayed again to the determinant of Mr Asghar's health. We would urge the Punjab Government to do all it can to help facilitate access by Professor Ahmed to Mr Asghar as soon as possible.
