Thanks for views. To clarify, the £56m is on top of the £700m. To my knowledge we have made no public statement on how this £56m will be used – the CES press release said "A total of £56m will be paid by the successful applicants in option fees and passed to the Scottish Government for public spending".

We'd hadn't built this funding into future plans so it doesn't directly impact on NZ planned spending as you say – however there is an opportunity cost from it not being available to support unfunded pressures in the net zero space in the future.

We could change the wording to more on the lines of "we are utilising £56m of Scotwind clearing revenues for [redacted – section 30(b)(ii)]

Would that be preferable?

Hi Annabel, Kerry, Kersti,

Finance are pulling together input for DFM's upcoming speech to Parliament on the Emergency Budget Review. DFM is keen to highlight some of the hard decisions we are taking to find resources to tackle the cost crisis. Re Scotwind, we had included £41m of Scotwind revenues (from the £700m total) in 22-23 Budget as you know. Scotwind clearing process has since generated a further £56m of revenues, and Finance are building this into the central position as additional funding to mitigate new pressures such as higher public sector pay rises than planned given the cost of living crisis. This hadn't been the intention – the Scottish Budget 22-23 had indicated that Scotwind revenues this year would be invested in projects supporting our transition to net zero.

Can I check please that you're content that one of the examples of difficult decisions for DFM's speech will reference this, to be phrased as something similar to: we are utilising the £56m Scotwind clearing revenues for [redacted – section 30(b)(ii)] [NB the value of £56m is already in the public domain via Crown Estate Scotland press release]
