#### PLANNED CARE WAITING TIMES TARGETS - PROGRESS UPDATE 13 JAN 2023

#### PRIORITY AND PURPOSE

This is a routine submission to provide the First Minister and Cabinet Secretary for Health and Social Care with an update on progress against the delivery of the planned care waiting times targets.

#### **CONTEXT AND ISSUES**

Officials last met with the Cabinet Secretary on 7 December to provide an update on progress towards the long wait targets.

### Latest Performance Update

NHS Lothian

CfSD are re-engaging with the Board around efficiencies which might be made in Dermatology OPs. The Board report there are still one or two very long waits on their list, due to patient availability, and they plan to bring these patients in as soon as possible. The Board are also being supported by NECU to undertake a validation exercise for a proportion of their Orthopaedic list, however significant pressures remain in this area as capacity is being used for urgent care, while inpatient beds are not available for recovery.

### **OPTIONS CONSIDERED AND ADVICE**

Boards continue to submit monthly updates to CfSD on progress across High Impact Programmes, meeting monthly with CfSD to assess, review and improve processes and data quality. To date, there has been significant progress against 22/23 NHS Recovery Plan commitment to release OP activity through redesign [Redacted – section 30(b)] with Boards indicating the potential to be even more productive and are aiming to achieve significantly more than this year's commitment [Redacted – section 30(b)]

Planning for 2023/24 is underway to expand the specialties covered for ACRT and PIR to align with additional OP commitment in Recovery Plan for 23/24.

The NECU Team continue to scope and implement capacity solutions for NHS Boards, [Redacted – section 30(b)]

Specialty Delivery Groups (SDGs) have met over the last month with a specific focus on sharing best practice and opportunities around day-surgery given winter bed pressures. Planning sessions are being delivered over January and February to develop SDG workplans and deliverables for 2023/24.

#### **CONCLUSION AND NEXT STEPS**

As a key support function for NHS Boards, NECU will now support the administrative and clinical validation for patients waiting over one year across inpatient and outpatient services in the following key specialties:

- ENT
- General Surgery
- Gynaecology
- Orthopaedics
- Urology

These are the key specialities that have been impacted due to the recent NHS pressures, and have some of the longest waiting patients, therefore NECU will now be able to support the delivery of high volume waiting list validation. We have asked that the NECU team at CFSD work with NHS Boards to support this validation campaign.

We have also been working with NHS GJ to identify any potential theatre capacity, which can be made available to Boards immediately. Weekend capacity has been identified within Orthopaedics, cath labs, Day-Surgery unit, General Surgery, Ophthalmology and also for CT and MRI. These sessions are not currently staffed therefore further discussions on an individual Board basis are required to identify opportunities to utilise appropriately.

This, and the validation work, will be supported by some slippage in our 2022/23 allocation. We will continue to work closely with the Boards and the CFSD team to monitor uptake and progress of this work over the coming weeks and months

#### Earlier Cancer Diagnosis

CfSD are also establishing a National Bronchoscopy & EBUS Training Programme for NHS Scotland through the NHS Scotland Academy (hosted at the NHS Golden Jubilee) which will, in part, address an unmet need in providing better EBUS staging for lung cancer patients in Scotland, ultimately contributing to improved lung cancer outcomes.

The two new Rapid Cancer Diagnostic Services (RCDS) in NHS Lanarkshire and NHS Borders are working on go live dates, and announcements will be coordinated with SG and CfSD comms.

### NHS Ayrshire & Arran

The majority of patients waiting >104 weeks and >78 weeks are now within one specialty: Diabetes and Endocrinology. To help address this, a NECU-lead mutual aid arrangement was commissioned by the Board to support a waiting list validation exercise in December 2022. However due to a clinical issue, this support was temporarily paused in January, with the subsequent impact to date therefore smaller than anticipated. This arrangement is expected to recommence in late-February, and steady ongoing progress to reduce long waits is expected to follow.

Insourcing clinics to support this speciality are underway, and an initial NECU facilitated meeting between Ayrshire & Arran and NHS Grampian was held on 7 February to discuss options for mutual aid. A follow-up meeting for clinical staff to agree processes will be arranged as soon as possible.

NECU-lead mutual aid for Neurology remains paused, pending resolution of clinical concerns, however some Board-led waiting list initiatives and additional insourcing are underway in the interim.

The Daily Mail have asked for a comment on research from Aberdeen University which claims patients will wait up to seven years for hip and knee surgery:

I have spoken to researchers at the University of Aberdeen who predict that patients face waits of up to seven years for hip and knee surgery because more patients are being added to the list than treated.

Now they say the worst case scenario of seven year waits is looking more likely because waiting times have worsened and elective surgeries were reduced during the winter pressures.
