The survey collected information from veterans on a range of topics to understand current access to and perception of services in addition to veterans' experiences and circumstances. Officials liaised with the Scottish Prison Service to help enable the inclusion of veterans in prison. The survey ran from November 2022 to February 2023, with over 2300 2230 responses received from veterans in Scotland. First findings are expected from Autumn 2023. Officials have submitted analysis proposals to ONS, and will continue to work with them to develop findings and outputs for Scotland. Scottish Government and NRS analytical officials have began scoping the feasibility of analysing veteran suicides in Scotland through data linkage. A media event will be held that morning at a local Edinburgh primary school for broadcast journalists and news photographers. This will be led by NRS. Cab Sec CEAC to notify Parliament via a GIQ after FMQs.

14 SEP: Office for Statistics Regulation to publicly confirm census outputs are to be designated as National Statistics and will therefore form an integral part of the statistical system in the UK.

The information published through census outputs will help to shape Scotland for future generations and is an asset for Scotland.

- Scotland has relied for more than 200 years on the information the census provides.
- It remains the best way to gather vital information which government, councils, the NHS and a range of users in the public, private and third sectors need.
- The results help local authorities, businesses and the government plan a wide range of vital public services, to improve the lives of those living and working in Scotland.

Since completion of the collection phases of Scotland's Census 2022, NRS has been processing and quality assuring the data, and making use of other administrative data sources.

- This builds on the almost 90 % national return rate achieved through collection and enables robust, reliable estimates for the whole population to be provided.
- The innovative statistical approaches applied have been steered by a group of international independentt census and statistical experts.
- NRS has engaged with stakeholders to ensure users of the data can have confidence that the updated methodology provides full population coverage.
- The timetable for publishing all the results is:
 - Population estimates at local authority level today (14 September 2023);
 - Local area statistics (c50 households) being provided in spring 2024; and
 - Detailed household characteristics, such as information on ethnicity, employment, education, sexuality, carers and veterans, from summer 2024 onwards.

An evaluation of Census 2022, with a focus on lessons learned for any future Census and other complex programmes, will be prepared for Ministers and provided to Parliament by the end of 2024.

Update from Scotland – Ally

Scotland's Census publishes next week (14 Sept). NRS have this week received National Stats Accreditation, the International Steering Group have commended them on that adaptation of the methodology given the higher than anticipated non-response rate, and I led a small group of experienced analysts to review the output, which I am happy about and am publicly stating that analysts and general public should have confidence in the population estimates.

Follow on work to provide the small area statistics will begin shortly and the team are working to a similar schedule as rest of UK, albeit one year later. We are in discussion with IDP on provisioning Census 2022 data to provide a full UK wide dataset, however this has slowed and currently looking at IG issues with providing 2011 data. Once resolved will look at 2022.

Cabinet Secretary for Constitution, External Affairs and Culture Angus Robertson said:

"Today's publication represents a historic moment with the largest population ever recorded by Scotland's Census of 5.4 million, an increase of 2.7% since the previous census in 2011.

"It confirms this growth has been driven by inward migration, demonstrating that Scotland is an attractive place to come to live and work.

"We know however that Scotland faces an ongoing population challenge with fewer births than deaths registered in Scotland since 2011, which reinforces just how damaging Brexit will be to Scotland with the loss of freedom of movement."

"As outlined in the Programme for Government, the Scottish Government is however taking action: we will publish an Addressing Depopulation Action Plan which will set out the first phase of our response to population decline occurring in some of Scotland's communities. We will also introduce a Talent Attraction and Migration Service to support more people to live and work here.

"We have also called on the UK Government to devolve immigration powers to the Scottish Parliament and work with us to deliver our proposal for a Rural Visa Pilot to enable rural and island communities to attract migrants in line with local needs. "The census also shows that in common with many countries our population is aging. Understanding these changes in the population will allow local authorities, businesses and the government to adapt vital public services to better meet the needs of those living and working in Scotland – including our large, established migrant community, whose contribution we greatly welcome. Today's results also show a trend towards smaller households and more households overall, which further demonstrates the importance of our strategy to tackle social isolation and loneliness through stronger social connections, and our continued funding for organisations working to address this issue.

"Following the collection of Scotland's Census 2022, NRS updated its statistical methods to ensure outputs represent 100% of Scotland's population. This approach has been commended by the independent Office for Statistics Regulation (OSR) who have awarded Scotland's census outputs National Statistics designation based on the high quality and good practice of the statistics.

"The updated methodology was supported by a panel of independent international census and statistical experts, who have worked closely with NRS since the collection period."

Your question around census lessons learned was passed onto us at NRS, and I've discussed it with [redacted] as we are working jointly on different aspects to make sure we cover all the bases. Very happy to discuss at any point if that would be helpful.

You will recall the permanent secretary provided an update to FPAC on 1 June, setting out the commitment to provide lessons learned to Parliament by the end of 2024 (extract below). There are three broad strands to the work currently:

- NRS continue to adapt the programme with the lessons learned as we move into the outputs phase.
- NRS is working with the SG chief statistician team to consider the broader, strategic lessons learned that informs the wider use of statistics in the future, including surveys, data processing and potential future census. We are working towards a joint Ministerial submission and discussion around this in the autumn.
- NRS is working with SG digital assurance office on case studies taking forward the learnings for other major programmes.

Census Lessons Learned Having completed the Collection phase of the Census Programme, National Records of Scotland (NRS) are working to deliver the planned programme of analytical products starting later this year and running, as planned, through 2024. In parallel, NRS is preparing the General Evaluation Report of Census 2022 which will cover the full lifecycle of the Programme, and any lessons that can be learned.

The process of gathering lessons learned is drawing from several streams. NRS has collated over 400 individual lessons learned, and further lessons have been taken from the statistical modelling phases of the work, in particular, the complementary use of other sources of administrative data to ensure robust population estimates. NRS will also be reflecting on feedback from users through the outputs and dissemination phase of the work.

In addition to the reflections by NRS, the evaluation will draw on the various assurance reviews undertaken, such as the Technology Assurance Framework reviews and the benefits realisation

gateway review planned for late 2023. It shall also be informed by the evaluation work undertaken by the Office of the Chief Statistician and feedback from the Office for Statistics Regulation.

The lessons learned from this process shall be drafted into the General Evaluation Report. The NRS are committed to publishing this Report on its website after it has been completed and laid before Parliament in 2024.

FIRST OUTPUT CENSUS 2022 – COHERENCE ASSESSMENT RESULTS

Purpose

1. To inform Executive Team of the Chief Statistician's approval of the results from the Coherence Assessment for the First Outputs of Census 2022 Statistics due to be published on 14 September 2023.

Priority

2. Routine. For information.

Background

3. Interim Chief Executive and Registrar General at National Records of Scotland, Janet Egdell, , wrote to the Chief Statistician, to request support in reviewing the Coherence Assessment for the First Outputs of the Census 2022.

4. Population estimates by five-year age groups (such as 0 to 4, 5 to 9 up to 90+) and the estimated number of households at both Scotland and Local Authority levels are derived from the Census Statistical Model and referred to as First Outputs.

5. The Census Statistical Model was developed, tested and the methodology published ahead of conducting the Census 2022 in line with international standards.

6. However due to the lower-than-expected return rate the Statistical Model was adapted to make greater use of admin data using new innovative methods guided by the International steering Group of census experts.

7. The Coherence Assessment, conducted by NRS, checks the validity of the population estimates, by comparing results with other known information and data.

8. This exercise tests the assumptions from the methodology in building the Census Model so that differences between the results from the First Outputs with other known sources are understood and explained to validate the results.

9. The Chief Statistician stood up a small group of senior experienced analysts, who use these statistics predominantly for funding decisions and statistical outputs, to review the Coherence Assessment done by NRS with them.

10. The publication of the First Outputs, like the Censuses in England and Wales and Northern Ireland must have National Statistics Accreditation from the Office for Statistics Regulation (OSR).

Producing First Outputs

11. Census Model derives First Outputs from information collected from the Census. A secondary 'Census Coverage Survey' (CCS) addresses gaps in information from non-responses. Administrative data is normally used to improve the quality of the data gathered in the census.

12. Non-response issues with Census 2022 were publicised at the time. The International Steering Group (ISG), made up of census and statistical experts from across the world, was established to provide independent external advice on the quality of Scotland's Census and the statistical approaches that will be used to produce high quality census outputs.

13. The ISG recommended a novel approach to use administrative data to improve the quality of the CCS rather than the Census. This required extra extensive administrative data to be collected than had originally been planned.

14. Information about the novel approach methodology, details on all stages of collecting and creating the First Outputs, including decision making, are published on the NRS website.

Assurance in the First Outputs

15. Due to the high profile of these statistics and the publicity surrounding the non-response rates, and in addition to National Statistics accreditation and an endorsement from the ISG on the methods used, the Registrar General also asked the Chief Statistician to review the Coherence Assessment which has concluded.

16. The ISG approved the methods and will release a statement alongside the publication of the First Outputs stating, "The International Steering Group commends NRS for its systematic and robust application of the census estimation methodology that has led to today's published estimates".

17. Indications from the discussions with OSR is that the First Outputs are likely to achieve National Statistics designation. They have assessed the public value, high quality and trustworthiness of the statistics. A final decision is expected to be announced by OSR shortly after 5 September 2023.

Chief Statisticians Review of the Coherence Assessment

18. Following constructive engagement between the Group set up by the Chief Statistician and NRS, they concluded that they are satisfied with the rationale and decisions taken to provide census outputs which are sound and well-reasoned.

19. The Chief Statistician has communicated his satisfaction to the Registrar General, based on this review, that the outputs will provide the robust population statistics to support the wider statistical system. He has recommended that analysts and the general public can have confidence in the outputs.

20. NRS have taken on board recommendations from the Group, and from other discussions with Local Authorities and experts from the ISG, to refine the model used to produce the census estimates.

21. NRS have taken on board further recommendations from the Group and to publish more details of the decisions taken to refine the methodology used in the Census Model to produce the First Outputs.

22. In addition, the Group recognises that publishing statistics on this scale is hugely challenging and further work is being started to address wider issues identified through this process not directly related to the First Outputs.

Recommendation

23. You are invited to note the contents of this submission and the letter sent from the Chief Statistician to the Registrar General of NRS.

24. The Chief Statistician is happy to speak to any members of the Executive team about this matter.

What's the story?

Scotland's population is the largest and the oldest it's ever been.

Since the previous census there were more deaths than births so the increase has been driven by migration.

The pattern of where people live in Scotland is continuing to shift. Some areas, like the south and south west have seen population decline, while Edinburgh, the Lothians and Glasgow have seen some of the biggest increases. The biggest increase was in Midlothian.

Some of the migration will be from the rest of the UK, and some will be from abroad. What's clear from today's figures is that Scotland's population is the largest it's ever been and without migration it would have fallen. We know migration is driven by people moving for work, family reasons or study.

No other survey provides the range of information that the census does.

Census information is hugely important as it provides a wide range of unique data used by government, businesses and charities to plan vital public services such as roads, schools and hospitals and infrastructure.

Just how much older are we and why are we seeing a swing towards more people being in the older age groups?

There are many more older people than there were at the last census. In 1971 the youngest, those under 15, outnumbered the oldest, those 65 and over, by two to one. We now have more than quarter of a million more people aged 65 and over than we have under 15.

Just over 20% of the population is 65 or older – one in five of us are in that age group. That's a massive change in the shape of Scotland's population.

The ageing population is part of a longer term trend. The main driver of this trend is the generation of babies born post-war moving into the oldest age groups.

Is Scotland's population "older" than the rest of the UK?

People aged 65 and over make up 20% of Scotland's population, almost 19% of the people in England and Wales and just over 17% of the population in Northern Ireland so Scotland does have a slightly older age profile than the rest of the UK. However there are much bigger differences between local authority areas within Scotland. The four largest cities in Scotland were amongst the areas with the lowest proportions of people aged 65 and over. The council area with the lowest proportion of

people aged 65 and over was Glasgow City (14.0%). The council areas with the lowest percentage of people in the 65+ group also have higher proportions of young adults. These council areas tend to have large student populations.

This could be bad news for public finances, doesn't it cost more to look after older people?

Ultimately, this is a matter for decision makers such as local and central government who plan and deliver services. It is our role as statisticians to collate and deliver the numbers.

Didn't the census go badly wrong last year - are you now able to say why so many didn't fill it in and who they are?

As with every census there will be an evaluation. We will send a report on lessons we can learn to parliament next year. Today's estimate covers the whole population of Scotland. We've been able to do that thanks to the millions of households who filled in the census and by adapting our methodology. The priority right now is to start getting this vital data out to the people who will use the figures to plan services.

(If pushed re delay, if next one will be 2031 or at all)

That's an important question and it will be dealt with in our report to parliament next year and in subsequent recommendations. But these statistics are at the heart of the statistical system in Scotland and we have to concentrate on getting them out to those who need them now.

Today our focus is on publishing our first results which show how Scotland's population is the largest it has ever been, how we have seen a swing more towards the oldest age groups in comparison with the youngest and how migration is not just driving population growth but preventing it from declining.

But is this data any good?

We can be confident that this data is of high quality. We've worked with the best and brightest experts in the field of census data to amend our methodology and have achieved accreditation by the independent regulator, the Office for Statistics Regulation. These are National Statistics based on their high quality and good practice and we're proud of the huge amount of work that has gone in to meeting that very high standard. It's an extremely rigorous process that we have gone through and people can have confidence in the numbers.

So if you were able to crunch the numbers anyway, did anyone need to fill in the census at all?

We absolutely needed all the responses we got last year. Almost 90% of households filled it in and we thank them for doing it. Their responses gave us a good foundation on which to move to the processing stage.

Can we compare these statistics to figures for England and Wales or Northern Ireland?

NRS has worked closely with ONS and NISRA to harmonise on questions, methods and outputs.

From these results today we can see some broadly similar results to those for England and Wales where the population grew and there was a significant jump in numbers of people in the older age groups.

And can we now say what the population of the UK is?

NRS will continue to work with ONS and NISRA to produce UK level statistics.

The figures today include a breakdown by sex but in the guidance people were advised to give the sex they identify as and not what they were assigned at birth. How can we be sure the figures are accurate for say providing health services?

On this point the guidance was consistent with what we did in 2011. In addition, the breakdown between male and female, is similar to previous years and in line with the results in England, Wales and Northern Ireland.

Next year we will release data on trans status. This is the first time this question was asked in response to the need for data on the size and location of the trans population in Scotland.

Today's publication represents a historic moment with the largest population ever recorded by Scotland's Census of 5.4 million, an increase of 2.7% since the previous census in 2011.

- In common with many countries, our population is ageing, with over one million people aged 65 and over (1,091,000). This is over a quarter of a million higher than the number of people under 15 (832,300).
- Understanding these changes in the population will allow local authorities, businesses and the government to adapt vital public services to better meet the needs of those living and working in Scotland.
 The number of people in older age groups (65+) increased by 22.5% since 2011.
- In England and Wales the 65+ population increased by 20.0% between 2011 and 2021. In Northern Ireland the 65+ population increased by 23.8% over the same period.
- On census day there were 2,509,300 households with at least one usual resident. This is up 136,500 (5.8%) from the 2011 census. The increase in the number of households (5.8%) is higher than the increase in the population (2.7%).
- Today's results further demonstrate the importance of our strategy to tackle social isolation and loneliness through stronger social connections, and our continued funding for organisations working to address this issue.

Without migration the population of Scotland would have decreased by around 49,800 since 2011.

- It confirms this growth has been driven by inward migration, demonstrating that Scotland is an attractive place to come to live and work
- Scotland faces an ongoing population challenge with fewer births than deaths registered in Scotland since 2011, which reinforces just how damaging Brexit will be to Scotland with the loss of freedom of movement.
- As outlined in the Programme for Government, the Scottish Government is taking action: we will publish an Addressing Depopulation Action Plan which will set out the first phase of our response to population decline occurring in some of Scotland's communities.
- We will also introduce a Talent Attraction and Migration Service to support more people to live and work here.
- We have also called on the UK Government to devolve immigration powers to the Scottish Parliament and work with us to deliver our proposal for a Rural Visa Pilot to enable rural and island communities to attract migrants in line with local needs.

EXTERNAL SUPPORT

Following the collection of Scotland's Census 2022, NRS updated its statistical methods to ensure outputs represent 100% of Scotland's population.

- This approach has been commended by the independent Office for Statistics Regulation (OSR) who have awarded Scotland's census outputs National Statistics designation based on the high quality and good practice of the statistics.
- This builds on the almost 90 % national return rate achieved through collection and enables robust, reliable estimates for the whole population to be provided.
- The innovative statistical approaches applied have been steered by a group of international independent census and statistical experts.
- Professor James Brown, ABS Professor of Official Statistics at University of Technology and Chair of the group said: "The International Steering Group commends NRS for its systematic and robust application of the census estimation methodology that has led to today's published estimates."
- NRS has engaged with stakeholders to ensure users of the data can have confidence that the updated methodology provides full population coverage.

VALUE OF CENSUS

The information published through census outputs will help to shape Scotland for future generations and is an asset for Scotland.

- Scotland has relied for more than 200 years on the information the census provides.
- It remains the best way to gather vital information which government, councils, the NHS and a range of users in the public, private and third sectors need.
- The results help local authorities and the government plan a wide range of vital public services, to improve the lives of those living and working in Scotland.
- The timetable for publishing all the results is:
 - Population estimates at local authority level today (14 September 2023);
 - Local area statistics (c50 households) being provided in spring 2024; and
 - Detailed household characteristics, such as information on ethnicity, employment, education, sexuality, carers and veterans, from summer 2024 onwards.

POSTPONEMENT TO 2022

The decision to move the Census to 2022 was not taken lightly

- The twelve months leading up to a census are vital in planning and testing the effectiveness and safety and security of census systems and collection processes to ensure these are ready.
- COVID-19 restrictions prevented these key activities from progressing.
- NRS conducted a comprehensive options assessment on the risks of COVID-19 to the delivery of the census in March 2021.
- The priority and responsibility of National Records of Scotland (NRS) was to put in place a Census that enabled everyone across Scotland to participate, so that information collected can be used to produce high quality outputs and deliver the benefits required by the people of Scotland.
- In making the decision to move the census to 2022, NRS and Ministers considered balancing the risk of delivering a Census in 2021 during the pandemic and the long term impact of this on data users.

An evaluation of Census 2022, with a focus on lessons learned for any future Census and other complex programmes, will be prepared for Ministers and provided to Parliament by the end of 2024.

• A recommendation will be made to Scottish Ministers on future census statistics in 2024.






Objective is to have to have estimates for the whole population, counted once and

We set a target of 94% returns but as with 2001 and 2011 had statistical methods for getting to 100%

We actually achieved slightly less than



Change in Estimation Approach



Our statistical methods use a Census Coverage Survey to produce final estimates.

We can still produce estimates based on what we collected but there is a greater risk that this estimate (one of these marks) is further away from the actual population

We are going one step further than planned to give us greater confidence in the estimates (one of the marks shown).

By supplementing the Census Coverage Survey with Administrative Data we can be more confident about the estimates.



Change in Estimation Approach

We always planned to do a validation/quality assurance of the estimates

Comparing our estimates to other data and statistics we'll get a good sense of whether we need to do further investigation or modelling

If we did find our estimates were out of line with other data we have plans in place to change our approach

We do know that there isn't an alternative source that is a perfect estimate of the population – that's why we do a census



Method Development – International Steering Group (ISG)

Established by the Registrar General for Scotland and chaired by Professor James Brown, University of Technology Sydney

- International experts have helped shape methodology changes

Additional quality assurance

- Additional QA steps have been taken to have confidence in the administrative data we area using.
- Manual review of automated links
- Analysed administrative data links at an aggregate level to check for unusual patterns e.g. by geographic area



Validation of population estimates

- Coherence with other statistics and data helps us consider where we may need to revise estimation
- Validating across a range of sources as there is no perfect comparator source
- Sources used include:
 - Mid-Year Population Estimates
 - 2011 Census
 - Scottish School Census
 - National Health Service Central Register
 - Council Tax
 - Alternative data Based Population Estimates



Local authority QA

- We will also share census estimates with local authority representatives for QA purposes.
- Under Code of Practice we can share prepublication data for QA.

Responses to the consultation

- We received over 140 survey responses to the outputs consultation.
- Responses from users in central and local government, academic institutions, charity organisations and individual responses.

What the responses tell us – Our plans

We asked users for feedback where there was a notable change to the approach used in 2011. This included:

Reducing the number of tables published due to the introduction of the Flexible Table Builder 71% of respondents had no concerns and were happy with this approach.

Our approach to publishing univariate topic tables

91% of respondents had no concerns with no longer using the KS and QS codes

Our approach to publishing multivariate topic tables

85% of respondents had no concerns with no longer using the DC and LC codes

Not producing the Detailed Characteristics (DC) and Local Characteristics (LC) postcode sector geographies previously used in the 2011 census 81% of users had no concerns with us dropping the DC and LC postcode sector geographies

Changes we will make

- We aim to publish additional pre-defined tables where we identified a strong user need to do so. We will
 review requests for additional tables and where appropriate and feasible will add these to our plans for
 pre-defined tables.
- We aim to publish two versions of some multivariate tables where we identified a user need and it is in line with our statistical disclosure control policy.
- We will investigate further if it is possible to publish origin destination data at more disaggregated levels.
- We will add an additional analytical report to our list covering the health topic. We will continue to work with stakeholders to determine the content of each report and any additional topics which should be covered through these reports.



What the responses tell us - User quotes

Outputs Consultation - Reminded by our users how important census statistics are:

"Given the pandemic, and the pressure on health and social care services, we really, really need a refresh of reliable data so we can understand our communities and what need is out there. We are dealing with some of the most vulnerable people."

"UK Armed Forces veterans first - because the last available demographic survey is very limited in scope and over 8 years old, and the organisation is seeking to expand service offering into new geographies and robust data on needs will transform this decision making process."

"Our preference would be for 'Ethnic group' data to be one of the first to be published. The census is the only comprehensive source for this information and the results are needed for research and analysis."





Any comments on that welcome in this chain as well.



Hello.

I attended the session on the updated census methodology and outputs yesterday which was really interesting. I noted the timescales for the topic releases next year, but I was wondering if there would be any possibility of getting a national figure for the number of people providing unpaid care (by the hour bands if possible) around October/November this vear?

The reason I ask is that the Carers Act (which gives unpaid carers the right to support if they need it) is entering its next phase, and we are currently estimating the costs for the next 10 years of the Act. At the moment, we are using an estimate of the number of unpaid carers in Scotland based on national survey data but having the census figure would be a big help.

I understand if this isn't possible and that release of these figures are scheduled for summer 2024, but I thought I would double check as it would just be the national total that would be needed.

Many thanks to you and other members of the SG Coherence Group for your help and advice.

As you know we are publishing First Outputs on 14 September and this was pre announced on 18 August on our website and through a news release.

When we spoke last week I talked you through the final change we have made to implementing the household adjustment and you asked me to send a short explanation to this group. We also discussed this change with [redacted] in ONS who sits on ISG.

The group may recall from our discussions that this adjustment is made to households and then fed through into the population estimates. The change we have made is to our assumption that the bias affected all those people within the household equally. Now we assume the non-responding households we didn't detect due to bias are likely to be similar to those non-responders we detected in coverage estimation, particularly in terms of household size. Therefore to account for this in the final estimates, we stratified households by household size and distributed the total correction in each LA in proportion to the average size of non-responding households in that LA. More detail will be available in our Quality Report which will be published alongside the estimates.

The first results from Scotland's Census 2022 will be published by National Records of Scotland (NRS) on Thursday 14 September 2023.

These results will include estimates of the total population of Scotland and the population size in every local authority area, including a breakdown by five-year age groups and sex.

There will also be figures showing the change in population since the last census in Scotland in 2011 – both at national and local authority level – as well as population density and household numbers.

For more than 200 years Scotland has used the data the census provides, and it remains the best way to gather vital information about Scotland's people which local and central government, the NHS and a range of other data users in the public, private and third sectors need.

NRS Chief Executive Janet Egdell said:

"The information published through census outputs will help to shape Scotland for future generations. The results on 14 September are the first step in publishing a wide range of unique data that will be used by government and other public bodies to plan vital public services and infrastructure across Scotland in the years to come."

Questions & Answers summary

Question 1 – Is my understanding right that population estimates for age range x gender x area x Gaelic language fluency will be released in Summer 2024?

Yes, data from the question on Scottish Gaelic will be published during the topic data phase which is scheduled to begin in Summer 2024. We aim to publish breakdowns of topic variables by age and sex where appropriate.

Question 2 – How much information will be published on the confidence intervals of the estimates, what stage will this be shared?

Confidence intervals will be published as part of a package of quality information alongside the first release.

Question 3 – How were those without online access included?

90% responded online. If respondents were unable or unwilling to respond online, we provided a range of alternatives including paper questionnaires and telephone interviews. This approach was consistent with that taken in both England & Wales and Northern Ireland.

Question 4 – How do you use logistic regression for population estimate?

The logistic regression approach uses a single national model to calculate record level non-response weights which are used to estimate council population and households. The model in effect predicts the likelihood of a person responding to the census accounting for age, sex, ethnicity, and other potential variables.

Question 5 – Of the approx 10% that did not respond, were you able to estimate if most were from a particular demographic?

Published statistics will include information on the demographics of those who did not respond. In our coverage survey we collected information on characteristics most associated with the profile of non-respondents from previous censuses so that our estimation modelling will account for this. Information on coverage rates by characteristics will be made available when we publish estimates on the detailed characteristics in 2024.

Question 6 - Over what period will the topic data be released - weeks or months?

The topic data phase is scheduled to begin in Summer 2024. Topic releases will be staggered. We aim to minimise the time between releases but it is likely to take a few months to work through all of the topics we collected data on. We will update users as soon we have confirmed the order of topics and the timing for each release.

Question 7 – Will the information will be provided by industry and LAs?

Yes, data on the industries people work in will be published during the topic data phase which is scheduled to begin in Summer 2024. We aim to publish breakdowns of topic variables by age and sex where appropriate.

Question 8 – Do you know if the data zone / intermediate zone redrawing work has been completed yet?

The work to redraw data zones will be carried out when we have produced small area statistics (spring 2024). As after each census this work is important to ensure that there is consistency in the size of each area.

Question 9 – Do I understand correctly that we might be informed of when the information about the 8 themes will be published next summer will be available soon? Is it possible to be more specific about what 'soon' means?

We will update users as soon we have confirmed the order of topics and the timing for each release.

Finally I want to share with everyone some work that I have been doing with National Records of Scotland. You may be aware of the problems in getting responses to the Census in 2022 which were publicised extensively in the media at the time. What is less well know is the fabulous work that we have been doing across the Data Domain with

NRS. We have supported them to gain access to and use administrative data. This has complimented the superb work done by the demographic teams in NRS to address the problems related to people who did not complete their census form. The work they have done has helped to build a full census database and ensure everyone in Scotland in March 2022 has been properly counted.

Yesterday I sent a letter to the Registrar General, Janet Egdell, which summarises the work that senior analysts from across Scottish Government have done to assess the results from the Census. I have attached ([redacted]) the letter I sent here, and I would point out the paragraph where I have stated "I am satisfied, based on this review, that the first outputs from the Census 2022 will provide the robust population statistics to support the wider statistical system and that analysts and the general public can have confidence in the outputs, and that they can be published on 14 September 2023."

A big thank you to everyone who has supported the work done in the past year. There are many of you who have contributed to this successful outcome but I would like to pick out special praise for [redacted], [redacted] and [redacted].

We would like an opportunity to brief you on what to expect when we start to publish the results from last year's Census, as we know it will have impacts on your various funding allocations. Can I ask for 30 mins of your time in late June / early July?

Since the Collect phase in 2022, my colleagues have been processing, cleansing and analysing the data, including genuinely ground-breaking work using administrative data sources as part of how we produce the statistics.

We are on track for early autumn publication of the first outputs providing robust local authority high level stats. This will provide a sound basis for the Scottish statistical system and decisions it informs. This will then be followed, through 2024, by small area detail (down to 50 households) and information covering a myriad of individual topics, providing an updated evidence base. <u>Census outputs schedule | Scotland's Census (scotlandscensus.gov.uk)</u>

Your stakeholders may have questions around the robustness of the evidence base, and we would like a chance to talk you through what we have done to mitigate any such concerns.
