- Victor's visit takes place Monday 24th April Friday 5th May.
- He plans to be in Edinburgh evening of Sunday 30th April Tuesday 2nd May. Engagement with the Scottish Government will be Tuesday 2nd May with the Monday being a bank holiday. He will then travel to Manchester that evening or morning of Wednesday 3rd.
- As Gov officials, we only need to organise his time with Gov departments. Engagement with civil society is for his office to organise.
- Victor has expressed an interest in: conversion therapy; violence and discrimination faced by LGBT people, and victim support; access to public services; legal frameworks; prisons; and legal gender recognition. He has also expressed an interest to meet with the Scottish First Minister - please feel free

to offer an alternative minister should this not be feasible (we are able to manage expectations on ministerial engagement if needs be).

PO/Cabinet Secretary for Justice and Home Affairs PO/Minister for Equalities, Migration and Refugees PO/Minister for Victims and Community Safety The United Nations Independent Expert on Sexual Orientation and Gender Identity, Victor Madrigal-Borloz, will be visiting the UK from 24 April to 5 May. He will be accompanied by two colleagues from the Office of the High Commissioner for Human Rights: Mr [redacted] ([redacted]), and Ms [redacted]([redacted]).

During their visit, they will be meeting with Ministers from the UK Government and devolved administrations and will hold roundtables with senior government officials. Mr Madrigal-Borloz has expressed an interest in discussing conversion practices, violence and discrimination faced by LGBT people, victim support, access to public services, legal frameworks, prisons, and legal gender recognition.

Mr Madrigal-Borloz is set to be in Edinburgh from Sunday 30 April - Tuesday 2 May and hopes to engage with Ministers and senior government officials on Tuesday the 2^{nd} of May. His office is yet to provide a detailed itinerary, but they have indicated a desire for engagement to take place between 9am – 2pm with a 30minute Ministerial meeting between 9am and 10am.

While in Scotland, Mr Madrigal-Borloz will also meet with civil society organisations. In addition to the Scottish Human Rights Commission, this engagement will likely include some of our key LGBT stakeholders (LGBT Health and Wellbeing, LGBT Youth Scotland, LEAP Sports Scotland, Stonewall Scotland, Time for Inclusive Education (TIE), Equality Network, and Scottish Trans). Our key stakeholders submitted a joint submission to Mr Madrigal-Borloz in advance of his upcoming visit highlighting their priority issues and concerns. The joint submission (attached herein) highlighted the following: the Gender Recognition Bill, Trans healthcare, increase in anti-LGBTI hate crime, Ending Conversion Practices, LGBT+ human rights, Intersex/VSC rights, LGBT+ mental health, Trans people in custody, Inclusive education, and Trans inclusion in sport.

Mr Madrigal-Borloz has also indicated a desire to visit a Scottish prison/detention centre and to speak with an inmate. We are working with colleagues in the Scottish Prison Service to facilitate this request.

As the visit will take place on a Tuesday, we understand the Cabinet Secretary for Justice and Home Affairs might be unavailable due to the Cabinet meeting and ask that the Minister for Victims and Community Safety attends in the Cabinet Secretary's stead to discuss prison policy, if possible.

Given the importance, and sensitivity of the proposed topics for discussion, it is our recommendation that the Minister for Equalities, Migration and Refugees and, if possible, the Minister for Victims and Community Safety meet with Mr Madrigal-Borloz and his delegation. Should Ministers agree, we will liaise with Mr Madrigal-Borloz's office and with colleagues in the UK Government to make the appropriate arrangements.
