- £4m funding to be earmarked for humanitarian and health assistance. This is planned to be rolled up into one announcement. Permanent Secretary to confirm level of funding for humanitarian/financial aid.

## 1st Mar SGoRR(M) Concurrent Risk – Ukraine

- Written communication to all business sectors setting out Scottish Government expectations with regards to disinvestment in Russia.
- The SG needed to show strong leadership to Scottish businesses, for all sectors, and in particular, finance and cultural sectors, to review their relationships with the Russian state and with other Russian organisations and businesses and to take appropriate action to protect their reputations.
- External Affairs directorate to produce written templates for Ministers to respond to MSPs on how communities can help with aid to Ukraine.

## 8th Dec SGoRR(M) Winter Preparedness

- By the end of January, reach point where contingencies for Scottish Fire and Rescue Service Industrial Action are in place. Inspection report to be published, and spoken to either through SGoR or to CabSec and Minister for Community Safety.
- Transport Scotland Communications to emphasise that SG are unable to resolve rail strikes. Prepare for orchestrated work on UKG to engage with RMT.
- Further exercise and thought along lines of BEIS exercise; work with partners to improve preparedness for national power outage.
- Transport Scotland Comms to provide information on what SG can do to amplify messaging urging drivers to check road closures and conditions before travelling.
- A submission to be provided to CabSec Justice and Veterans outlining representation of how emerging situations are escalated within Comms & Marketing, how is the overall tone decided, with respect to providing information and reassuring wider population.

## SGoRR(M) – NHS Pressures – Friday 6<sup>th</sup> January 2023

#### Actions

- 1. FM would like the Chief Medical Officer (CMO) and National Clinical Director (NCD) to consider the need for more formal messaging (to begin as of next week) on basic hygiene measures such as masks in public settings and isolating at home if unwell.
- 2. FM would like assurance that focus is on additional steps being taken to alleviate hospital occupancy levels, delayed discharges and blockages, working with local authorities to do so. Assurance that Health Boards are planning accordingly for the fastest possible discharge generally, before reaching stage of 'delayed'. FM would like assurance that everything that can be done is being done to speed up discharge upstream from the point of delayed discharge, where cases become by definition more complex.
- 3. Government is open to Health Boards looking at the hierarchy of care priorities over coming weeks.
- 4. DFM would like a focus on increased messaging to direct public to NHS24 at the earliest stage.
- 5. Cab Sec Health & Social Care would like assurance that everything is being done to maximise NHS24 workforce capacity over the coming weeks.
- 6. Cab Sec Health & Social Care would like assurance that every Health Board is exploring the (increased) opening of primary care settings on weekends and in evenings, as per the Lanarkshire initiative.
- 7. FM reiterated that all 'good practice' initiatives being deployed in any Health Boards are being replicated in every Health Board in the country, to ensure a national standard service.
- 8. Cab Sec Social Justice, Housing and Local Government reiterated that Saturday opening of GPs and other primary care settings would alleviate admission and discharge pressures over weekends and would like assurance that all third sector bodies are being utilised to support discharge throughout the system.
- 9. FM and Cab Sec for Health & Social Care have requested a very close eye being kept on oxygen supply levels and Cab Sec would like further detail on forecast oxygen use and gaps in the levels required to be highlighted to him. Cab Sec Health & Social Care would like assurance that issue of O2 cylinders and empty cylinder prompt recovery is following best practice across the country for most efficient management of these supplies.
- 10. FM would like assurance that all social care capacity is being used to the maximum, consistently and to the most efficient levels and that work to get additional beds should start immediately without delay (not wait until parliamentary statement).
- 11. FM would like assurance that support from SG is being given to the standardisation of care at home across the country. Anecdotally she is hearing about different working practices/hours.
- 12. Cab Sec Health and Social Care would like assurance that the guardianship process is being expedited where possible. Where no family member is stepping forward then Local Authorities are stepping in as early as possible to progress a LA guardianship order.

- 13. DG Health and Social Care would like all systems to be focusing on planning of flows in and out of hospital and warns that a premium may have to be paid for care beds to free up hospital capacity.
- 14. Comms to issue a News release after SGoRR meeting on actions that SG is taking. The subsequent public messaging on preventative messaging should be separate and distinct.
- 15. FM would like a covid-style briefing to be held on Monday featuring the FM or Cab Sec Health & Social Care and the CMO or NCD to provide public messaging / press questioning.
- 16. FM wants the next SGOR(M) next Friday 13th.
