Why is the workshop needed?

In January 2023 we completed a series of lived experience interviews with people from across Scotland.

There were a number of areas which were highlighted by participants as areas in which they would like to see improvement and we also heard examples of best practice.

One of the most recurring topics was information supplied by health care professionals at all stages of consultation and treatment. This often left patients feeling lost, unheard and uneasy about their future. This is something we would like to explore during the session around the different pieces of information provided to patients and where you might see gaps.

Another aspect we'd like to explore which came through in multiple conversations is around communications between primary, secondary and tertiary care to support patients and how they are receiving communications from Health Care Professionals.

How we will use the Mural Board

The Mural Board has been created to capture some initial thoughts before the workshop so that conversations can pick up from any key themes already emerging.

The Board can be used by participants unable to attend the workshop to allow input into the discussion.

During the workshop we will continue to capture thoughts and ideas via the Board which will be collated and drafted into a paper, which will be shared with the group after the workshop.

We will also leave the Mural Board open after the workshop for around 2 weeks to capture any further thought or ideas that may present themselves after the session.

Introduction

The Women's Health Plan for Scotland was published in August 2021 and featured a number of actions to deliver improved care and treatment for those with endometriosis. To help us deliver the actions a Lived Experience Forum and an Endometriosis Advisory Group were created to understand where there was best practice to be shared and where there are opportunities for improvement.

Why is this workshop needed

At the beginning of 2023 we spoke with 20 people with lived or living experience of endometriosis, who were members of endometriosis support groups across Scotland. We also released a survey internally in the Scottish Government to ask colleagues about their experiences. There were a number of areas highlighted for improvement and also positive experiences which could be taken as best practice.

High level findings from the Lived Experience Insight Report Results

Key areas of consideration during this session

The Lived Experience Insight Report covered a number of areas but for this session in particular we would like to cover the following areas:

- **Communication between primary, secondary and tertiary care.**
 - We would like to explore if the systems currently meet your needs to ensure a patient centred approach to care.
- **Information presented to patients during consultation and after surgery**
 - In particular we would like to identify what information you currently are able to provide and if there are any gaps in the information or barriers to providing the information.
 - We would also like to explore after surgery care and the information provided around management after surgical diagnosis or treatment.

Mural Board Information

A Mural Board has been created for the session which will be used during to capture ideas. Everyone will be added to the workspace to allow them to use the Board. It will also be an opportunity to input before the session for those able to attend and provide the opportunity for those unable to attend to feed in.

After the two weeks we will then collate the information gathered and draft a summary of the session with key highlights which we will circulate for comments. The ideas gathered will inform further policy decisions moving forward.
