• In questioning why SG was not pursuing a public energy company, instead was establishing an energy Agency- the convener asked what was a virtual agency and if it had budget or estimate for staffing of new Agency.

Response

 It's about scaling up; big challenge is the pace to take this forward. Need to act now, start with a virtual Agency. On budget and staff- virtual Agency will be using existing resources but will look at skills and resource needed for a full permanent Agency.

NZET Committee 1/2/2022

The committee was asking questions on the Scottish budget, the convener asked:

- if additional funding had been provided for the energy Agency in the Scottish budget
- is it still for the time being a virtual Agency? does it have dedicated staffing and resource.
- Will the Agency actively be involved to assist Local Authorities,?
- Are there plans to accelerate the Agency and make it an urgent priority, going back to my point about scale of investment and the amount of resource in the Agency- clock is ticking to 2030 target date.

Response

- It is being managed internally within existing budgets. There is no specific ring-fenced budget, it is being managed within my portfolio budget, and is taken into account in our budget lines for this FY.
- There will be a dedicated team in SG that helps to draw the Agency together initially with a view to ramping it up and developing it to be much more stand- alone- not entirely separate from SG. However, that is a couple of years away from the work that is necessary to get it up and running

Written PQ Dean Lockhart - 25/2/2022

 To ask the SG when the proposed National Public Energy Agency will be operational; how many full-time dedicated staff it will employ; what its annual budget will be, and when it anticipates that the virtual agency will move to being a standalone organisation.

Response

 As set out in the PfG we made a commitment to create a National Public Energy Agency. We will work to have a virtual Agency established this year, and a dedicated physical Agency by September 2025.

- The virtual Agency will be in place throughout the transition period until a standalone Agency is in place.
- This is an ongoing area of work, and as a first step we launched a
 consultation in December 2021 which closed on 8 February to help inform
 development of the design of the new body. Consultation responses are
 currently being analysed and further details will be released as the work
 evolves.

NZET Committee – 26/4/2022

Mr Harvie was appearing before the committee to discuss the LHEES SSI. The final question from the convener was on the Agency, and the challenge of the work to be undertaken around heat decarbonisation. He mentioned a previous appearance by Mr Matheson who stated that the virtual Agency would be in place later this year, with no additional staff. In responding Mr Harvie undertook to provide an update to the committee on the Agency.

Response

Mr Matheson wrote to the convener on 6 May updating on progress. In terms of responding to the issue on staffing, he stated this would be considered as the shape of the Agency is progressed over the coming months. Other issues highlighted were the Call for Evidence response, the independent report on the analysis of responses has been send to the committee, and that an independent strategic board would be established to work in partnership with SG to help shape and design the Agency.

S6W-10172 Dean Lockhart: 25 August 2022 To ask the Scottish Government, regarding the non-virtual National Public Energy Agency, whether it will provide (a) an update on when it will be set up and (b) details of (i) what services it will provide, (ii) how many staff it will employ and (iii) what its annual budget will be.

Answer

I reaffirm the answer to S6W-06416, and in my letter of 6 May to you as convener of the Net Zero, Energy and Transport committee about the National Public Energy Agency. Specifically, as set out in the Scottish Government's a Fairer, greener Scotland: Programme for Government 2021-22, we made a commitment to create a National Public Energy Agency by September 2025. This is an ongoing area of work, and issues such as staffing and budget will be considered as the work to develop and design the Agency progresses over this parliamentary period.

S6W-10173 **Dean Lockhart: 25 August 2022** To ask the Scottish Government whether it will provide (a) an update on when the virtual National Public Energy Agency will be established and (b) details of (i) how many people it will employ and (ii) what services it will provide.

I reaffirm the answer to S6W-06416, and in my letter of 6 May to you as convener of the Net Zero, Energy and Transport committee about the National Public Energy Agency. Specifically, that we will work to have a virtual Agency established this

year, which will be in place throughout the transition period until a standalone Agency is in place. I indicated that an independent Strategic Board will be established to work in partnership with the Scottish Government to help us with this work.

I will announce details of the board members shortly, along with an update on the virtual Agency, which I have previously advised would remain under our control until a constituted body has been established but would operate under the virtual Agency banner and within existing budgets.
