The First Minister's latest call comes as the United Nations has expressed concern up to 1.9 million internally displaced people are moving into smaller and smaller pockets in the Gaza Strip. The UN Relief and Works Agency (UNWRA) for Palestinian Refugees has warned that 40% of the population of Gaza is now at risk of famine due to "catastrophic hunger", and the latest Integrated food security Phase Classification (IPC) brief shows Gaza is experiencing a food security emergency driven by ongoing hostilities.

Responding to the unfolding humanitarian crisis in the region, the First Minister said diplomatic approaches have so far failed to bring about any change and an immediate ceasefire was needed.

The First Minister said:

"The time has come for the UK Government to speak out forcefully and make it clear that Israeli action has gone way beyond a legitimate response to the appalling Hamas attack of 7 October.

"Hearing comments from an Israeli Government Minister urging displacement of Palestinians from Gaza is deeply disturbing and should be universally condemned. Gaza is Occupied Palestinian Territory and will be part of a future Palestinian state - Gazans should not be subject to forcible displacement or relocation from Gaza.

"The UK Government must make clear that Prime Minister Netanyahu, Israeli Ministers and military commanders will be held accountable for the killing of thousands of innocent civilians and the deaths of tens of thousands more from starvation and disease if Israel does not immediately cease indiscriminate attacks and allow aid to enter Gaza on the scale needed to avert a humanitarian disaster. Hamas leaders must also be held accountable for the appalling attacks against Israeli civilians on 7 October.

"Talk of a sustainable ceasefire from the UK Government has made no difference on the ground, as the situation has worsened for the people of Gaza. The UK Government must use its voice and influence to stop the killing – directly with the Israeli government, and indirectly with the US."

# First Minister urges UK to hold the Government of Israel to account FM: UK Government's repeated refusal to call for an immediate ceasefire is shameful

First Minister Humza Yousaf has urged the UK Government to use its position as a trusted ally of the Government of Israel to demand an end to "indiscriminate attacks" that have seen thousands of children in Gaza killed. He has made it clear that those responsible for killing civilians must be held accountable.

Ten weeks since Israel's invasion of Gaza the First Minister said the UK Government's refusal to call for an immediate ceasefire is "shameful".

The First Minister's latest call comes as the United Nations has expressed concern up to 1.9 million internally displaced people are moving into smaller and smaller pockets in the Gaza Strip. The UN Relief and Works Agency (UNWRA) for Palestinian Refugees has warned that 40% of the population of Gaza is now at risk of famine due to "catastrophic hunger", and the latest Integrated food security Phase Classification (IPC) brief shows Gaza is experiencing a food security emergency driven by ongoing hostilities.

Responding to the unfolding humanitarian crisis in the region, the First Minister said diplomatic approaches have so far failed to bring about any change and an immediate ceasefire was needed.

The First Minister said:

"The time has come for the UK Government to speak out forcefully and make it clear that Israeli action has gone way beyond a legitimate response to the appalling Hamas attack of 7 October.

*"Hearing comments from an Israeli Government Minister urging displacement of Palestinians from Gaza is deeply disturbing and should be universally condemned. Gaza is Occupied Palestinian Territory and will be part of a future Palestinian state - Gazans should not be subject to forcible displacement or relocation from Gaza.* 

"The UK Government must make clear that Prime Minister Netanyahu, Israeli Ministers and military commanders will be held accountable for the killing of thousands of innocent civilians and the deaths of tens of thousands more from starvation and disease if Israel does not immediately cease indiscriminate attacks and allow aid to enter Gaza on the scale needed to avert a humanitarian disaster. Hamas leaders must also be held accountable for the appalling attacks against Israeli civilians on 7 October.

"Talk of a sustainable ceasefire from the UK Government has made no difference on the ground, as the situation has worsened for the people of Gaza. The UK Government must use its voice and influence to stop the killing – directly with the Israeli government, and indirectly with the US."

# SG HUMANITARIAN FUNDING

Last Thursday, we announced a further £250,000 in funding for UNRWA to support the immediate food, health, shelter and protection needs of people seeking safety.

# That means we **are providing £750,000 in total towards the United Nations** <u>Relief and Works Agency's (UNRWA) in response to the ongoing escalation in</u> <u>the Gaza Strip.</u>

- These funds will support the immediate food, health, shelter and protection needs of people seeking safety.
- Members of the public who wish to do so, can contribute to the UNRWA flash appeal, or those of the many aid agencies operating in Gaza.
- The UN 'Flash' appeal is specifically for Gaza. That is where the unfolding humanitarian disaster is, with an estimated 1.4 million people displaced by the bombing and by military evacuation orders. The Israeli Government has not requested humanitarian assistance from the international community.
- We are satisfied that UNRWA, with the institutional substance of a UN agency, its established operations and long experience of working on the ground in Gaza, is best placed to ensure that the funds are used to provide humanitarian aid to those in desperate need.
- The UN must be able to access essential fuel supplies in order to support the distribution of life-saving humanitarian aid.
- Following raids on warehouses and distribution centres, UNRWA have provided us with assurances that they have taken steps to strengthen security at their facilities.

# <u>Alleged involvement of several UNRWA employees in Hamas attacks on Israel</u> <u>on 7 October</u>

# Background

The UN agency for Palestinian refugees (UNRWA) released a statement saying it had opened an investigation into several employees suspected of involvement in the 7 October attacks in Israel by Hamas, and that it had severed ties with those staff members.

The UN Secretary-General also released a **statement** saying he is horrified by this news and has asked Mr. Lazzarini to investigate the matter swiftly and to ensure that any UNRWA employee shown to have participated or abetted what transpired on 7 October, or in any other criminal activity, be terminated immediately and referred for potential criminal prosecution.

Evidence of the employees' alleged involvement was provided to UNRWA by the Israeli authorities.

# Scottish Government Support for UNRWA

On 14 October, the Minister for CEID announced a contribution of £500,000 towards the United Nations Relief and Works Agency's (UNRWA) flash appeal in response to the ongoing escalation in the Gaza Strip. In November, the First Minister announced a further £250,000 towards the same appeal, bringing Scottish Government's total funding to UNRWA to assist the relief efforts in Gaza to £750,000.

As part of negotiating the terms of the grant agreement, officials conducted an assessment of the UNRWA Regulatory Framework, including code of conduct and disciplinary procedures for staff.

Also on 2 November, the First Minister and Minister for CEID met with the director of the UNRWA Representative Office in Europe, Marta Lorenzo where he heard about their work in responding to the humanitarian crisis in the OPTs.

# Other Donor's Support for UNRWA

UNRWA, whose biggest donors in 2022 included the US, Germany and the EU, has repeatedly said its capacity to render humanitarian assistance to people in Gaza is on the verge of collapse. AS

**USA:** The US state department said it was extremely troubled by the allegations, which it said pertained to 12 UNRWA employees. They have temporarily paused additional funding for UNRWA while they review these allegations and the steps being taken to address them. The US provided \$344 million in 2022

**EU:** The EU foreign policy chief, Josep Borrell, said it would "assess further steps and draw lessons based on the result of the full and comprehensive investigation". The EU provided \$114 million in 2022.

**UK:** On 24 November the UK announced a package of £30 million funding for aid to Gaza; £10 million of this was allocated to UNRWA. A further £30 million was announced in December but there are no further details on how this was allocated. The UK is a longstanding donor to UNRWA and provided \$21 million of funding in 2022.
