I am coming out to you both in the first instance, apologies if doesn't sit directly within your areas.

I am looking to get a note that addresses some of the non political points mentioned in the correspondence below in regards to trade agreements between UK and EU below please.

Grateful if you could confirm this has been picked up.

I hope you're well.

I am just off the phone with an expert on trade agreements to talk over the Scottish Government's reasoning for not intervening in the use of Prestwick Airport late last year by an Israeli Air Force plane.

I wanted to run a few things by you. I think I understand it on a pratical level. As far as I can see it, the rules set out in the guidance on state-owned enterprises by the OECD are clear: "The government should allow SOEs full operational autonomy to achieve their defined objectives and refrain from intervening in SOE management."

But I am not sure I understand it politically. Surely the SG has been happy in the past to pick fights with the UKG on a variety of issues and I can't square the strength of the rhetoric on the war in Gaza with the SG staying fairly quiet on the use of Prestwick by the Israeli military.

The comment I got through the last story I did read as follows: "To comply with trade agreements between the UK and the EU, the business is required to operate on a commercial basis and at arm's length from the Scottish Government.

"Ministers do not intervene in commercial decisions at the airport."

I've since had clarification there was a mistake in the first sentence and it should refer to "the trade agreement btwn UK and EU" - not multiple trade agreements.

Can I also ask if the SG takes a view on whether the OECD guidelines should be included in the TCA? From Article 381 of the agreement: "Each Party shall respect and make best use of relevant international standards including the OECD Guidelines on Corporate Governance of State-Owned Enterprises."

I'd also ask whether I am correct to read into the SG's comment the implication that ministers might like to intervene in the operations of Prestwick Airport but feel hamstrung by the TCA rules?

Any help with this would be massively appreciated.

Thanks for taking my call.

I am looking for comment from the Scottish Government for a story I am writing based on an FOI response which shows the SG has not raised the case of an Israeli Air Force plane passing through Prestwick Airport with the CAA, the MoD, the airport itself or Transport Scotland.

Greens MSP Ross Greer said: "There are still big questions to be answered about why an Israeli military aircraft was allowed to land at Prestwick.

"We must ensure that no Scottish public assets are being used to enable Israel's brutal campaign of genocide against the people of Gaza.

"I urge the Scottish Government to speak to the management of Prestwick Airport and to use its position as the airport's owner to prevent this from happening again. "The airport and the UK Ministry of Defence must urgently clarify what has happened here."

Alba Depute Leader Kenny MacAskill MP said: "Britain is becoming increasingly complicit in the Israeli genocide. There can be no excuse for the Scottish Government in not being explicit in its demands and actions that Scotland is not associated in any way. We require greater transparency and assurance."

As responsibility for Scottish Government Commercial Assets, including Glasgow Prestwick Airport, is within my portfolio, I am responding on the Minister for Transport's behalf.


Glasgow Prestwick Airport is first and foremost a commercial airfield. It operates on a commercial basis at arm's length from Ministers and Officials. It is for Glasgow Prestwick Airport's management team to consider all opportunities to grow the business and generate revenue.

Any aircraft operating in UK airspace is authorised to do so by the UK Civil Aviation Authority under powers reserved to the UK Government. It is a commercial decision for Prestwick Airport as to whether to accept any request for a technical stop, particularly if the presence of a particular aircraft or cargo is likely to result in heightened scrutiny or the potential for disruptive protest.

I am unable to disclose details of commercial matters concerning Glasgow Prestwick Airport's engagement with customers.
