#### ADDRESSING OVERCROWDING & PRISON POPULATION

We recognise that the imprisonment rate in Scotland is too high and rising and are taking action to address that.

We have provided an extra £29m this year to support the Scottish Prison Service to deliver a stable and secure prison system, on top of the £97m in capital funding that we are giving to continue the modernisation of the prison estate to better meet the needs of staff and prisoners.

We have established a Prison Population Leadership Group, including partners such as SPS, Scottish Courts and Tribunal Service, Crown Office and Procurator Fiscal Service, Police Scotland, Community Justice Scotland and the Parole Board for Scotland to consider the challenges and mitigations associated with the rising prison population.

We are developing options for using GPS with electronic monitoring, and encouraging more widespread use of community-based interventions which we know are more effective than short custodial sentences at reducing reoffending.

We are working with justice partners to address the issue, including making the best use of the current prison estate and sourcing additional prisoner places to ensure the safety and wellbeing of people living and working in prisons.

The prison population has been growing consistently since the start of the year and we recognise that the impact of this is felt across the justice system.

This is due to multiple factors including reducing the backlog of cases in our justice system by over a third; an increase in average sentences imposed for certain offences; and the increase in the number of serious sexual offence cases prosecuted in the courts.

This shows the success of other areas of our justice system in policing and convictions, improvements in clear-up rates, and increased reporting and investigation of crimes such as sexual offending.

03 October: UK Justice Secretary Alex Chalk announced that UKG would explore renting prison spaces abroad to tackle overcrowding.

Extending the presumption against short sentences from 3 to 12 months in 2019; Introducing electronic monitoring on bail;

Passing the Bail and Release from Custody (Scotland) Act 2023 to refocus how remand is used so that it is reserved for those who pose a risk to public and victim safety; and

Investing in community justice which we know is more effective at reducing reoffending than short-term imprisonment by providing a total of £134m to support community justice services in 2023-24.

Increased use of cell sharing, overcrowding and mixing different types of prisoners can also lead to increased tensions and increased likelihood of disorder.

The custodial estate has a design capacity of 7905 – this is the population level at which prisons are not overcrowded, in that cells are occupied by the number of people intended in their design.

Since the start of the year, there has been a sustained increase in the prison population; it has risen from around 7,300 at the start of the year to 7,959 as of Monday 27 November. This is the highest the prison population has been since COVID. Of more significant concern is the steady upward trajectory throughout the year, with no indication from justice partners that this is likely to slow in the immediate term. The 9% increase in the prison population since January 2023 is having a significant impact on SPS staff and those in their care, including increased cell sharing and overcrowding, with inevitable impact on wellbeing of individuals, increased likelihood of disorder and increased pressure on staff.

A Scottish Government spokesperson said:

"The way Scotland's prisoner population and the prison estate are managed is an operational matter for the Scottish Prison Service.

"However, while prison is needed for those who pose a risk to public safety, we recognise that the imprisonment rate in Scotland is high and we are taking action to address that.

"That includes a focus on encouraging more widespread use of community-based interventions which we know are more effective than short-term imprisonment at reducing reoffending and assisting with rehabilitation.

"The recent Bail and Release from Custody Act seeks to refocus how remand is used so that it is reserved for those who pose a risk to public and victim safety. It also improves support for people leaving prison, helping them to successfully resettle in their communities and not reoffend."

HMPYOI governor Gerry Michie told STV News: "The Scottish Prison Service are facing significant challenges in terms of the ultimate population. "There are a number of prisons in Scotland at this moment in time that are overcapacity. And there are a small number of prisons, including myself, that are under capacity.

"[Polmont] does have the capacity to take a new population. And there are a number of different population options being considered by the chief executive and senior leaders in the organisation. And I am a part of that.

"If it's adult males, that is the end result, then then that's a new population for us.

"But I think that our philosophy, how we treat people is exactly the same whether you're a child, a young person, a female or an adult male. We will try to treat them in a particular way.

"Design capacity means that we've got lots and lots of space with a very well resourced prison. And we particularly focus for young people and women at this moment in time, on education, a life skills and vocational training.

"So there's lots of opportunities here for a new population to get involved in that."

The continual problem of overcrowding (meaning there is always a percentage of cells used as double cells) exacerbates all issues.

Some of the wellbeing issues in Barlinnie are addressed and monetised as the cost to SPS of increasing capacity or resources to deal with overcrowding, inadequate regime, cell size and engagement time.

The replacement of HMP Barlinnie will mitigate a significant strategic risk for SPS, avoiding the risk of infrastructure failure (post Glasgow opening) at HMP Barlinnie and the consequent disruption, difficulty, and cost of relocating the Barlinnie population and creating overcrowding elsewhere. The costs and risks of such a relocation would be significant.

While a rationalisation may be possible with HMP Barlinnie still in place it would not generate a significant level of saving as, all things being equal, the population reduction would be focussed on HMP Barlinnie itself to reduce the risks posed by overcrowding there.

HMP Highland provides the SPS with an additional operational capacity of 107 spaces, and all 200 being fit for purpose. Given that these spaces will hold more people in their locality, and they are not displaced, it supports SPS to make population decisions elsewhere within the SPS and releases space in the estate, reducing overcrowding.

As you'll be aware, Ministry of Justice have created a process that enables HMPPS (in co-ordination with MoJ) to permit the release of groups of prisoners from those selected prisons which are unable to maintain acceptable conditions due to overcrowding (or will soon reach that point unless action is taken), through the selective application of their Ministerial power to release for compassionate reasons [Redacted - section 30(b)(i)]

UK Minsters have stated that this power is being used selectively, and only for limited periods, in order to prevent conditions in selected prisons reaching a level that might contravene their rights. [Redacted - section 30(b)(i)] Individuals are being released a maximum of 18 days from their scheduled release date, and eligibility is limited to those on short determinate sentences. The use of this power seems to have been devolved to Governors who can apply it in their prisons – and this is kept under review during regular discussions between MoJ and HMPPS.

### OVERCROWDING

The removal of an offender's liberty must always be available for our independent courts. We are working with justice partners to address the issue, including making the best use of the current prison estate and sourcing additional prisoner places to ensure the safety and wellbeing of people living and working in prisons.

In August this year, Barlinnie governor Michael Stoney said the prison was at risk of "catastrophic failure", with figures suggesting it was running at 140% capacity in July. Scottish Conservative justice spokesman Russell Findlay said: "The SNP

Government previously stated that HMP Glasgow would be built by 2026 – but now seem to suggest that work might not even begin until then.

HMP Barlinnie is a Victorian-era prison which was running at 140% capacity in July. "This follows the recent warning from HMP Barlinnie's governor about imminent catastrophe due to highly dangerous conditions.

"Yet again, ministers have abjectly failed to manage a critical infrastructure project and must now come clean on when the new prison will open and how much it is going to cost."

Scottish Labour justice spokeswoman Pauline McNeill – a Glasgow MSP – accused ministers of attempting to "blur the lines on a deadline that has already been pushed back time and time again".

She added: "Scotland's prisons are already at their breaking point, and further delays to Barlinnie's replacement will only make things worse.

"It would be an absolute disgrace for a prison serving Scotland's biggest city and the west of Scotland to be further delayed.

"We need urgent clarity from the Scottish Government on when they expect HMP Glasgow to be finished and what is being done in the meantime to tackle the rampant overcrowding in our prisons at present."

A Scottish Government spokesperson said: "HMP Glasgow is being designed to deliver safe and secure accommodation.

"Estimated costs and timescales will be set out once a final design is available and will deliver a real and lasting benefit, both in the city and surrounding area."
