



# **Draft response**

A Scottish Government spokesperson said:

"The 2014 Glasgow Commonwealth Games received international recognition as an outstanding fortnight of sporting and cultural events. The Scottish Government will of course explore if Scotland can support of a multi-city, multi-partner hosting opportunity however the Commonwealth Games Federation will need time to consider next steps, and it would be premature to comment further at this stage."

# **QUERY**

As you'll see on page 69 of the documents released to me through FOI, exploratory work has been carried out on a potential four-nation rescue plan for the 2026 Commonwealth Games.

While much of the correspondence released to me is heavily redacted, a UK Sport paper shared between officials makes clear that they were working on "a proposal that could potentially deliver a Commonwealth Games"

The UK Sport paper outlines "a potential revised hosting model" which would presumably see different events held in Scotland, England, Wales and Northern Ireland.

This paper - described as "an initial desk top exercise" - raises "several questions and highlights areas that require further investigation, and these should be considered in full before any decisions are made."

The email makes clear that this "does not infer that any offer would be made or that any funding has been made available to do so."

"It would still be for all partners to explore in a robust way whether it is in the interests of the UK, both societally and aligned to wider hosting aspirations, whether this would be worth pursuing.

"The broad conditions where that course of action might be considered feasible and/or desirable are outlined here, but not explored in full."

They note that the costs of hosting the Games "are significant" but that the final price "would be dependent on the requirements that were agreed and any associated legacy plans attached to hosting".

Other correspondence released to us through Freedom of Information, shows officials in Scotland are nervous about a possible bid.

Rachael Mckechnie Deputy Director, of Major Events and Themed Years at the Scottish Government, told colleagues: "There are significant financial implications here against the backdrop of extremely stretched budgets."

Another email points out that the "very short timeframe in which to deliver the event... will increase costs. "

It adds: "The inflationary pressures on many aspects of major event delivery remain strong

so a significant degree of contingency and optimism bias would need to be built into any business case."

# **Commonwealth Games: Potential UK Hosting Model**

The information contained in this paper is highly confidential and must not be shared outside of the distribution group. UK Sport, as the UK Government's lead agency for international sporting events, has produced this paper within an extremely short timeframe. This paper raises several questions and highlights areas that require further investigation, and these should be considered in full before any decisions are made – this paper should not be considered a viable alternative for a feasibility study. Everything within this paper should be treated as exploratory and subject to change at this stage.

The paper has been produced internally by UK Sport Officers as an initial desk top exercise, and who have liaised on budgetary matters with Dave Berry Consulting (DBC). Any DBC detail is noted as source.

#### A. Background

- 1. The Commonwealth Games is a quadrennial international multi-sport event among athletes from the Commonwealth of Nations. The event was first held in 1930 and has run every four years since (except two editions halted by World War II).
- 2. The event was called the British Empire Games from 1930 to 1950, the British Empire and Commonwealth Games from 1954 to 1966, and British Commonwealth Games from 1970 to 1974. Some Games have included integrated para sports in their schedules since 2002.
- 3. The event is owned and overseen by the Commonwealth Games Federation (CGF), which controls the sporting programme and selects host cities. In 2017 CGF Partnerships (CGFP), was established as a joint venture between the CGF and Lagardère Sports to support the delivery of the Games through long-term commercial partnerships and embedding staff within organising committees.
- 4. As the member bodies of the CGF, the Commonwealth Games Associations (CGA) lead and manage the participation of their teams at the Games. In the UK these are separate associations for each of England, Northern Ireland, Scotland and Wales. The support of CGA(s) are also of critical importance in putting forward a bid to the CGF and would be key partners in any hosting proposal, noting that it is the CGAs that 'submit a bid' with the support of Governments.

- 5. In the last 20 years, from the 2002 edition, the event has primarily been hosted in the UK or Australia with the exception only of 2010 which was held in India. In 2022, South Africa were due to the host the Games but withdrew in 2017, with Birmingham stepping in to host that edition in Dec 2017.
- 6. Victoria, Australia were due to host the 2026 edition of the Games. Planning was underway when they withdrew in July 2023 citing a budget increase from their planned AUS\$2.6bn to an estimated AUS\$6bn (£1.4bn to £3.13bn). For context (based on publicly reported figures of operating costs), the Birmingham 2022 Games cost £778m, Gold Coast AUS\$1.2 (circa £600m) and Glasgow £473m.
- 7. Public sources claim that Victoria has agreed to pay AUD\$380m (£190m) to settle all disputes arising from the cancellation of the 2026 Commonwealth Games. This will be paid to the CGF, Commonwealth Games Partnerships (CGFP) and Commonwealth Games Australia. The split is unknown.
- 8. It is understood that the CGF is still in conversation with Australia to explore any possible solutions that remain. Publicly, all Australian states have counted themselves out of any option to host the Games. No other potential hosts have been suggested by the CGF or in the media.
- 1. The bidding process for 2030 is currently open and the CGF are actively seeking bids. Alberta, Canada was the only declared interest in the process until August 2023 when they withdrew their interest. [Redacted Section 29(1)(a)]

# **B.** Context and Purpose

- 2. Given the risk that now exists to the 2026 Commonwealth Games [Redacted Section 29(1)(a)] UK Sport has produced some preliminary thoughts outlining a potential revised hosting model for 2026 [Redacted Section 29(1)(a)]
- 3. Whilst this paper explores a potential hosting model for a reduced scope Games, this does not infer that any offer would be made or that any funding has been made available to do so. It would still be for all partners to explore in a robust way whether it is in the interests of the UK, both societally and aligned to wider hosting aspirations, whether this would be worth pursuing. The broad conditions where that course of action might be considered feasible and/or desirable are outlined here, but not explored in full.

- 5. No formal conversations have taken place between the UK or home nations and the CGF and there has been no commitment to make a proposal to the CGF.

In 2021 the CGF reduced the 'core' sports to just two (Athletics and Swimming) and suggested that around 15 sports should be included in the programme in total.

# C. Conclusions

As noted in the introductory note, the intention of this paper has been to do some preemptive work to outline a proposal that could potentially deliver a Commonwealth Games Redacted Section 29(1)(a)

However, it is not intended to be a comprehensive or full assessment of whether this proposal should proceed to the CGF, and it is not a replacement for a feasibility study.

# **FOOTBALL BRIEF**

# Scotland vs England

- This match marks the 150<sup>th</sup> anniversary of what FIFA has recognised as the sport's first international match, a 0-0 draw watched by 4,000 spectators at the West of Scotland Cricket Club's ground in Partick, in November 1872. It also commemorates the 150<sup>th</sup> anniversary of the Scottish Football Association which was founded on the back of that match.
- All 11 players in that first game were Queen's Park players, the leading Scottish club at the time
- The sides have met 115 times with Scotland winning 41, England winning 48 and 26 draws.
- They most recently met at Wembley in the 2020 (played in 2021 due to covid) European Championships, drawing 0-0. Prior to that the two met in a World Cup qualification group in 2016/17, with Scotland losing 3-0 away from home but drawing 2-2 at Hampden, conceding a last minute equaliser.

# Euro 2024 Qualification

Scotland currently top their group to qualify for the European Championships in Germany next summer. They play Cyprus away on Friday 8<sup>th</sup> September, while Spain are away to Georgia.

#### STRATEGIC PARTNERSHIP

### The Power of Football

The network of football across Scotland is vast. Football is the country's number 1 sport, with over 2,500 clubs spread across the country. Currently there are over 150,000 registered players, with a further 50,000 coaches and volunteers. If we also include the number of recreational participants, parents, fans, and influencers in the local community, the Scottish FA estimates that football clubs' impact on more than 900,000 people on a weekly basis

The Scottish FA have long recognised the importance of community football clubs, and for over 15 years, supported by the national agency of sport, national lottery, and other key commercial partners, there has been strategic investment into a targeted national and regional workforce. This workforce has underpinned the Scottish FA's long-term strategy, including supporting the implementation of a national club accreditation programme and ongoing club development work.

In addition, the Scottish FA have further invested directly into its network of partners, to support clubs to offer more projects, programmes, and participation opportunities for all. In order that the Scottish FA build upon the existing work and achieve the transformative change, it would like to work with key stakeholders including the Scottish Government and sportscotland to help develop its offering and realise shared outcomes.

The strategic direction of the Scottish FA is focused on three key areas, as outlined by the following plans:

- Scottish FA Power of Football strategic plan 2021 2025
- Accelerating the Growth of Girls' and Women's Football the Scottish FA's strategic plan for girls' and women's football
- Football for All plan the Scottish FA's new strategic plan for developing opportunities for all

At the heart of all three documents, is an ambition to work with key partners. Local and national, to develop and transform our community football clubs and use the power of football to inspire a nation.

The unique reach of football and its ability to deliver across Scottish Government portfolios, offers a platform to influence and benefit Scottish society and impact on a wide number of key thematic areas, both on and off the pitch.

Scottish football has a track record of delivering on Scottish Government national and local outcomes through projects and programmes such as the following:

- Cashback programmes (Justice)
- Time to tackle (Mental Health)
- Ayr United Project (Out of School Childcare)
- Football Memories Group (Dementia/Mental Health)
- Climate Action & Sustainability (Environment)

- Learning through Football (Education)
- Coach Education & Development (Education)
- Para Football (Equalities)
- Go Fitba (Community)
- Football for All (Health)

These examples have delivered a mix of national and local outcomes, with key partners from the public and social sectors engaged. The projects and programs have been recognised by national and international partners as best practice, with a reach far beyond the traditional sporting boundaries, tackling areas such as increasing physical activity levels, addressing food insecurity, improving mental health, engaging young people, reducing offending etc.

Football activity is played in a variety of formats and this flexible approach allows the game to be enjoyed by people from nursery aged children through to our older citizens, via walking football and recreational activity. This broad appeal offers the Scottish FA, clubs, and wider stakeholders the opportunity to provide significant reach in communities across the country, and football also has a unique capacity to support early intervention with young people, enabling them to build better futures.

Existing programmes such as the work carried out by Cashback and community football clubs with the Fair Play Foundation and Network Rail have demonstrated a commitment to work with communities to use the power of football to engage, inspire and educate. The Scottish FA would seek opportunities to learn through others, such as this innovative scheme from Borussia Dortmund and through education, awareness raising and long-term implementation models we have an ambition to improve the lives of our participants and the communities they live in.

Scotland has some of the best community football clubs in Europe. Organisations that are deep rooted in their community, which help support players, coaches, volunteers, and parents. The role of our clubs within society is fundamental and can often be the 'glue' to connect communities far beyond other statutory and non-statutory organisations. The breadth and diversity of the communities that these clubs service is considerable, and many operate within areas of significant deprivation.

Furthermore, the Social Return on Investment (SROI) model, created by UEFA offers football the opportunity to demonstrate impact at a national, regional, and local level more effectively than ever before The SROI model outlines that community football in Scotland is worth £728 million per annum and has significant Health, Social and Economic outcomes – from this report and similar national and club models, it's clear that community football clubs are key to the fabric of society in Scotland and this monetary and social value, is reflected across much of Europe.

During the Covid pandemic, many of these outstanding organisations very quickly pivoted from delivering football sessions to delivering food parcels and providing hope for many in their locale. The main motivation for our clubs is evident – they wish to serve and better their local community and use the power of football to help impact on the lives of so many.

# **ALCOHOL CONSULTATION**

#### New Deal for Business

- Scotland's economic vision is one of a wellbeing economy where business and trade can thrive while caring for people and planet. We recognise that becoming a thriving and healthy country that delivers and optimises positive outcomes requires all sectors to work together.
- The Scottish Government remains absolutely committed to our Public Health agenda and the range of priority actions that we have set out on in relation to the various health harming products (including alcohol, tobacco and less healthy food).
- Many of these proposals will inevitably have an impact on the way in which businesses currently operate.
- As part of our commitment on the New Deal for Business, we will engage at an
  early stage in the process to work with business (and a range of other key
  stakeholders) to ensure that the impact of policy proposals on businesses is fully
  understood and that policy implementation is effective and proportionate, while still
  delivering the beneficial outcomes for population health that we are seeking.
- This is distinct from guiding the content and development of that policy in the first instance which we understand and agree is not appropriate for all sectors.

### Consultation Key lines

- Ministers have asked officials to go back to the drawing board on potential proposals to restrict alcohol advertising and promotion.
- We all want to reduce the harm that is caused by alcohol, particularly to young people.
- We know that young people seeing alcohol marketing is associated with them starting to drink alcohol or drinking more alcohol.
- We must ensure we prevent alcohol harms without undermining Scotland's worldclass drinks industry or tourism sector.
- I am hopeful that, by taking a fresh look at the issue, we can find a way forward that achieves both those crucial aims.
- We will be reflecting on the feedback we received from stakeholders during the recent Ministerial roundtables and will analyse the public consultation responses to understand the views and perspectives of those that responded.
- No decisions have been taken on scope or on the type of restrictions that might be taken forward in future.

# **Background**

Research has consistently shown that exposure to marketing is associated with an increased likelihood that children will start to drink or – if they already drink – drink more. This is endorsed by the World Health Organization.

Alcohol-related harm is one of the most pressing public health challenges that we face in Scotland. An average of 700 people are hospitalised and 24 people die each week from illnesses caused directly by drinking alcohol.

Restricting alcohol advertising and promotion is one of the World Health Organization's three best buys to reduce alcohol-related harms.

In recognition of the wide range of potential impacts raised by the consultation, the then Minister for Public Health held a series of roundtables with key stakeholders, including representatives from the alcohol, retail and advertising industries, to hear directly from them.

Further consultation and engagement with public health stakeholders and businesses will take place as our work progresses.

We consulted on restricting alcohol advertising and promotion to protect vulnerable groups, including children and young people and those in recovery. These groups have told us directly that they see a lot of alcohol advertising and promotion and want us to restrict this.

Alcohol marketing is seen by, and appealing to, large volumes of children and young people.

International evidence shows that seeing alcohol marketing is associated with an increased likelihood that children and young people will start to drink alcohol or, if they already drink alcohol, drink more. This is harmful to them in both the short and long term.

Emerging evidence sets out that those who are in recovery find alcohol marketing triggering and take action to avoid seeing this due to the appeal it has for them. This can be a barrier to their successful recovery.

The consultation meets our PfG commitment 2022/23 to "consult on proposals to restrict alcohol advertising and promotion later this year and, subject to the outcomes of the consultation, introduce legislation within the lifetime of this parliament."

Several other European countries have implemented mandatory restrictions on alcohol marketing and the UK is lagging behind in this area.

# Scottish football expresses concern at proposed new rules for fans travelling on public hire vehicles

Scottish football's leading bodies have expressed concern over proposed new rules for fans

travelling to matches on public hire vehicles, which have been issued by the Traffic Commissioners for Great Britain.

A joint statement issued on behalf of the Scottish FA, Scottish Professional Football League,

and Scottish Women's Premier League said: "There's no evidence that this is a significant

problem in Scottish football. We are concerned by the targeted nature of these proposals

which serve to demonise football fans and interfere unnecessarily in people's lives.

"In Scotland, there are already appropriate powers held by PHV operators, Police Scotland

and other partners to deal effectively with a very small number of incidents by a minority of fans.

"The consultation itself notes that the majority of football fans are law-abiding and do not

cause any disturbances when travelling to or from games, yet these proposals would unfairly affect the vast majority of football fans who travel safely and respectfully to and

from matches on a weekly basis.

"We don't support these unnecessary and heavy-handed proposals and we will be making

our views clear in the consultation."
