

The Scottish Government has invested over £350 million in Ukrainian resettlement since Russia's full-scale invasion. In addition to this, the UK Government has made the following transfers to the Scottish Government in relation to Ukrainian Resettlement:

- A £30 million allocation as part of their UK-wide 'Moving On Fund' which was announced following the announcement in November 2022 that Year 2 and 3 tariff funding to local authorities for displaced Ukrainians would be removed.
- A £24.2 million allocation as part of the Education Tariff, which funded the education needs of displaced Ukrainians, and which was discontinued by the UK Government after 22-23.
- £13.5 million in Thank You Payments recognising the Scottish Government's role as the host of those Ukrainians who arrived under the super sponsor scheme.

Of these, the £30 million and £24.2 million were passed on in full to Scottish Local Authorities using the allocations shown below. The Thank You Payments were retained to offset the spend referred to above that the Scottish Government has incurred in their role as host supporting displaced guests.
