Please find below a submission recommending that the Cabinet Secretary meets the deputy head of mission next week from the Embassy of Israel.

## ISSUE

1. The Deputy Chief of Mission (DCM) from the Israeli Embassy is visiting Scotland from [redacted-s.30b(i)] and has sought calls with Scottish Government ministers. Officials recommend that the Cabinet Secretary accepts the meeting.

## PRIORITY:

2. Urgent – [redacted – s.32(1)(a)]

## BACKGROUND

3. The Israeli DCM, Daniela Grudsky Ekstein, will pay her first official visit to Scotland in the role next week. [redacted – s.32(1)(a)]
4. The Cabinet Secretary would usually accept meetings with visiting senior diplomats. Ms Ekstein's predecessor met Ms McKelvie in her previous role last year. We do not know Ms Ekstein's wider programme, but would expect it to include meetings with Scotland's Jewish community and some Festival engagement. [redacted – s.30(b)(ii)]
5. The Foreign Secretary recently visited Israel and the Occupied Palestinian Territories, where he called for an immediate ceasefire, the release of hostages and for more humanitarian aid to enter Gaza. The UK Government has also dropped its objection to the ICC's case against Israel.
6. The First Minister has also agreed to meet the head of the Palestinian Mission in London when he next visits Scotland. Officials will liaise with the mission. The former First Minister met the head of mission last year.

## SENSITIVITIES

7. The ongoing war in Gaza has led to widespread demonstrations across Scotland. The meeting would be an opportunity for the Cabinet Secretary to make clear Scotland's position on an immediate ceasefire, access for humanitarian aid, and the release of hostages.
8. The Scottish Government has been steadfast in confronting antisemitism and supporting our Jewish community, including the First Minister's strong speech at

the International Holocaust Remembrance Alliance's meeting in Glasgow last month.

9. The FCDO has no objections to the meeting and will offer some background briefing if necessary.

## COMMUNICATIONS

10. In the interests of transparency and give likely media interest, we recommend a short press statement making clear that the Cabinet Secretary met the DCM at the Israeli Embassy's request, and stated Scotland's position on the war in Gaza. [redacted – s.32(1)(a)]

In the letter, Mr O'Hara states that he is "at a loss to understand why" the meeting took place, stating that Ms Grudsky "represents a government which is currently under investigation for genocide" and a prime minister "who is facing a potential arrest warrant for the most serious of crimes".

On discussions about future cooperation on technology, culture and renewable energy, he states that "no such discussions should be taking place with a government who is responsible for causing such unfathomable pain and suffering" and the "bewildering display of diplomacy" by the Scottish Government will "give credence" and "legitimacy" to the Israeli government.

Mr O'Hara further claims the meeting has "undone" the work by SNP MPs on the Gaza-Israel conflict and the actions of the UK Government.

I understand the Scottish Government has already commented on the meeting. However, would Mr Robertson now care to comment on the points made by Mr O'Hara?

And just finally, I mentioned this to the Cabinet Secretary, Angus Robertson met the Israeli Deputy Ambassador last week in St [redacted - s.38(1)(b)]'s House. Was that the correct thing to do, do you think?

Ivan McKee:

Well, there's no shortage of things to talk to the Israeli Government about. You could talk about the genocide charge that they are up against in the court of justice. We can talk about the arrest warrant that is out for the Deputy Ambassador's boss and others, Benjamin Netanyahu, in the International Criminal court. We talk about the thousands of Palestinians held illegally in detention in Israel being tortured and raped according to [inaudible] human rights organisations. We can talk about the slaughter that is happening in Gaza and talk about the need for an immediate ceasefire. They're using starvation as a tool as a policy within Gaza, there is no shortage of points we can land, very strongly, to make sure the Israeli Government absolutely understands where the Scottish Government stands on these matters and I believe that's what Angus Robertson did.

Yeah. But were those points really landed do you think in your view because you obviously feel very strongly about this

Ivan McKee:

I wasn't at the meeting and so I'm not sure of the exact detail of what they talked about but certainly the Scottish Government's position, as the First Minister has made clear, is a ceasefire and a need for humanitarian aid on the actions of the Israeli Government continue to illegally expand settlements in the West Bank and making that a positive policy of doing so whilst this potential genocide is ongoing, those points are very clear from the Scottish Government's perspective and the First Minister reiterated our position on this yesterday.

An important part of diplomacy is tone, was the Scottish Government's tone right here in its communication about the meeting or was it tone deaf?

Ivan McKee:

I've made my point about things that were important and things that we should communicate with Israeli Government.

**Follow-up**

I am looking for comment in response to criticism of Angus Robertson's 'secret meeting' with an Israeli diplomat last week.

A readout from the meeting was circulated today, four days after the meeting took place and The National understands this was at the request of the Israeli embassy citing security concerns.

This is unusual; recent meetings between the Prime Minister and foreign leaders such as Volodymyr Zelenskyy have been trailed in advance to the press, with readouts coming within hours of the meeting taking place.

Scottish Greens MSP, Ross Greer has called on the SNP to apologise for "this underhand attempt to build closer ties with Israel".

He said: "The Israeli regime is committing genocide in Gaza. They cut off water and electricity, restricted the supply of everything from medicines to period products and have slaughtered tens of thousands of innocent people in a ten month campaign of relentless bombing.

"This is a shameless two-faced approach from the SNP. They publicly condemn Israel's war crimes whilst holding secret meetings with its representatives to discuss so-called 'mutual interests'. Angus Robertson wouldn't dream of meeting representatives of Syria's murderous Assad regime. Apartheid Israel should be no different.

"The Scottish Greens have repeatedly proposed ways the SNP could turn their strong words into action, using the powers of the Scottish Government to ch[redacted - s.38(1)(b)]ge Israel. For example, they could ban every business identified by the UN as complicit in the occupation of Palestine from receiving any public grants or contracts here in Scotland. I first made this suggestion months ago, but absolutely no action has been taken despite our repeated requests and those of the Palestinian community.

"The SNP can't have it both ways. They should apologise for this underhand attempt to build closer ties with Israel at the very same time as it inflicts a horrific slaughter on the Palestinian people."

**1. Are there any other governments whom the Scottish government has a similar policy towards?**

Yes. The Scottish Government has taken this approach previously where they have judged it necessary or appropriate. Ministers take such decisions on a case-by-case basis.

**2. What would have to take place to reverse the effective ban on meeting Israeli officials?**

As set out in the Cabinet Secretary's statement, this will remain our position until such time as real progress has been made towards peace, unimpeded access to humanitarian assistance is provided and Israel cooperates fully with its international obligations on the investigation of genocide and war crimes.

**3. Is it the Scottish Government's position that there is a genocide taking place in Gaza?**

It is for the international courts considering the Genocide Convention to investigate and determine the charge of genocide. As a government committed to the international rule of law, we support any investigation into alleged crimes against humanity and genocide. The International Court of Justice has insisted that Israel take all steps to prevent the allegations of the crime of genocide, and ordered Israel to ensure access so this crime can be investigated by relevant UN bodies.
