As discussed, you are aware of the news yesterday that Former First Minister passed away suddenly whilst at a speaking event in Macedonia. We were in touch

with your Global Response Centre team last night to confirm consular support and contact with the Salmond family.

Scottish Ministers have been in touch with JP this morning and we would now appreciate clarification of the following two points as soon as possible to allow updated briefing for our Ministers:

1. The contact name and details of the lead FCDO official (including contact point for family); and
2. Details of the repatriation protocol for a former First Minister of Scotland.

JP is very happy to speak to Sir Philip directly today by phone if helpful.

DFM passes on her thanks for this advice.

For the sake of the copy list, DFM has confirmed she has spoken to a representative of the family and also Tasmina Ahmed Sheikh who remains in North Macedonia. DFM has also continued engaging with SoSfS, who is engaging with Foreign Secretary.

The critical element from the family's perspective is confirmation that a flight will be available by Tuesday as this is the earliest point at which the body might be available for repatriation – once the necessary paperwork is complete. [redacted s28]

Note of call between DFM [redacted] Forbes and FCDO Minister of State for Europe Stephen Doughty – Monday 14 October 2024

Minister Doughty shared his personal condolences. He knew the former First Minister and was hugely saddened by his sudden loss. He was in Luxembourg and had that afternoon spoken to the North Macedonian Prime Minister and Foreign Minister who had both offered their condolences and offered their help to ensure a smooth repatriation. The embassy team were also fully engaged and had been in direct contact with the Salmond family.

The Deputy First Minister thanked Minister Doughty. She knew that the family had appreciated all the good wishes and the cross-party support. She thanked UKG for their response and the exceptional support from the FCDO team and the Ambassador in particular.

Ministers agreed that it was important to handle this sensitively and to ensure that the family knew that they had the full support of both governments. There could be no suggestion of delay from either UKG or SG. The necessary paperwork would be completed by the end of the day on **Monday** so it was important to act quickly to put arrangements for repatriation in place.

[redacted] The FCDO had looked at the option of using the RAF. Ultimately this would be a decision for the MoD but in general they would only agree to use of the RAF where there was no commercial option. In addition Minister Doughty pointed out that use of the RAF was likely to introduce further delay – it would likely take 3-5 days for the necessary protocols to be agreed. Even with good will from the Macedonian authorities necessary clearances would need to be in place for a UK military plane to land there. FCDO protocol generally only considered RAF flights for members of the royal family. So SG could make the request to the MoD – through the Scottish Office – but FCDO’s advice was that this was likely to introduce further delay and prohibitive expense. Private charter options were available and FCDO would work with SG to ensure dignified treatment at both ends of the flight. Whatever the SG and the family decided they would have FCDO’s support to ensure that the repatriation was as dignified and straightforward as possible

DFM raised the issue of airports. The main airport was three hours drive from where the body is but there was a small airfield much closer. The family were keen to explore whether it would be possible to use that airport.

Minister Doughty said that FCDO would be happy to look at options for airports and would arrange transport to the airport. He asked that SG discuss further with the family and come back to FCDO with a very specific request. He would personally ensure that everything possible was done to facilitate our requests.

DFM thanked him for his support. We would come back with a specific ask. We would look at alternatives to the RAF but if we could not find something that worked for the family we might have to return to that option.

Some additional advice from FCDO on the RAF option. I think the point that military assistance will only be authorised if a commercial option is not available is important.

“Requests for military assistance to the civilian authorities, or MACAs as they are known, have quite strict rules attached to them. The process for a MACA if SG requests one is that it has to be submitted to SoS Scotland for authorisation before going to the Defence Secretary for approval. I understand that this is because Defence is reserved under the Scotland Act so the formal request to the Defence Secretary has to come from SoS Scotland. The first rule of MACAs is that military assistance will only be authorised if a commercial option is not available. [redacted s28]

The primary issue that the DFM will want to raise on the call tomorrow is the importance that the family place on confirmation that a flight will be available by Tuesday for repatriation. We understand that this is the earliest point at which the body might be available for repatriation – once the necessary paperwork is complete. The family understand that the FCDO are willing to arrange either RAF or Commercial flight but that there are only two commercial flights per week. This remains the priority for us to resolve Gov to Gov.

- The full set of paperwork from the local funeral director has been finalised.
- Aircraft is booked and paid for and will be positioned tomorrow, ahead of repatriation on Friday.
- The charter company are proceeding with lodging the necessary applications for ground clearance from the UK Civil Aviation Authority and North Macedonian equivalent for ground clearance. Colleagues at the Embassy will follow up on the latter to ensure this is approved quickly. Would it be possible for Scottish Government to check with the CAA if they can expedite permissions to land at Aberdeen once we receive the reference number?
- Repatriation is tentatively scheduled for Friday at 11:00, arriving at Aberdeen Airport later that day. The NM Government are preparing a Guard of Honour send off, which will be attended by former President Ivanov, Tasmina, and one BBC reporter. HMA North Macedonia will also be in attendance, accompanied by a comms officer.

Shona,

Thank you for your call earlier today.

As discussed, an International Funeral Director can be appointed to coordinate the repatriation of Mr Salmond. Normally, the next of kin would be responsible for making this appointment however a nominated point of contact (i.e. the Scottish Government) should be able to make this appointment on the family's behalf with their consent.

We provide a list of UK based international funeral directors but do not have any specific recommendations as to who you appoint: [UK-based international funeral directors - GOV.UK \(www.gov.uk\)](http://www.gov.uk). The international funeral director (IFD) will be able to work with the local funeral director in North Macedonia (who we are in regular contact with) to ensure all the necessary local and UK requirements are met to bring Mr Salmond home. This includes providing documents such as a local civil registry death certificate, a certificate of embalming and a certificate giving permission to transfer the remains to the UK. I would strongly advise that you do appoint an IFD as they are best placed to manage these processes and will be well versed in what is needed. I understand that the family have expressed a preference for a local funeral director as well, if the local funeral director is not able to manage the international repatriation then it should be possible that they take over after Mr Salmond has landed in Aberdeen.

The IFD should also be able to assist with providing quotes and logistical arrangements for a private charter flight to return Mr Salmond. If you have any issues with them providing you with these quotes, please do let us know and we will see if we can assist here.

Please note, these are private companies and there would be a cost attached which the FCDO would not be able to pay. In normal circumstances, the family or the individual's insurance company would cover the costs.

We have a follow up call with the DFM at 5pm so any views by then would be very much appreciated.
