Hi all, sorry tried to give you a calls this morning but could not get any of you, I wont take it personally. 
To advise that Ministers have now taken a decision on Peak Fares and have decided to reinstate Peak Fares at the end of the pilot and for Season Tickets to be reduced by 20% for 12 months and Flexi Passes increased from 5 to 6 (equivalent of 20% discount) permanently. Also to confirm that Super Off Peak fares should be reinstated at the end of the pilot. This is all to be announced in the form of a GIQ which will be lodged later this afternoon and responded/published tomorrow at 09:30. Cab Sec will do media tomorrow after her visit to Border's railway (around lunchtime) and the Full Evaluation will be published on the TS website at the same time as the GIQ is answered tomorrow. I know you will have to start to prepare for tomorrow but can I ask that is treated where possible in confidence we are required to follow convention and for Parliament to be updated first with regard to this decision.
